Bar Complex (three fires), Shasta-Trinity NF. Transfer of command from IMT 1 (Molumby) to IMT 1 (Opliger) will occur tomorrow. Fourteen miles northwest of Weaverville, CA. Timber and brush. Spotting and backing fire. Structures threatened. Structure protection and road closures in effect.

Uncles Complex (three fires), Klamath NF. Eighteen miles northeast of Orleans, CA. Old growth timber and brush. Backing fire. Historic structures and cultural resources threatened.

Cedar Creek, Okanogan-Wenatchee NF. Eight miles southwest of Mazama, WA. Timber. Monitoring by air. No further information received. Last report unless significant activity occurs.
