Area Command Team (Ribar) is assigned to manage large fires for the Boise National Forest.

Murphy Complex, Twin Falls District, BLM. IMT 1 (Hawkins). Fifty-six miles southwest of Twin Falls, ID. Brush and juniper. Moderate fire activity with some running. Evacuation of several communities remains in effect. Numerous communities, Mountain Home AFB Training Range facilities and ranches are threatened.

Dakota Hill (five fires), Zion NP. IMT 2 (Sciacca). Twelve miles north of Springdale, UT. Hardwood litter, dead and down timber, grass. Minimal to moderate fire behavior. Numerous structures and communities remain threatened. Evacuations remain in effect. Precipitation occurred over the fire area yesterday. Reduction in acreage due to more accurate mapping.

East Zone Complex (three fires), Payette NF. IMT 2 (Heintz). Twenty-five miles northeast of McCall, ID. Timber litter. Active fire behavior with running, crowning and torching. Bridges, a campground and numerous structures remain threatened.

Paradise, Cedar City Field Office, BLM. Ten miles northwest of Modena, UT. Grass, brush and timber. Running, torching and crowning. Structures remain threatened. Evacuations in effect. Reduction in acreage due to more accurate mapping.

Granite, Bridger-Teton NF. Fifteen miles southeast of Jackson, WY. Timber, grass, dead and down timber. No further information received.

Tongue Complex (three fires), Boise District, BLM. IMT 2 (Johnson). Forty-five miles south of Silver City, ID. Brush, grass and juniper. Moderate fire activity with torching.

Salt Creek, South Central Area, Utah Division of Forestry. IMT 1 (Ruggiero). Five miles east of Nephi, UT. Timber, grass and chaparral. Extreme wind-driven fire behavior with rapid rates of spread in some areas and smoldering and creeping in others. Precipitation occurred over portions of the fire area yesterday. Structures remain threatened.

Trapper Ridge, Boise NF. FUMT (Hahnenberg). Twenty-eight miles northeast of Idaho City, ID. Timber litter. Active fire behavior with torching. Reduction in acreage due to more accurate mapping.

Middle Fork Complex (22 fires), Boise NF. IMT 2 (Whalen). Eighteen miles northeast of Lowman, ID. Timber and brush. Torching, long-range spotting and intense surface burning. Structures remain threatened. Road closures remain in effect.

Van Horn, Salmon-Challis NF. Fifteen miles north of Challis, ID. Timber litter, snags, dead and down timber. Torching, short crown runs. Structures remain threatened.

Kimbell, Salt Lake Field Office, BLM. Seven miles northwest of Grantsville, UT. Timber and grass. Running and torching. Structures remain threatened.

Cascade Complex (17 fires), Boise NF. IMT 2 (Suwyn). Ten miles south of Yellow Pine, ID. Timber. Extreme plume-dominated fire behavior with crown fire and rapid spread. Structures remain threatened.

Krassel Complex (4 fires), Payette NF. FUMT (Perkins). Forty-four miles northeast of Yellow Pine, ID. Grass, brush, timber litter and downed logs. Moderate fire activity.

North Fork, South Idaho Timber Protective Association, Idaho Department of Lands. Fourteen miles southeast of Donnelly, ID. Timber, heavy dead and downed logs, snags. Crown fire runs and spotting.

Black Pine 2, Sawtooth NF. Started on private land eleven miles southeast of Malta, ID. Grass, brush, pinyon pine and juniper. Running, group torching and spotting.

Jim Canyon, Sawtooth NF. Seven miles west of Curlew, ID. Brush, juniper and grass. Smoldering. Reduction in acreage due to more accurate mapping.

Gun Canyon, Twin Falls District, BLM. Seven miles east of Declo, ID. Grass, sage and juniper. Last report unless new information is received.

Area Command Team (Loach) is assigned to manage large fires for the Elko Field Office, BLM.

Winecup Complex (nine fires), Elko Field Office, BLM. IMT 1 (Broyles, Martin). Includes previously reported Dairy Valley fire. Six miles west of Jackpot, NV. Brush, grass, pinyon pine and juniper. Torching, running and spotting. Ranches, structures and utility infrastructures threatened.

Cathedral, Humboldt-Toiyabe NF. IMT 2 (Woychak). Twenty-five miles southwest of Ely, NV. Pinyon pine and juniper. Minimal fire behavior.

Red House Complex (three fires), Elko Field Office, BLM. IMT 1 (Molumby). Twenty miles north of Carlin, NV. Brush and grass. Minimal fire behavior with creeping. Structures remain threatened. Reduction in acreage due to more accurate mapping.

Hepworth Complex (four fires), Elko Field Office, BLM. IMT 2 (Saleen). Ten miles north of Wells, NV. Grass, brush, juniper and hardwoods. Creeping and smoldering. Structures remain threatened.

Antelope Complex (six fires), Battle Mountain Field Office, BLM. IMT 1 (Muir). Thirty-six miles north of Austin, NV. Brush and grass. Creeping and smoldering with isolated torching. Structures remain threatened.

Hawken, Humbolt-Toiyabe NF. Transfer of command from IMT 1 (Martin) back to local unit yesterday. Started on private land four miles southwest of Reno, NV. Brush, grass and timber. Minimal fire behavior.

Tippetts, Ely Field Office, BLM. Fifty-eight miles northwest of Ely, NV. Brush, grass and juniper. Isolated interior torching. Reduction in acreage due to more accurate mapping.

Barrel Springs 2, Winnemucca Field Office, BLM. Twenty-five miles south of Winnemucca, NV. Brush and grass. Running and spotting.

Poe Cabin, Craig Mountain Area Office, Idaho Department of Lands. IMT 1 (Stanich). Twenty-three miles southwest of Grangeville, ID. Tall grass. Active fire behavior with isolated torching and short up-slope runs. Communities and structures remain threatened. Evacuations and road closures remain in effect.

Chimney Complex, Craig Mountain Area Office, Idaho Department of Lands. IMT 2 (Kusicko). Nineteen miles south of Lewiston, ID. Timber and grass. Active fire behavior. Numerous structures remain threatened. Evacuations remain in effect.

Ahorn, Lewis and Clark NF. IMT 1 (Bennett). IMT is also managing Novak and Little Wolf Creek fires. Thirty miles west of Augusta, MT. Timber litter. Active fire behavior with group torching and short runs. Structures remain threatened.

Novak, Central Land Office, Montana DNR. Ten miles southwest of Cascade, MT. Timber, brush and grass. Active fire behavior with torching, spotting and short runs. Structures remain threatened. Interstate 15 lane closures.

Little Wolf Creek, Central Land Office, Montana DNR. Forty-six miles west of Great Falls, MT. Timber, brush and grass. Isolated torching with creeping and smoldering. Structures remain threatened.

Rattlesnake, Nez Perce NF. IMT 2 (Turman). IMT is also managing the Concord WFU. Twenty-five miles south of Elk City, ID. Timber and grass. Active fire behavior with short crown runs. Communities, recreation areas and structures remain threatened.

Fool Creek, Lewis and Clark NF. FUMT (Hall). Thirty miles northwest of Choteau, MT. Timber litter. Creeping and smoldering.

Rugby, Lewis and Clark NF. IMT 2 (Angell). Twelve miles west of Neihart, MT. Timber. Group torching and short runs. Structures threatened.

Owl, Yellowstone NP. IMT 2 ordered. Forty-five miles south of Bozeman, MT. Timber and grass. Active fire behavior. Structures threatened.

Pattengail Creek, Beaverhead/Deerlodge NF. IMT 2 (Secret). Ten miles northeast of Wisdom, MT. Timber. Active fire behavior with group torching and long range spotting.

Walk In, Northern Cheyenne Agency, BIA. Eight miles northwest of Ashland, MT. Logging slash. Active fire behavior.

Concord, Nez Perce NF. Twenty miles southwest of Elk City, ID. Timber litter. Moderate fire activity.

Elm Street Complex (two fires), Idaho Panhandle NF. Seven miles north of Clarkia, ID. Medium logging slash. Torching and smoldering.
