Area Command Team (Zimmerman) is assigned to assist the Northern Rockies in analyzing assessments for long duration fires and emerging incidents.

**Mile Marker 124**, Southwestern Land Office, Montana DNR. IMT 2 (Angell). Nineteen miles southeast of Missoula, MT. Timber and understory. Backing fire with individual torching. Structures, power lines, petroleum pipelines and communication towers remain threatened. Traffic restrictions on I-90 and evacuations remain in effect.

**Meriwether**, Helena NF. IMT 1 (Bennett and Oltrogge). Thirty-seven miles northwest of Helena, MT. Timber, brush and grass. Scattered torching with short crown runs. Structures remain threatened.

**Skyland**, Flathead NF. IMT 2 (LaFave). Forty-five miles east of Whitefish, MT. Timber, litter and understory. Short crown runs with isolated torching. Structures remain threatened.

**Ahorn**, Lewis and Clark NF. Transfer of command from IMT 1 (Bennett) to IMT 1 (Whitney) today. Thirty miles west of Augusta, MT. Timber litter. Active ground fire, short runs and individual tree torching. Structures remain threatened. Evacuations remain in effect.

**Poe Cabin**, Craig Mountain Area Office, Idaho Department of Lands. Transfer of command from IMT 1 (Stanich) to IMT 2 (Sciacca) on 8/5. Twenty-three miles southwest of Grangeville, ID. Timber, understory and grass. Short runs, isolated torching and creeping. Structures remain threatened.

**Sawmill Complex** (three fires), Lolo NF. IMT 2 (Heintz). Twenty-two miles southeast of Missoula, MT. Timber. Active fire behavior with isolated torching and short-range spotting. Numerous structures remain threatened.

**Rattlesnake**, Nez Perce NF. IMT 2 (Secret). Twenty-five miles south of Elk City, ID. Timber and grass. Active fire behavior with short crown runs, torching and spotting. Two communities remain threatened.

**Chippy Creek**, Northwestern Land Office, Montana DNR. IMT 2 (Raley). Forty-two miles southwest of Kalispell, MT. Timber and understory. Running, crowning, torching and spotting. Structures remain threatened.

**Bridge**, Clearwater NF. Forty-five miles southwest of Missoula, MT. Timber. Backing fire, isolated torching and creeping. Area closures remain in effect.

**Brush Creek**, Flathead NF. IMT 2 (Koehler). Twenty-five miles west of Whitefish, MT. Timber and understory. Torching and spotting. Structures remain threatened.

**Rombo Mountain**, Bitterroot NF. FUMT (Svalberg). Eighteen miles south of Darby, MT. Timber and understory. Active surface fire. Structures remain threatened.

**Owl**, Yellowstone NP. IMT 2 (Wilder). Forty-five miles south of Bozeman, MT. Timber and grass. Smoldering. Structures remain threatened.

**Fool Creek**, Lewis and Clark NF. Transfer of command from FUMT (Hall) back to local unit yesterday. Thirty miles northwest of Choteau, MT. Timber and snags. Moderate fire behavior. Structures remain threatened.

**Chimney Complex**, Craig Mountain Area Office, Idaho Department of Lands. Nineteen miles south of Lewiston, ID. Timber and grass. Isolated torching and smoldering.

**Garceau**, Flathead Agency, BIA. Transfer of command from IMT 2 (Grant) back to local unit today. Fifty-five miles south of Whitefish, MT. Timber and grass. Individual tree torching and creeping.

**Hay Creek**, Dakota Prairie National Grasslands. Nine miles northwest of Bison, ND. Grass. Active fire behavior with isolated short runs. Reduction in acreage due to more accurate mapping.

**Conger Creek**, Lolo NF. Twenty miles north of Ovando, MT. Timber. Torching with short crown runs. Structures remain threatened.

**Porcupine**, Gallatin NF. Thirty-one miles north of Livingston, MT. Timber. Active burning with torching and spotting.

**Pattengail Creek**, Beaverhead/Deerlodge NF. Ten miles northeast of Wisdom, MT. Timber. Group torching and creeping. Reduction in acreage due to more accurate mapping. Last report unless significant activity occurs.

Area Command Team (Ribar) is assigned to manage large fires for the Boise and Payette National Forests.

**Cascade Complex** (six fires), Boise NF. IMT 1 (Opliger). Three miles northeast of Cascade, ID. Timber and timber litter. Torching and short-range spotting. Two communities remain threatened.

**East Zone Complex** (three fires), Payette NF. IMT 1 (Pincha-Tulley). Thirty miles northeast of McCall, ID. Timber litter, brush and grass. Running, torching and long-range spotting. Two communities, historic sites and bridges remain threatened.

**Middle Fork Complex** (four fires), Boise NF. IMT 2 (Harvey). Fifteen miles northeast of Garden Valley, ID. Timber and brush. Moderate fire behavior with torching and short-range spotting. Structures remain threatened. Road closures remain in effect.

**Trapper Ridge**, Boise NF. Transfer of command from FUMT (Hahnenberg) to IMT 2 (Lund) tomorrow. Twenty-eight miles northeast of Idaho City, ID. Timber and hardwood litter. Active fire behavior with running, torching and short-range spotting. Structures remain threatened.

**Horton**, Payette NF. Fifteen miles north of McCall, ID. Timber litter. Torching and short-range spotting. Evacuations in progress.

**Raines**, Payette NF. FUMT (Ourada/Soper). FUMT is also managing the Krassel Complex. Thirty-eight miles northeast of McCall, ID. Timber and grass. Active fire behavior with torching. Structures remain threatened.

**Krassel Complex** (six fires), Payette NF. Forty-four miles northeast of Yellow Pine, ID. Timber, grass and brush. Active fire behavior with torching.

**Granite Creek**, Bridger-Teton NF. Fifteen miles southeast of Jackson, WY. Timber and dead and down fuels. Precipitation occurred over the fire area yesterday. No further information received.

**Cold**, Boise District, BLM. Sixteen miles southeast of Mountain Home, ID. Brush. Moderate to active fire behavior. Structures remain threatened.

**Shower Bath**, Salmon-Challis NF. Eighteen miles northwest of Challis, ID. Timber litter. Torching, creeping and smoldering. Trail closures in effect. Last narrative report unless significant activity occurs.

## Fatigue/Stress

Accumulated (Chronic) Fatigue is defined as fatigue from which normal rest does not produce recovery. Accumulated fatigue is often caused by extended periods of stress with inadequate recovery periods, which results in decreased productivity, compromised immune function, and reduced alertness. Fatigued workers perform poorly, behave carelessly, tolerate greater errors and become inattentive. Chronic fatigue often results in increased stress, which may present itself through certain behavioral and physiological indicators, such as those described below:

- Decreased motivation and low morale.
- Increased irritability and depression.
- Confused, poor problem solving.
  - Poor abstract thinking
  - poor attention/decisions
  - poor concentration/memory
- Altered state of alertness.
  - A marked increased or decreased awareness of surroundings.
- Physical reactions (any of these symptoms may indicate need for medical evaluation. When in doubt, contact a medical professional).
  - chills
  - thirst
  - nausea
  - fainting
  - twitches
  - vomiting
  - dizziness
  - weakness
  - chest pain
  - headaches
  - elevated blood pressure
  - rapid heart rate
  - muscle tremors
  - profuse sweating
  - difficulty breathing
- Extreme emotional responses.
  - fear
  - panic
  - intense anger
  - emotional outbursts
  - feeling overwhelmed
  - loss of emotional control
  - inappropriate emotional response
- Social/behavioral changes.
  - withdrawn
  - antisocial acts
  - erratic movements
  - change in speech patterns
  - change in usual communications
  - alcohol or substance abuse
- Recommendations for chronic fatigue/stress are:
  - Take longer periods of rest/recovery
  - Ensure that workers are adequately rested before they begin work shifts
  - Slow the work pace to a moderate level on physically demanding tasks
  - Provide periodic rest breaks to allow physical and mental recovery
  - Alternate between heavy and light tasks
  - Change assignments to prevent boredom
  - Provide breaks, naps, or time off after tasks have been completed
  - Eat well-balanced meals regularly, with energy supplements during periods of high exertion.
  - Maintain hydration
  - Ensure workers maintain good personal hygiene
  - maintain high standards of physical fitness and work capacity
  - Seek medical attention when in doubt of symptoms
  - In extreme cases, personnel may need to be relieved of their duties.
