**Middle Fork Complex** (45 fires), Willamette NF. Washington IMT 2 (Gormley). Lane County, OR. Timber, brush and slash. Moderate fire behavior with backing, creeping and smoldering.

**North Fork**, Umpqua NF. IMT 2 (Batten). Includes the previously reported Rattle fire. Twenty-six miles northeast of Glide, OR. Timber. Minimal fire behavior with smoldering, backing and short uphill runs.

**Wild Rivers Complex**, Siskiyou NF. IMT 2 (Suwyn). Seventeen miles southwest of Grants Pass, OR. Timber, brush and grass. Creeping.

**Swanson Lake**, Northeast District, Washington DNR. Transfer of command from Washington IMT 2 (Reed) back to local unit tomorrow. Four miles southwest of Creston, WA. Timber, grass and brush. Minimal fire behavior. Residences and cultural sites threatened. Area closures in effect.

**Summit Springs Complex** (3 fires), Sisters Unit, Oregon DOF. Transfer of command from Oregon IMT 2 (Hirsch) back to local unit today. Nine miles north of Sisters, OR. Timber and brush. Active fire behavior. Structures and cultural sites threatened.

**Bridge Creek**, Ochoco NF. Transfer of command from IMT 2 (Rapp) back to local unit tomorrow. Five miles southwest of Mitchell, OR. Timber. Creeping and smoldering. Reduction in acreage due to more accurate mapping.

**Ochoco Fire Use – WFU**, Ochoco NF. FUMT (Reidy). Ten miles southwest of Dayville, OR. Timber. Creeping with isolated torching.

**Jack Creek**, Okanogan/Wenatchee NF. FUMT (Bonefeld). Confine/contain management strategy. Thirteen miles southwest of Leavenworth, WA. Subalpine fir. Smoldering. Precipitation occurred over the fire.

**Gnarl**, Mt. Hood NF. Twenty-four miles south of Hood River, OR. Timber. No new information. Last report unless new information is received.

**Lonesome Complex** (3 fires), Rogue River NF. Twenty-one miles northeast of Prospect, OR. Timber. Creeping and smoldering.

**Harvey Lake**, Warm Springs Agency, BIA. Twenty miles west of Madras, OR. Timber. Minimal fire activity.

**Clackamas River Complex** (30 fires), Mt. Hood NF. Twenty-six miles southeast of Estacada, OR. Timber. Creeping and backing. Structures threatened.
