Area Command Team (Ribar) is assigned to manage large fires for the Boise and Payette National Forests.

Murphy Complex, Twin Falls District, BLM. IMT 1 (Hawkins). Includes previously reported Scott Creek LnD from the Winecup Complex. Fifty-six miles southwest of Twin Falls, ID. Brush and juniper. Moderate, sustained fire activity with some running. Numerous communities and ranches remain threatened. Jarbidge evacuation lifted.

Salt Creek, South Central Area, Utah Division of Forestry. IMT 1 (Ruggiero). Five miles east of Nephi, UT. Chaparral, timber and grass. Precipitation resulted in low to moderate fire behavior. Structures remain threatened.

East Zone Complex (three fires), Payette NF. Transfer of command from IMT 2 (Heintz) to IMT 1 (Pincha-Tulley) yesterday. Thirty-two miles northeast of McCall, ID. Timber litter. Moderate fire behavior with torching. Communities, bridges, campgrounds and numerous structures remain threatened.

Granite, Bridger-Teton NF. Fifteen miles southeast of Jackson, WY. Timber, grass, dead and down timber. Minimal fire behavior. Precipitation occurred over the fire area yesterday.

Middle Fork Complex (40 fires), Boise NF. IMT 2 (Whalen) and IMT 2 (Harvey). Fifteen miles northeast of Garden Valley, ID. Timber and brush. Group torching, long-range spotting and moderate surface burning. Structures remain threatened.

Tongue Complex (three fires), Boise District, BLM. IMT 2 (Johnson). Forty-five miles south of Silver City, ID. Brush, grass and juniper. Minimal fire activity.

Paradise, Cedar City Field Office, BLM. Twelve miles northwest of Modena, UT. Timber, brush and grass. Backing fires, short runs, some torching. Structures remain threatened.

Cascade Complex (17 fires), Boise NF. IMT 2 (Suwyn) and IMT 1 (Opliger). Three miles northeast of Cascade, ID. Timber. Inversion moderated fire behavior. Structures remain threatened.

Van Horn, Salmon-Challis NF. Fifteen miles north of Challis, ID. Timber litter, snags, dead and down timber. Group torching, crown runs and creeping.

Black Pine 2, Sawtooth NF. Started on private land eleven miles southeast of Malta, ID. Grass, brush, pinyon pine and juniper. Minimal fire behavior. Precipitation occurred over the fire area yesterday.

North Fork, South Idaho Timber Protective Association, Idaho Department of Lands. Fourteen miles southeast of Donnelly, ID. Timber, heavy dead and downed logs and snags. Minimal fire activity.

Krassel Complex (5 fires), Payette NF. FUMT (Perkins). Forty-four miles northeast of Yellow Pine, ID. Grass, brush, timber litter and downed logs. Low intensity surface fire.

Trapper Ridge, Boise NF. FUMT (Hahnenberg). Twenty-eight miles northeast of Idaho City, ID. Timber litter. Some torching and spotting. Structures threatened.

Kimbell, Salt Lake Field Office, BLM. Seven miles northwest of Grantsville, UT. Timber and grass. Minimal fire behavior. Precipitation occurred over the fire yesterday. Reduction in acreage due to more accurate mapping.

Dakota Hill (five fires), Zion NP. Transfer of command from IMT 2 (Sciacca) to local unit today. Twelve miles northeast of Springdale, UT. Hardwood litter, dead and down timber, grass. Minimal fire behavior. Precipitation occurred over the fire area yesterday. Evacuations will be lifted today and roads will be open to local traffic.

Sleepy Hollow, Wasatch Front Area, Utah State Division of Forestry Fire & State Lands. Nine miles southeast of Logan, UT. Grass and brush. Extreme wind-driven fire behavior with rapid spread. Evacuations in effect.

Jim Canyon, Sawtooth NF. Seven miles west of Curlew, ID. Brush, juniper and grass. Last report unless new information is received.

Poe Cabin, Craig Mountain Area Office, Idaho Department of Lands. IMT 1 (Stanich). Twenty-three miles southwest of Grangeville, ID. Timber and grass. Fire activity increased. Communities and structures remain threatened. Evacuations and road closures remain in effect.

Chimney Complex, Craig Mountain Area Office, Idaho Department of Lands. IMT 2 (Kusicko). Nineteen miles south of Lewiston, ID. Timber and grass. Active fire behavior. Numerous structures remain threatened.

Ahorn, Lewis and Clark NF. IMT 1 (Bennett). IMT is also managing Novak, Little Wolf Creek and Meriwether fires. Thirty miles west of Augusta, MT. Timber litter. Moderate fire behavior. Structures remain threatened. Evacuations remain in effect.

Novak, Central Land Office, Montana DNR. Ten miles southwest of Cascade, MT. Timber, brush and grass. Minimal fire behavior. Structures remain threatened.

Little Wolf Creek, Central Land Office, Montana DNR. Forty-six miles west of Great Falls, MT. Timber, brush and grass. Minimal fire behavior.

Rattlesnake, Nez Perce NF. IMT 2 (Turman). IMT is also managing the Concord WFU. Twenty-five miles south of Elk City, ID. Timber and grass. Moderate fire behavior with isolated torching. Communities and recreation areas remain threatened.

Garceau, Flathead Agency, BIA. IMT 2 (Grant). Fifty-five miles south of Whitefish, MT. Timber and grass. Active fire behavior with short crown runs and long-range spotting. Structures threatened. Evacuations in progress.

Owl, Yellowstone NP. IMT 2 (Wilder). Forty-five miles south of Bozeman, MT. Timber and grass. No new information.

Black Coulee, Lewistown Field Office, BLM. Six miles south of Malta, MT. Grass. Wind-driven fire behavior with rapid rate of spread. Structures threatened.

Skyland, Flathead NF. IMT 2 (LaFave). Forty-five miles east of Whitefish, MT. Timber. Active fire behavior.

Walk In, Northern Cheyenne Agency, BIA. Eight miles northwest of Ashland, MT. Logging slash. Last report unless new information received.

Fool Creek, Lewis and Clark NF. FUMT (Hall). Thirty miles northwest of Choteau, MT. Timber litter. Creeping and smoldering.

Rugby, Lewis and Clark NF. IMT 2 (Angel). Twelve miles west of Neihart, MT. Timber. Creeping and smoldering. Structures remain threatened. Reduction in acreage due to more accurate mapping.

Pattengail Creek, Beaverhead/Deerlodge NF. Ten miles northeast of Wisdom, MT. Timber. Active fire behavior.

Meriwether, Helena NF. Thirty-seven miles northwest of Helena, MT. Timber and grass. Active fire behavior.

Grasshopper, Dakota Prairie National Grasslands, FS. Started on private land twelve miles southwest of Lemmon, SD. Grass. Rapid rate of spread.

Concord, Nez Perce NF. Twenty miles southwest of Elk City, ID. Timber litter. Moderate fire activity. Structures remain threatened.

Elm Street Complex (two fires), Idaho Panhandle NF. Seven miles north of Clarkia, ID. Timber. Smoldering.

Sawmill Creek, Lolo NF. Twenty-two miles southeast of Missoula, MT. Timber. Active fire behavior with torching. Structures threatened.

Harrington Mountain, Bitterroot NF. Twenty-six miles southwest of Darby, MT. Timber and litter. Minimal fire behavior. Last report unless significant activity occurs.

Harrington Ridge, Bitterroot NF. Twenty-six miles southwest of Hamilton, MT. Timber and litter. Minimal fire behavior. Last report unless significant activity occurs.

Isolated torching and short runs. Structures remain threatened. Reduction in acreage due to transfer of Scott Creek LnD fire to the Murphy Complex.

Antelope Complex (six fires), Battle Mountain Field Office, BLM. IMT 1 (Muir). Thirty-six miles north of Austin, NV. Grass. Creeping and smoldering.

Tippetts, Ely Field Office, BLM. Fifty-eight miles northwest of Ely, NV. Brush, grass and juniper. Isolated interior torching.

Cathedral, Humboldt-Toiyabe NF. Twenty-five miles southwest of Ely, NV. Pinyon pine and juniper. Minimal fire behavior.
