Predictive Services Discussion:

Breezy to gusty north-northeast winds will continue across portions of northern California into western Oregon, with relative humidity dropping below 25% in southwest Oregon and northern California. Thunderstorms will stretch from Texas northeastward to the Great Lakes, including severe thunderstorms on the southern Plains. Heavy rain and areas of flooding are expected across north Texas, central and eastern Oklahoma, and western Arkansas into southern Missouri. While relative humidity will increase from previous days, portions of the Lower Mississippi Valley and Southeast will still drop to 25-35% during the afternoon, with breezy east-southeast winds ahead of the approaching cold front. Above normal temperatures will continue across much of the Southeast, with continued below normal temperatures in the Intermountain West.
