

* Aug 1, 2018 FW Resource Aerial Observation, Fairbanks, AK. BLM Fleet Top Cub. Five inch+ hole in the fabric of the horizontal stabilizer and damage to the leading edge after utilizing a remote airstrip. No injuries. <u>NTSB# GAA18CA521</u>.

Incident with Potential (IWP)

*July 16, 2018 Carson City, NV AS350B3 Helicopter in flight impact with unknown object. Post flight revealed paint scratches on tail boom and tail rotor tab indicator damage. No injuries.

*July 22, 2018 Owyhee, NV near mid-air collision between helicopter and fireboss during delivery of fire suppressants. Fireboss switched between Heli A/A & FW A/A frequency when in drop sequence during fuel cycle, resulting in a missed call out during heavy workload on ATGS(t).
