NORTHWEST: Initial attack activity.

CALIFORNIA NORTH ZONE: No significant activity.

CALIFORNIA SOUTH ZONE: Initial attack activity.

NORTHERN ROCKIES: Initial attack activity.

EASTERN GREAT BASIN: Initial attack activity.

WESTERN GREAT BASIN: Initial attack and large fire activity.

QUINN CANYON, Humbolt NF - 1,900 acres. High temperatures and flare-ups are hampering suppression efforts. Containment expected today, 8/1.

MEADOW, Las Vegas District, BLM - 21,600 acres. Type II Team (McAtee) committed. Contained.

ARGENTA, Battle Mountain District, BLM - 1,200 acres. Contained.

SOUTHWEST: Initial attack and large fire activity.

JACKSON, Safford District, BLM - 1,100 acres. Poor access, high winds and heavy fuels are causing control problems. Containment expected today, 8/1.

HINTON, Safford District, BLM - 120 acres. Contained.

BUG, Arizona State - 450 acres. Type II Team (Hollenshead) committed. Fire is threatening residences, a county park and a communications site. Steep rocky terrain and hot and dry weather conditions are posing control problems. No estimate of containment.

ROCKY MOUNTAIN: Initial attack activity.

FLOOD ASSISTANCE, Topeka, Kansas. The Rocky Mountain Area has established a Receiving and Distribution Center in eastern Kansas.

EASTERN: No activity.

FLOOD ASSISTANCE, Shawnee NF - Type II Team (Adams) committed. The Tri-County Flood Team is coordinating emergency actions relating to flooding within the Alexander, Jackson and Union Counties in Illinois.

SOUTHERN: Initial attack and large fire activity.

JUNIPER, Ocala NF - 900 acres. Erratic winds, high temperatures and low relative humidities are hampering control efforts. Containment expected 8/5.

Texas State has a 4,000 acre fire threatening the town of Graham. Spot fires are contributing to control problems. No estimate of containment.

ANALYSIS: Initial attack activity and large fire activity continued in the Southwest, Great Basin and the Southern Areas. The Southwest Area has not received much monsoon moisture yet, however, the relative humidity has increased.

PROGNOSIS: A RED FLAG WATCH is issued for hot weather and northeast breezes for northern California, which will contribute to increased initial attack activity. The west will continue to be mostly sunny and hot with scattered afternoon thunderstorms. Initial attack and large fire potential continues in the Southwest and Great Basin areas. Alaska will be partly cloudy with scattered showers. Partly cloudy with afternoon thundershowers in the Southern Area.

GRANITE, California Desert District, BLM - 350 acres. Contained.

RANCHO, California State - 1,100 acres. Control efforts on the fire are hampered by high temperatures, steep terrain and shifting winds. Current threat is to the Carmel River watershed. No estimate of containment.

NORTHERN ROCKIES: No significant activity.

EASTERN GREAT BASIN: No significant activity.

WESTERN GREAT BASIN: Large fire activity.

QUINN CANYON, Humbolt NF - 1,900 acres. Contained.

SOUTHWEST: Initial attack and large fire activity.

JACKSON, Safford District, BLM - 1,200 acres. Contained.

BUG, Arizona State - 2,300 acres. Type II Team (Hollenshead) committed. A county park, communication site and residences are currently threatened. Hot, dry weather conditions and steep rocky terrain are hampering suppression efforts. No estimate of containment.

EDWARDS, Tonto NF - 1,500 acres. Control problems include steep, inaccessible terrain and high winds. Current threats are to private land and structures. No estimate of containment.

ROCKY MOUNTAIN: Initial attack activity.

FLOOD ASSISTANCE, Topeka, Kansas. The Rocky Mountain Area has established a Receiving and Distribution Center in eastern Kansas.

EASTERN: No activity.

FLOOD ASSISTANCE, Shawnee NF - Type II Team (Adams) committed. The Tri-County Flood Team is coordinating emergency actions relating to flooding within the Alexander, Jackson and Union Counties in Illinois.

SOUTHERN: Initial attack and large fire activity.

JUNIPER, Ocala NF - 1,150 acres. The fire was less active due to increased relative humidities and lower winds. Containment expected 8/5.

MING BEND, Texas State - 4,000 acres. Contained.

ANALYSIS: Fire activity in the Southwest Area continued as the monsoonal front has not moved in to bring any relief. Initial attack activity increased in California due to record high temperatures. Colorado initial attack activity increased due to thunderstorms.

PROGNOSIS: Continued warm temperatures and scattered thunderstorms will dominate the Southwest, Great Basin and Rocky Mountain Areas. Initial attack activity will continue to escalate in all areas of the west and in the Southern Area due to the warm, drying conditions.

B248, Tanana Zone, Alaska State - 36,000 acres. High winds caused fire to spot across the pipeline corridor and haul road. The spot is estimated to be 250 acres. No estimate of containment.

NORTHWEST: Initial attack activity.

CALIFORNIA NORTH ZONE: No significant activity.

CALIFORNIA SOUTH ZONE: Initial attack and large fire activity.

RANCHO, San Benito-Monterey RU, California State - 5,000 acres. Steep terrain, poor visibility from smoke, high temperatures and low relative humidities are hampering suppression efforts. The Carmel River watershed continues to be threatened. Containment expected today, 8/3.

BALD MOUNTAIN, Inyo NF - 350 acres. The fire burned over Bald Mountain Lookout with no reported structural damage. Current threats are to a recreation area and a private trout farm. Containment expected today, 8/3.

NORTHERN ROCKIES: No significant activity.

EASTERN GREAT BASIN: Initial attack and large fire activity.

BULLDOG, Cedar City District, BLM - 1,000 acres. Contained.

WESTERN GREAT BASIN: No significant activity. SOUTHWEST:

Initial attack and large fire activity.

JAVALINA, Safford District, BLM - 167 acres. Contained.

BUG, Arizona State - 5,676 acres. Type II Team (Hollenshead) committed. The fire continues to threaten a county park, communication site and residences. Hot, dry weather conditions coupled with steep rocky terrain are causing control problems. Containment expected today, 8/3.

EDWARDS, Tonto NF - 2,000 acres. Type II Team (Kahon) committed. High winds and steep inaccessible terrain continue to hinder suppression efforts. No estimate of containment.

ALDER, Tonto NF - 115 acres. Contained.

BLACK MOUNTAIN, Arizona State - 700 acres. Contained.

BONITA CREEK, Safford District, BLM - 160 acres. Contained.

ROCKY MOUNTAIN: Initial attack and large fire activity.

ROATCAP, Montrose District, BLM - 150 acres. Type II Team (Hart) committed. Steep terrain, high winds and inaccessibility are hampering control efforts. Current threat is to a coal mine powerplant and a cow camp. Containment expected today, 8/3.

FLOOD ASSISTANCE, Topeka, Kansas. The Rocky Mountain Area has established a Receiving and Distribution Center in eastern Kansas.

EASTERN: No activity.

FLOOD ASSISTANCE, Shawnee NF - Type II Team (Adams) committed. The Tri-County Flood Team is coordinating emergency actions relating to flooding within the Alexander, Jackson and Union Counties in Illinois.

SOUTHERN: Initial attack and large fire activity.

The State of North Carolina has a 958 acre fire burning in Brunswick County. The fire is burning near Highway 211 which has been closed due to smoke. No other information available.

JUNIPER, Ocala NF - 1,150 acres. The fire was less active due to increased relative humidities and lower winds. Containment expected 8/5.

ANALYSIS: Increased fire activity continued in Arizona, California and Colorado due to persisting hot, dry weather conditions and thunderstorm activity. Twelve Type I crews, 8 airtankers, 1 leadplane and 3 Type II helicopters have been mobilized to the Southwest, mainly in support of the fires on the Tonto NF.

PROGNOSIS: A RED FLAG WATCH has been issued for dry thunderstorms and low relative humidity for west-central Nevada, Lake Tahoe and Sierra east slopes. Potential exists for increasing initial and extended attack fires due to continued high temperatures and scattered thunderstorms in the Southwest, Great Basin, southern California and Rocky Mountain Areas.

FLOOD ASSISTANCE, Shawnee NF - Type II Team (Adams) committed. The Tri-County Flood Team is coordinating emergency actions relating to flooding within the Alexander, Jackson and Union Counties in Illinois.

BIG WELL, Arizona State - 1,500 acres. Type II team (Moore) committed. The fire is very hard to contain due to shifting winds and rugged terrain. Several power poles caught on fire and a ranch house was being threatened. No estimate of containment.

NEW WATER, Truxton Canyon Agency, BIA - 600 acres. Contained.

ROCKY MOUNTAIN: Initial attack activity.

FLOOD ASSISTANCE, Topeka, Kansas. The Rocky Mountain Area has established a Receiving and Distribution Center in eastern Kansas.

EASTERN: No significant activity.

Activity in Alaska will have areas of light rain with little or no thunderstorm activity. ANALYSIS: Initial attack and large fire activity continued in the Southern Area while the remainder of the U.S. experienced minimal activity.

PROGNOSIS: Mostly sunny skies with warmer temperatures will prevail over most of the western U.S. today with increasing clouds in northern California. The Southern Area, southwestern New Mexico mountains, and the central Colorado Rockies will receive scattered afternoon and evening thundershowers which may curtail fire activity in these areas.

A cold front will extend from the Ohio Valley into central Texas, bringing scattered showers and cooler temperatures. Louisiana will be partly cloudy with scattered afternoon and evening thundershowers. This weather pattern should help to moderate fire potential in both of these areas.
