MEADOW CREEK, Wenatchee NF - 410 acres. Type II Team (Jones) committed. Spot fires and unburned fuels are producing control problems. Plantations, cultural sites and key watershed are threatened. Containment expected 10/2.

CALIFORNIA NORTH ZONE: Initial attack activity.

CALIFORNIA SOUTH ZONE: Initial attack and large fire activity.

MARRE, Los Padres NF - 31,000 acres. Type I Team (Dougherty) committed. Fire activity decreased yesterday due to higher humidity. Direct attack of the fire is progressing. Steep terrain and limited access is hindering control efforts in the wilderness. The fire is 50% contained with full containment expected 10/5.

NORTHERN ROCKIES: Initial attack activity.

PROGNOSIS: A RED FLAG WATCH has been issued for east winds in western Washington and northwestern Oregon for tonight. Sunny, hot "and dry weather conditions will remain in California, continuing the . potential "for initial attack and large fire activity. Utah, Nevada and northern Arizona sunny and slightly cooler, minimal fire activity is expected. Fire activity is expected to continue in the Northwest Area with sunny and warm conditions coupled with east winds.

Flat Canyon, Manti-LaSal NF - 1,400 acres. Type II Team (Barber) committed. Timber resources, gas and powerlines, and private developments continue to be threatened. Low humidities, steep slopes and heavy fuels are hampering suppression efforts. Containment expected 10/14.

Meadow Creek, Utah State - 1,250 acres. Erratic winds, and very dry fuels are hindering control efforts. Containment expected 10/4.

ANALYSIS: Good progress continued to be made on existing large fires with minimal resource mobilization occurring. Moderate initial attack activity continued in California and the Northwest Area.

PROGNOSIS: A RED FLAG WARNING has been issued for strong winds and low humidities in southwest Utah. Fire activity is expected to continue in Utah with continued warm, dry and windy conditions. California will be cooler with higher humidities and a chance of showers in the northern portion and along the southern coast. This marine influence should decrease initial attack and allow progress toward containment of the Marre Fire. The Northwest Area will have a shallow layer of marine air in the western valleys bringing cooler temperatures and higher humidities. Fire activity is expected to decrease with forecasted conditions.

This cooler weather pattern should limit initial attack activity and aid in the containment of existing fires, throughout the western states.

STECKLE, Ventura County - 26,500 acres. The fire is 90% contained with full containment expected today, 10/31.

CALIFORNIA, Riverside RU, California State - 25,100 acres. Contained.

GUEJITO, San Diego RU, California State - 20,722 acres. East winds caused increased activity on the fire yesterday. Containment expected 11/1.

NORTHERN ROCKIES: No activity.

EASTERN GREAT BASIN: No activity.

WESTERN GREAT BASIN: No activity.

SOUTHWEST: No activity.

ROCKY MOUNTAIN: No activity.

EASTERN: No activity.

SOUTHERN: No activity

ANALYSIS: Good progress continues to be made on fires in southern California as they meet containment targets. Initial attack activity has moderated. A significant amount of reassignment and demobilization of resources has occurred within southern California.

PROGNOSIS: The high pressure ridge will weaken today. This will cause light winds, cooler temperatures and slightly higher humidity over the coastal section of southern California. This should aid firefighters in meeting containment goals on large fires and minimize initial attack activity. A surface high will move into the Pacific Northwest late today increasing north winds in northern California. Initial attack activity is expected to continue.
