

INCIDENT MANAGEMENT SITUATION REPORT  
THURSDAY, AUGUST 15, 1996 - 0530 MDT  
NATIONAL PREPAREDNESS LEVEL IV

\*\*\* ALL FIREFIGHTERS HAVE THE RIGHT TO A SAFE ASSIGNMENT \*\*

CURRENT SITUATION: Most Areas experienced increased fire activity yesterday, especially Northern California and the Northwest Areas. Initial attack resources remain scarce and the competition for national resources continues. Two Type I Incident Management Teams were ordered, one for Northern California and one for Southern California. Type II Incident Management Teams were committed in California and the Great Basin. Resource mobilization through NICC remained high.

Northwest Large Fires:

SIMNASHO, Warm Springs Agency, BIA. A Type I Incident Management Team (Porter) is assigned. This fire is burning in grass, brush and timber 10 miles north of Warm Springs, OR. The fire made a major run yesterday, crossing Highway 26 north of the town of Warm Springs. The BIA Fire Center, north of Warm Springs was temporarily evacuated as the fire moved within 20 feet of the center. At least 5 homes have been destroyed and 80 homes are currently evacuated. The resort at Kah-nee-tah remains threatened but has not been evacuated. Suppression efforts are hampered by terrain.

WILDCAT, Malheur NF. A Type I Incident Management Team (Dubois) is assigned. The fire is 10 miles southeast of John Day, OR. Crews worked to reinforce existing firelines and mop up spots on the east side of Strawberry Creek. Suppression resources are assisting with initial attack on the forest. Permanent and summer residences, the Blue Mountain Hot Springs Resort and recreational areas remain threatened.

COW HOLLOW COMPLEX, Vale District, BLM. A Type II Incident Management Team (McDonald) is assigned. The fire is burning in brush and grass 8 miles south of Vale, OR. The fire continues to make runs and some structures continue to be threatened. Dry fuels are the major control problem. The community of Vale, OR. is no longer threatened.

SLOAN'S RIDGE, Wallowa-Whitman NF. A Type I Incident Management Team (Payne) is assigned. The fire is burning in subalpine fir and lodgepole 12 miles northwest of Sumpter, OR. Heavy rain on Tuesday helped with suppression efforts. Blasters from Oregon Department of Forestry continue to build line with fire line explosives. Crews are also assisting with initial attack on new lightning starts.

SALT COMPLEX, Wallowa-Whitman NF. A Type I Incident Management Team (Bailey) and a Type II Incident Management Team (Lukens) are assigned. The fires are burning on the Oregon/Idaho border of the Hells Canyon Recreation Area. The complex consists of the SALT CREEK and HEAVEN'S GATE fires. The Salt Creek Fire continues to move northward, with some movement to the south. Crews are stationed at Dorance Cow Camp and Tryon Ranch for protection of these areas. On Heaven's Gate, crews are working at keeping the fire out of the Salmon River drainage.

WHEELER, Oregon State. A State Incident Management Team (Hunt) is assigned. The fire is burning near Spray, OR., 15 miles southwest of Heppener, OR. A major threat to the community of Spray continues. Some mop-up has begun in key areas of the fire. DONNEYBROOK, Oregon State. This fire is burning around the community of Ashwood, OR., 20 miles northeast of Madras, OR. Rural and volunteer units have been working the fire. Burn-out operations have been successful. Residences in Ashwood continue to be threatened.

BARTLETT MTN., Burns District, BLM. The fire is burning south of Drewesy, OR. There are scattered ranches in the area, but they are not threatened at this time. Precipitation from passing cells kept fire behavior at a moderate level.

BULL, Umatilla NF. A Type II Incident Management Team (Curtsey) is assigned. The fire is burning near the lookout at Desolation Butte on the edge of the North Fork of the John Day Wilderness, 20 miles southeast of Ukiah, OR. A lookout and repeater are threatened.

SOUTH ZONE COMPLEX (formerly reported as RIGDON COMPLEX), Willamette NF. A Type II Incident Management Team (Gardner) is assigned. The fires in this complex are burning 11 miles southeast of Oakridge, OR. Fourteen fires in the complex are staffed, with the remaining fires being monitored. Current threats are to major communication and lookout towers, private timber land, late successional reserves and threatened and endangered species.

SPRING, Umpqua NF. A Type II Incident Management Team (Murphy) is assigned. The fire is burning in the Boulder Creek Wilderness of the Diamond Peak Ranger District. The area is very rugged and access is limited. No additional information has been received.

ALDER RIDGE, Fremont NF. A Type II Incident Management Team (Duke) is assigned. The fire is burning 15 miles south of Silver Lake, OR. The fire made a major run yesterday resulting in the evacuation of Thompson Reservoir. Powerlines, campground structures and threatened and endangered fish habitat are threatened.

One fire is in a confinement suppression strategy totalling 740 acres.

#### Northern California Large Fires:

ROCK, Shasta-Trinity NF. A Type II incident Management Team has been ordered. The fire is located approximately 40 airmiles southwest of Redding, CA. Inaccessability to the fire is hampering containment efforts.

FORK, Mendocino NF. A Type I Incident Management Team (Kohut) is assigned. The fire is burning north of the town of Upper Lake, CA. Extreme fire behavior resulted in burning over of High Glade Lookout. The lookout was safely evacuated well before the burn over. Approximately 40 homes remain evacuated with an additional 40 homes are threatened.

ALTUNA, Shasta-Trinity NF. A Type II Incident Management Team has been ordered. The fire is located about 40 miles north of Redding, CA. Good progress was made yesterday constructing dozer line. Terrain, winds, and access are hampering containment efforts.

HORSE, Shasta-Trinity NF. A Type I Incident Management Team (Loving) has been ordered. The fire is located on the Shasta and Siskiyou county line. The fire is actively burning in grass and brush. No other information was available.

#### Southern California Large Fires:

KAWEAH, Tulare Ranger Unit, California State and Sequoia Kings NP. A State Type I Incident Management Team (Benson) is assigned. Numerous structures in the community of Three Rivers and Park residences are threatened and have been evacuated. A National Type I Incident Management Team (Monahan) has been ordered.

ROGGE, Stanislaus NF. A Type II Incident Management Team has been ordered. The fire is burning in the Tuolumne River drainage near the community of Pine Mountain Lake. Rapid downhill spread was experienced yesterday afternoon. Concerns are that the fire will jump the Tuolumne River and become a threat to Pine Mountain Lake.

AKERSON COMPLEX, Yosemite NP. This complex consists of the ACKERSON, MIGUEL, MATHER, POOPENAUT and GRAVEL fires. Structures, historic structures, camps and a telecommunications facility are currently threatened. Heavy fuels and steep terrain are hampering control efforts.

The WOLFSKILL, Riverside Ranger Unit, California State. A State Type I Incident Management Team (Wright) is assigned. This fire is burning in steep terrain near Banning, CA. The fire escaped control lines again yesterday, pushing the containment date back to this evening.

TUOLUMNE COMPLEX. A State Type I Incident Management Team is assigned. All fires in the complex are contained except the Keystone and Baseline. No other information was reported.

ESPERANZA COMPLEX, Tuolumne-Calaveras Ranger Unit, California State. A State Type I Incident Management Team (Ditullia) is assigned. The complex is made up of 16 fires, all but the Rimrock are contained. Good progress is being made towards containment.

#### Northern Rockies Large Fires:

COYOTE, Lewis and Clark NF. A Type I Incident Management Team (Frye) is assigned. The fire is burning within a logging operation 15 miles south of Monarch, MT. Good progress was made as weather moderated and resources arrived. A structure protection plan has been completed for the town of Neihart as well as residences in O'Brien and Johnson Creeks. No structures have been destroyed, however logging equipment was destroyed during the initial run on Monday. Threats remain to Showdown Ski Area, Montana power transmission lines, Watershed, West slope cutthroat trout habitat, private residences, the town of Niehart and an experimental forest.

WILLOW CREEK COMPLEX, Bitterroot NF. A Type II Incident Management Team (Spradlin) is assigned. Good progress was made on both fires in the complex. Crews began mop-up inside control lines and burnout of unburned portions on the Lower Willow fire. Firefighters completed a burnout in an existing cutting unit on the west flank of the Upper Willow fire. One division is unstaffed due to safety concerns and potential for growth to the east. The threat to Willow Mountain Lookout and residences has been reduced. Steep slopes, unburned fuels, multiple spots and heavy fuel loading are the most critical problems.

MOOSE BUTTE COMPLEX, Nez Perce NF. A Type II Incident Management Team (Cowin) is assigned to this incident south of Elk City, ID. The MOOSE BUTTE and LITTLE GREEN MOUNTAIN fires are included in this complex. Crews on the Moose Butte fire continue mop-up and patrol for spots. Infrared did not indicate significant spots outside of the perimeter. Crews on the Little Green Mountain continue to hold and improve lines and have begun mop-up. Crews are gridding and patrolling for spots, as infrared indicated spots more than 1/4 mile outside of the perimeter.

SWET/WARRIOR, Nez Perce NF & Bitterroot NF. A Prescribed fire Team is assigned. Declaration as wildfires resulted from the inability to validate availability of contingency resources.

One fire is in confinement suppression strategy totalling 220 acres.

#### Western Great Basin Large Fires:

GOLD QUARRY COMPLEX, Elko District, BLM. A Type II Incident Management Team (Vorce) has been ordered. The complex consists of the TUNNEL and SUSIE CREEK fires.

JERSEY, Battle Mountain District, BLM. The fire is located 50 miles southwest of Battle Mountain, NV. The current threat is to a historic building, a ranch, and a microwave communications site. Resources threatened include riparian habitat, critical summer and winter deer range, grazing allotments and private property. Limited access in steep terrain along with strong, gusty winds are hampering control efforts.

HUMBOLDT, Winnemucca District, BLM. A Type II Incident Management Team (Burdick) is assigned. This fire is located 45 miles northeast of Winnemucca, NV. Gusty winds caused flare-ups in pockets of unburned fuel. Current threats are to ranches, mines, a mining exploration camp (valued at a \$500,000), Big Horn Sheep habitat and critical deer winter range. There is also a potential threat to the town of Midas, where structural protection units are in place.

TROUT CANYON, Toiyabe NF. The fire is burning 40 miles west of Las Vegas, NV. Decreased winds allowed crews to make good progress yesterday. Potential threats to the community of Trout have lessened, although several spot fires remain outside of the perimeter.

SHOEMAKE, Ely District, BLM. The fire is located 35 miles southeast of Caliente, NV. The fire continued to burn actively, threatening critical deer winter range and Desert Tortoise. Control problems include steep terrain, poor access and extreme fire behavior.

MT. JACKSON, Toiyabe NF. A Type II Incident Management Team (Carlson) is assigned. The fire is 5 miles north of Bridgeport, CA. Lower temperatures and higher humidities aided suppression efforts yesterday.

WOOTER, Winnemucca District, BLM. The fire is located 70 miles northwest of Winnemucca, NV. Current threats are to Big Horn Sheep habitat and a historic mining site. Steep terrain is hindering control efforts.

# Eastern Great Basin Large Fires:

DANIELS, Uinta NF. A Type II Incident Management Team (Furlong) is assigned. This fire is 9 miles southeast of Heber, UT. Good progress was made yesterday. Control problems continue to be steep terrain and thunderstorms.

LIME KILN #3, Caribou NF. The fire is located 4 miles northwest of Malad, ID., threatening grain fields and structures. Steep terrain and hot weather are hampering control efforts.

HENS PEAK, Fishlake NF. This fire is located 11 miles northeast of Loa, UT. Good progress was made yesterday with work continuing on hot spots. Timber sales and spruce plantations remain threatened.

ADELAIDE COMPLEX, Fishlake NF. A Type II Incident Management Team (Shive) is assigned. The fires are 5 miles southeast of Kanosh, UT. The complex consists of the ADALAIDE and DOG MOUNTAIN fires. No new information was received.

HOT SPRINGS, Boise District, BLM. The fire is burning on rangelands 14 miles southwest of Glenns Ferry, ID. Control problems are not anticipated at this time. BASE, Boise District, BLM. This fire is located 9 miles northwest of Mountain Home, ID., threatening numerous structures and private improvements.

BOULTER, Richfield District, BLM. This fire is located 7 miles west of Eureka, UT. Good progress was made yesterday.

TUANNA GULTCH, Boise District, BLM. The fire is burning in grass and sage 13 miles west of Gooding, ID. Some precipitation was received on the fire yesterday. Control problems are not anticipated at this time.

Three fires are in a confinement suppression strategy totalling 6,104 acres.

Strong high pressure aloft will remain centered over the Great Basin and desert Southwest. Circulation about the high continues to pump moist and unstable sub-tropical air into much of the West. Widely scattered thunderstorms are forecast for the Great Basin with some of them dry in eastern Nevada and Utah. Scattered wet thunderstorms are forecast for the central and southern Rockies and the desert Southwest. A drier more stable westerly flow of air will move into California and Oregon. A Pacific Cold Front will bring cooler temperatures and a few coastal showers to western Washington. High temperatures will range from the mid 60's and 70's in western Washington to 110 in the desert Southwest, most areas will be in the mid 80's to near 100.
