

INCIDENT MANAGEMENT SITUATION REPORT
MONDAY, AUGUST 3, 1998 - 0530 MDT
NATIONAL PREPAREDNESS LEVEL II

CURRENT SITUATION:

Texas, Oklahoma and the Northwest Area continue to experience initial attack and large fire activity. Minimal activity was reported elsewhere. The National Interagency Coordination Center processed orders for a equipment, engines and overhead. Very high and extreme fire indices were reported in Texas, Oklahoma, Arkansas, Michigan, Colorado, Arizona, New Mexico, Nevada, Utah, Idaho, Montana, South Dakota, Washington and California.

SOUTHERN AREA LARGE FIRES:

BEAR MOUNTAIN COMPLEX, Oklahoma State. A Unified Command structure is in place and a Type II Incident Management Team (Bollman) is assigned. Forces continue to mop-up, patrol and assist initial attack as requested. There were several new starts in the complex yesterday. A lack of resources has resulted in many contained fires in patrol status without full mop-up or control. The Cut Through Fire has been contained.

CASH COMPLEX, Texas State - Hunt County. Twenty four structures are reported threatened. No other information was reported.

ESCOTA, Texas State - Fisher County. The fire made a major run yesterday, threatening oil tanks and buildings.

MUD FIRE, Big Thicket National Preserve. This fire is burning in a remote area of hardwoods, leaf litter and pockets of very thick brush and downfall created by the infestation of the Southern Pine Beetle. Thick brush is slowing handline construction. Efforts are being made to provide water to the line.

LYE CREEK, Texas State - Shelby County. The fire is burning in timber plantations and resident timber stands. Containment efforts are going well.

RICHLAND CREEK, Texas State - Navaro County. Eighteen structures were saved yesterday.

BRUSHY, Texas State - Callahan County. Two slopovers were contained on the fire yesterday.

O BAR O, Texas State - Kent County. The fire is lined and efforts to improve mop-up are in progress. The fire is threatening an oil storage area and associated facilities. Shifting winds, heavy oak and juniper brush are contributing to control problems.

SUGAR LOAF, Texas State - Palo Pinto County. The line was completed yesterday, but efforts to secure remains difficult. Full containment is expected today.

NORTHWEST LARGE FIRES:

#801, Oregon State - Jefferson County. This fire threatened and forced the evacuation of a subdivision ten miles west of Madras. Initial attack was effective and no homes were reported lost.

WHITE PASS COMPLEX, Gifford Pinchot NF. A Type II Incident Management Team (Furlong) is assigned. This complex is located at White Pass Ski Area and consists of ten fires, the largest being two hundred fifty acres. A transition to local districts is taking place today. Full containment was expected last night.

EASTERN AREA LARGE FIRES:

SLASH PILE, Hiawatha NF. This fire is located four miles south of Rapid River. The fire is burning in Jack Pine, slash and tornado blow down. Some torching and spotting occurred up to one quarter of a mile. No homes were reported damaged or lost and the evacuation order was lifted last night.

OUTLOOK:

In the western U.S. an upper ridge will strengthen over central California bringing hotter and drier weather. There is a heat advisory for portions of Arkansas, Texas and Oklahoma. Texas will be mostly sunny and hot with scattered thunderstorms in the far

west and north Texas. Oklahoma and Arkansas will be partly cloudy, hot and humid with scattered thunderstorms. High temperatures will be in the 90's to 108.

Michigan will be mostly sunny with high temperatures in the mid 70's to lower 80's.
