

INCIDENT MANAGEMENT SITUATION REPORT
 FRIDAY, JANUARY 29, 1999 - 1000 MST
 NATIONAL PREPAREDNESS LEVEL I

CURRENT SITUATION:

Initial attack activity continued in the Southern Area. The National Interagency Coordination Center processed orders for a type I helicopter, communications equipment and miscellaneous overhead positions for the Southern Area this past week.

OUTLOOK:

Mississippi and Georgia will have scattered showers today moving into South Carolina and Florida tomorrow. Widespread rain and thunderstorms are forecast for Sunday and Monday. Tuesday will be partly cloudy with scattered showers and thunderstorms Wednesday and Thursday. High temperatures will be in the 50's and 60's with 70's to lower 80's in Florida.

Southern California will be mostly sunny today with locally gusty winds in the passes and canyons. Cloud cover will increase Saturday bringing mostly cloudy skies Sunday and Monday with a chance of showers and mountain snow. Tuesday and Wednesday will be dry with an increasing chance of showers again on Thursday. High temperatures will range from the mid 30's and 40's in the mountains to the 50's and 60's in the lower elevations.

The Southwest Area will have a few rain or snow showers Friday and again on Monday, otherwise it will be dry. High temperatures will range from the 30's to 40's in the mountains to the 60's and lower 70's in southern Arizona.
