

INCIDENT MANAGEMENT SITUATION REPORT
TUESDAY, JULY 27, 1999 - 0530 MDT
NATIONAL PREPAREDNESS LEVEL II

CURRENT SITUATION:

Moderate initial attack activity was reported in the western United States. A new large fires were reported in the Rocky Mountain Area. Good progress was accomplished on large fires in the Northern Rockies, Eastern Great Basin and southern California Areas with containment accomplished on several large fires. The National Interagency Coordination Center mobilized a lead plane, type 1 and 2 helicopters, telecommunications equipment, a caterer, a shower, engines, crews and miscellaneous overhead. High to extreme fire indices were reported in Oregon, Washington, California, Montana, North Dakota, Idaho, Utah, Nevada, Wyoming and New Jersey.

NORTHERN ROCKIES LARGE FIRES:

FISHEL CREEK COMPLEX, Southern Land Office, Montana State. A Type II Incident Management Team (Hoff) is assigned. This fire is thirty-five miles northeast of Roundup, MT. One residence, three cabins, three out buildings and several thousand acres of rangeland have been lost. Ten homes and ranches were saved. Some threat to structures still exists. Good progress was made on fireline construction. Musselshell County has received a FEMA Emergency Funding Declaration.

PINCHOT, Nez Perce National Forest. This human caused fire in the Selway Bitterroot Wilderness is thirty-one miles east of Lowell, Idaho. No new information was received.

SHIVELY, Crow Agency, BIA. This will be the last report unless new information is received.

HAPPY CAMP ABC, Klamath National Forest. A Type II Incident Management Team (Weltch) is assigned. There are 43 fires within the Happy Camp, Ukonom and Salmon River Ranger Districts. The East fire is 160 acres, the Lighting fire is 35 acres, the Five fire is 50 acres, and the Snag/Cub fire is 10 acres. The Stein fire is 10 acres. One person was evacuated with injuries.

ROCKY MOUNTAIN LARGE FIRE:

BULL ELK PARK, Big Horn National Forest. A Type II Incident Management Team (Hartman) is assigned. This fire is in Sheridan County, 17 miles west of Dayton, Wyoming. The fire is burning in a heavy, old growth lodgepole stands in Lick Creek and the Dry Fork of the Little Big Horn Drainage. Control has been difficult due to low fuel moisture and steep slopes. Heavy fuels, spotting, torching, crowning, and high winds are the principle spread components.

SOUTHERN CALIFORNIA LARGE FIRES:

TURTLE, San Bernardino National Forest. This fire is near the intersection of Interstate 15 and Cajon Pass. Structures in the West Cajon Valley remain threatened. The fire was active in the vicinity of several residences, however no structures were lost. A large slop over was contained by ground crews and air support.

EASTERN GREAT BASIN LARGE FIRES:

SOLDIER, Salmon/Challis National Forest. A Fire Use Management Team (Johnson) is assigned. These two lightning ignited fires are thirty miles northwest of Stanley, Idaho, and are being managed to accomplish resource objectives. The fire expansion continues to progress slowly, with most growth during the night time inversion. Rolling material and torching continues to be observed. Resource assignments and trigger points continue to be developed. Preparation for a burnout operation on Greyhound Ridge will begin today.

OUTLOOK:

High pressure continues to dominate the weather across the western part of the country with monsoon moisture moving north out of Mexico into the southern states. An upper level trough along the west coast will keep the western and northern states dry and warm.

Colorado, Utah, New Mexico and Arizona will experience monsoonal moisture with showers and thunderstorms. Southern and eastern Nevada and southern Wyoming will have scattered showers. Arizona, southern Nevada and southern Utah will experience locally heavy rain with thunderstorms.

The rest of the western states will be dry with mostly sunny skies except for morning low clouds and fog along the coast. Local areas of Southern Idaho will see minimum relative humidities below 10 percent.

High temperatures will range from the 60's and 70's along the coast with 70's to 80's in the mountains. Mid 90's to 110 will be observed in the lower elevations and desert areas.
