

INCIDENT MANAGEMENT SITUATION REPORT  
SUNDAY, JULY 30, 2000 - 0700 MDT  
NATIONAL PREPAREDNESS LEVEL V

CURRENT SITUATION:

Five new large fires were reported, one each in the Eastern Great Basin, Rocky Mountain, Northern Rockies, Southwest, and Southern California Areas. Lightning is forecast for the eastern Oregon and Washington areas today, as well as southwestern Montana, which may increase initial attack activity. Containment goals were reached on seven large fires.

Mobilization of aircraft, equipment, crews and overhead through the National Interagency Coordination Center continues to be steady. Very high to extreme fire danger indices were reported in numerous units throughout the 11 western states and in Texas. The Pentagon's Directorate of Operations for Military Support (DOMS) has been requested to supply one military battalion to assist in the fire suppression effort. An advance party will fly to Ft. Hood, Texas today. Training will begin Monday.

EASTERN GREAT BASIN AREA LARGE FIRES:

Priorities are being established by the Great Basin Multi-Agency Coordinating Group based on information submitted via Wildfire Situation Analysis reports and Incident Status Summary (ICS-209) forms.

TWIN CREEK, Salmon-Challis National Forest. A Type I Incident Management Team (Stam) is assigned. This fire is 30 miles north of Salmon, ID near the Lost Trail Ski Area. Moderate fire behavior has been reported during the past 24 hours, with continued torching in the subalpine fir. Very low relative humidity and numerous uncontained spot fires are causing problems.

CLEAR CREEK, Salmon-Challis National Forest. Two Type I Incident Management Teams (Hart and Bateman) are assigned. The fire is 20 miles northwest of Salmon, ID. The fire has crossed Panther Creek and moved up Trial, Napias and Deep creeks to the east. Structural protection has been the main focus. Extreme burning conditions and spotting are deterring containment efforts. Rolling material in steep terrain is causing problems for fireline construction.

MOONSHINE, Upper Snake River District, Eastern Idaho Area, BLM. This fire is burning in sagebrush, grass and scattered timber 13 miles east of American Fork, ID. The fire jumped containment lines and made a major run, resulting in an additional 4000 acres burned. Approximately 32 structures and Native American cultural resources are threatened.

YANCE COMPLEX, Fishlake National Forest. A Type II Incident Management Team (Ostman) is assigned. This complex consists of the Yance and the Morning Dove fires, which are four miles northwest of Scipio, UT. Upslope runs, crowning and long range spotting have been observed. Powerlines and communication sites in the Leamington Pass area are threatened.

OLDROYD, Fishlake National Forest. A Type I Incident Management Team (Hutchinson) is assigned. This fire is 20 miles south of Richfield, UT.

The fire has been active on all sides. Approximately 25 summer residences are threatened to the northwest of the fire.

BROAD, Southcentral Utah State. This fire is burning in grass and pinyon pine four miles northeast of Leamington, UT. Crews made good progress constructing fireline, and all previously constructed lines held well. Spotting, torching and some running were observed.

WASATCH COMPLEX, Wasatch-Cache National Forest. A Type I Incident Management Team (Dague) is assigned. This complex consists of the Iron Mine Lake, Cottonwood, East Vivian and Wallsburg fires, all located southeast of Salt Lake City, UT. The East Vivian fire continues to challenge containment efforts and is half a mile from structures in South Fork Canyon. A structure protection plan is in place. The Wallsburg fire had numerous spot fires, but crews are making good progress containing them. Mopup and rehabilitation efforts are nearly complete on the Cottonwood and Iron Mine Lake fires.

JOHN ALLEN, Dixie National Forest. The fire burning in ponderosa pine, fir and heavy ground fuels ten miles northwest of Escalante, UT. Containment efforts are hindered by extremely dry fuels. Posey Lake Campground, a lookout and timber resources are threatened.

WEST FORK, Upper Snake River District, Eastern Idaho Area, BLM. This fire is five miles south of Lava Hot Springs, ID. Ten residences and ten commercial buildings are threatened in the community of Lava Hot Springs. A voluntary evacuation order is in effect.

HIGH POINT, Wasatch-Cache National Forest. A Type II Incident Management Team (Carr) is assigned. This fire is 1.5 miles east of Logan, UT. Ten structures are threatened, along with watershed, microwave sites and powerlines. Observed fire behavior was torching and small uphill runs. Concerns include an urban interface area west of the fire.

BURGDORF JUNCTION, Payette National Forest. A Type I Incident Management Team (Vail) is assigned. The fire is 23 miles north of McCall, ID. Torching, spotting and some crowning have been observed on the north side of the fire. Crews are locating spots outside of the main fire perimeter. Continued hot and dry weather with a forecast Haines Index of six today will challenge containment efforts.

COFFEE POINT NORTH, Upper Snake River District, Eastern Idaho Area, BLM. A Type I Incident Management Team (Humphrey) is managing this and other large fires in the eastern Idaho area. This fire is burning in grass and sagebrush six miles northwest of Springfield, ID. Active torching and spotting have been observed. Critical wildlife habitat is threatened.

FISHER SPRINGS, Upper Snake River District, Eastern Idaho Area, BLM. The fire was ignited by lightning eight miles southeast of Pocatello, ID. The fire is threatening structures on the Fort Hall Indian Reservation. The Rattlesnake fire (2000 acres) is also burning in the vicinity.

BISMARCK, Northwest Utah State. This lightning-caused fire is 15 miles south of Fairfield, UT. It is burning in grass, sagebrush, pinyon pine and juniper. The fire is backing toward Broad Canyon. Hot and dry conditions are impeding containment efforts.

GENTILE VALLEY, Upper Snake River District, Eastern Idaho Area, BLM. This fire is five miles south of Alexander, ID. The fire is burning in grass, sagebrush and scattered timber. Winds continue to cause rapid fire spread. Six homes are threatened.

MONUMENT CANYON, Sawtooth National Forest. This fire is 36 miles southeast of Burley, ID. The fire is wind-driven in grass, sagebrush, pinyon pine and juniper. The fire has grown toward the south, with hot, dry and windy weather continuing. Threats are to private lands and grazing.

SUPON, Upper Snake River District, Eastern Idaho Area, BLM. This fire is 20 miles north of Chesterfield, ID. It is burning actively in grass, sagebrush and scattered timber on state and private land. Critical wildlife habitat is threatened. Limited access, dry fuels and strong winds are causing control problems.

NAF, Upper Snake River District, Southcentral Idaho Area, BLM. This fire is a half mile west of Naf, ID. Crews are making progress toward containment. The south end of the fire is still active.

MONA WEST, Richfield Field Office, BLM. The fire is three miles west of Mona, UT. Running, crowning, spotting, and two major slopovers have occurred. A local radio station and a commercial poultry farm are threatened.

RATTLESNAKE, Arizona Strip District, BLM. The fire is burning in sagebrush, pinyon pine and juniper south of St. George, UT. Some torching on interior islands has been observed. Drops by single engine air tankers and helicopter buckets are supporting suppression efforts.

ELBOW, Arizona Strip Field Office, BLM. This fire is ten miles southeast of Mesquite, NV. Interior burning on the north and west sides continues. A helicopter with a bucket is working on the inaccessible portion of the fire.

POT CREEK, Vernal Field Office, BLM. This lightning-caused fire is near Vernal, UT. Little acreage gain was reported. The fire is in steep terrain.

FLATTOP, Upper Snake River District, Eastern Idaho Area, BLM. This lightning-caused fire is burning in grass and sagebrush near Aberdeen, ID. The fire intensity has decreased as the fire moves into an old burn area with lighter fuels.

TIN CUP, Upper Snake River District, Eastern Idaho Area, BLM. This fire is ten miles south of Butte City, ID near the INEEL facility. Wildlife habitat is threatened. No structures at the facility are currently threatened.

#### NORTHERN ROCKIES AREA LARGE FIRES:

A Type II Incident Management Team (Swope) is managing the Missoula staging area.

CANYON FERRY COMPLEX, Helena National Forest. A Type I Incident Management Team (Waterbury) and a Type II Incident Management Team (Hoff) are assigned. This complex, located 12 miles north of Helena, MT, consists of the Bucksnort Fire and the Cave Gulch Fire. The Magpie Creek drainage burned extensively, forcing crews to safety zones and out of the fire area. The status of structures in Magpie above Bar Gulch is unknown. Residents of York will tentatively return to their homes this morning.

FORT HOWES COMPLEX, Miles City Field Office, BLM. A Type II Incident Management Team (Colla) is assigned. This complex consists of the Stag Butte fire, Taylor Butte fire, and four others 25 miles south of Ashland, MT. The fire made a major run and some evacuations took place, but no structures were lost. The growth potential for this fire is very high.

COUGAR CREEK, Beaverhead-Deerlodge National Forest. A Type II Incident Management Team (Gauger) is assigned. The fire is 30 miles southwest of Philipsburg, MT. The fire grew rapidly yesterday to the east. Crowning was observed late into the evening and the fire is burning actively through the night.

CROOKED, Clearwater National Forest. A Type II Incident Management Team (Johnson) is assigned. The fire is burning in logging slash 50 miles southwest of Missoula, MT. The fire has spotted onto the ridge east of Rock Creek and is moving toward the Montana border. Threatened resources

include wildlife habitat, private timber land, historic trails and buildings near Lolo Pass.

TOBIN, Miles City Field Office, BLM. A Type II Incident Management Team (Cowin) is assigned. This fire is 26 miles northwest of Broadus, MT. The fire has demonstrated long range spotting and crowning behavior. The fire has growth potential due to low fuel moisture and shifting winds. Twenty structures were evacuated, but residents have been allowed to return to their homes.

UPPER MONTURE COMPLEX, Lolo National Forest. A Type II Incident Management Team (Doman) is assigned. This complex, formerly the Seeley Complex, is 34 miles northeast of Missoula. The Upper Monture fire made significant runs to the north and south which increased the fire size by 6,000 acres. The Spread fire was initial attacked near the Upper Monture Incident Command Post. Despite support of air tankers and helicopters, crews had to retreat to safety zones and the fire escaped initial attack.

DAILY, Miles City Field Office, BLM. This fire is five miles northwest of Ashland, MT. The fire is burning actively on all sides. Steep terrain and an inversion are causing problems. The fire is burning toward the north part of Custer National Forest.

POWDER RIVER COMPLEX, Miles City Field Office, BLM. This is a complex established by the Montana State Department of Natural Resources to cover fires in Custer, Rosebud and Powder River counties.

#### WESTERN GREAT BASIN AREA LARGE FIRES:

Priorities are being established by the Great Basin Multi-Agency Coordinating Group based on information submitted via Wildfire Situation Analysis reports and Incident Status Summary (ICS-209) forms.

SOUTH CRICKET, Elko Field Office, BLM. A Type II Incident Management Team (Burdick) is assigned. This fire is 15 miles northeast of Wells, NV. The fire is still exhibiting extreme resistance to control, making major runs to the northeast and south. A mobile home and four camp trailers have been destroyed. The fire jumped Highway 93 and threatened ranches. Other threats are to livestock, grazing land, endangered species, powerlines, the railroad and cultural sites.

COYOTE, Ely Field Office, BLM. A Type II Incident Management Team (Kearney) is assigned. This fire is burning in sagebrush, mahogany, conifer, pinyon pine and juniper 40 miles northeast of Pioche, NV. Strong winds and low relative humidity have resulted in extreme fire behavior and continued fire growth. Current threats are to livestock and critical wildlife habitat.

COTTONWOOD, Carson City Field Office, BLM. This fire is burning in pinyon pine and juniper 30 miles southeast of Lovelock, NV. Crews are making good progress constructing fireline. Acreage gain was minimal in the past 24 hours.

PHILLIPS RANCH, Humboldt-Toiyabe National Forest. This fire is burning in mixed conifer 50 miles southeast of Ely, NV. The fire continues to torch, crown and run on the northeast end. Threats are to an ancient bristlecone pine stand and historic mining resources.

#### ROCKY MOUNTAIN AREA LARGE FIRES:

MIDDLE ENOS, Worland District, BLM. A Type II Incident Management Team (Gardner) is assigned. The Enos and Middle Enos fires have combined under this name. The fires are burning in sagebrush and limber pine 20 miles south of Meeteetse, WY. Spotting, crowning and running fire behavior has been observed. Threatened resources include three oil wells and wildlife winter range.

SOUTH GRIZZLY, White River National Forest. A Type II Incident Management Team (Bustamante) is assigned. The fire is in a remote area 11 miles north of Glenwood Springs, CO. Crews are making good progress on fireline construction.

WARM SPRINGS, Worland District, BLM. This fire is burning in sagebrush and juniper fuels seven miles east of Thermopolis, WY. A nearby oilfield is threatened. Containment was expected late last night.

#### SOUTHERN CALIFORNIA AREA LARGE FIRES:

MANTER, Sequoia National Forest. A Type I Incident Management Team (Studebaker) is assigned. This fire is 15 miles northeast of Kernville, CA. The fire has made several large runs on all fronts. Youth camps and other facilities have been evacuated as a precaution. Structure protection plans have been implemented for the community of Kennedy Meadows.

PECHANGA, Riverside Ranger Unit, California Department of Forestry. The fire is five miles east of Temecula, CA. It started on the Pechanga Indian Reservation and has burned into the Agua Tibia Wilderness of the Cleveland National Forest. Residential areas and campgrounds are threatened.

PLASKETT 2, Los Padres National Forest. A Type I Incident Management Team (Gage) is assigned. This fire is 25 miles north of Cambria, CA east of Highway 1. Crews are completing a burnout operation on the north fork of Willow Creek. Mopup continues along Highway 1.

HAUSER, San Diego Ranger Unit, California Department of Forestry. The fire is burning in thick brushy fuels near Lake Morena in San Diego County. Threats are to watershed and Lake Morena Village. Mopup and patrol are continuing.

HAPPY, California Desert District, BLM. The fire is north of Trona, CA. This fire continues to burn in pinyon pine and juniper intermixed with desert shrub in extremely steep terrain. Helicopter bucket drops have been effective on the northeast flank.

#### SOUTHWEST AREA LARGE FIRES:

RIDGE, Fort Apache Agency. A Type II Incident Management Team (Leech) is assigned. This fire is four miles west of Carrizo, AZ. The fire's activity has declined, with most burning occurring in interior pockets. Crews are making good progress securing the west and north flanks. A

microwave tower, a major power line, a structure and timber resources are threatened.

HONEY WELL, Navajo Area Office, BIA. This fire is 25 miles northwest of Window Rock, AZ. Intense behavior caused the fire to spread rapidly. Evacuations of some residences are underway.

BLOODGOOD, Gila National Forest. These lightning-ignited wildland fires are being managed to accomplish resource objectives. A Fire Use Management Team (Adams) is assigned. The Bloodgood fire (2000 acres) and the Graves fire (200 acres) are both burning in the Gila Wilderness 30 miles north of Silver City, NM. These fires are low intensity ground fires which are burning in old fire scars.

MOGOLLON, Tonto National Forest. The fire was ignited by lightning on 7/22 ten miles northeast of Payson, AZ. No new information was reported. This will be the last report unless new information is received.

WALL, Albuquerque Field Office, BLM. The fire is burning in a remote portion of the El Malpais Wilderness 20 miles southwest of Grants, NM. The fire is being monitored by BLM personnel. The fire has received light rain.

A northward surge of mid- and high-level monsoon moisture may bring some dry thunderstorms to the Sierra Nevada, the Cascade Range, central and northeast Oregon, and the eastern slope of the Cascades in Washington and Oregon. There is a slight chance of dry thunderstorms in the higher elevations of Idaho and southcentral Montana. Isolated thunderstorms are expected in Wyoming and Utah. Scattered and wetter thunderstorms will occur in Colorado, New Mexico and Arizona. Skies will be mostly sunny in other parts of the western United States.

Temperatures will be hot, with highs in the 80's and 90's in the mountains and from 90 to the lower 100's in the valleys. Southern deserts will be 105 to 115 degrees. Minimum relative humidities will drop into the single digits at most lower elevations of the Great Basin. Humidities will be 10 to 20 percent in the mountain areas. Winds will generally be light, with some gusts up to 20 mph in the afternoon.

Southern California will be sunny and dry except for morning coastal fog. High temperatures will be 70 to 80 along the coast, and up to 115 in the desert areas. Minimum relative humidities will be as low as 10 percent. Afternoon winds will be south to southwest at 10 to 20 mph.
