

INCIDENT MANAGEMENT SITUATION REPORT  
TUESDAY, NOVEMBER 7, 2000 - 0730 MST  
NATIONAL PREPAREDNESS LEVEL II

CURRENT SITUATION:

One new large fire was reported in Tennessee. Crews met containment objectives on three Southern Area large fires, one each in Kentucky, Tennessee and North Carolina. Initial attack activity was moderate in the south. Higher relative humidity and a chance of precipitation may moderate fire behavior in Kentucky and Tennessee today. The National Interagency Coordination Center processed orders for infrared aircraft, radio equipment and overhead resources to the Southern Area. Very high to extreme fire indices were reported in North Carolina, Virginia and California.

SOUTHERN AREA LARGE FIRES:

HORSEHITCH/ROCKY TOP, Cherokee National Forest. A Type I Incident Management Team (Gage) has been ordered. These fires are about eight miles apart near Greeneville, TN. Flame lengths of 20 to 30 feet have been reported.

SHENANDOAH COMPLEX, Shenandoah National Park. A Type I Incident Management Team (Stutler) is assigned. This complex consists of the Pinnacles and the Old Rag fires, which are five miles southeast of Luray, VA. Fireline construction and burnout operations are continuing on the east flank of the fire.

BRUSHY RIDGE COMPLEX, National Forests in North Carolina. A Type I Incident Management Team (Melton) is assigned. The Brushy Ridge and Chimney fires are burning in the Linville Gorge Wilderness 20 miles north of Marion, NC. The acreage gain is due to burnout operations conducted to secure indirect firelines. Threatened resources include structures, scenic areas and commercial timber. Highway 1238 remains closed to public travel.

BIG SOUTH FORK COMPLEX, Big South Fork National Recreation Area. A Type I Incident Management Team (Studebaker) is assigned. The fires are 50 miles northwest of Knoxville, TN. The complex consists of the Schoolhouse, Camp and Darrow Ridge fires. Recent precipitation has moderated fire behavior. Crew activities include improvement and rehabilitation of firelines.

HONEY BEE COMPLEX, Daniel Boone National Forest. A Type II Incident Management Team (Kearney) is assigned. These fires are within a 15 mile radius of Whitley City, KY. Fires included in the complex are the Bicycle, Honey Bee, Maybe Later, Lot, Journey's End, Sanders Creek, Jackson Step-Up, River, Wally World, Big, Line, and several others less than 100 acres in size. Crews are progressing with mopup and rehabilitation efforts. The acreage increase reflects more accurate mapping.

SOUTHEAST DISTRICT COMPLEX, Kentucky State Division of Forestry. A Type I Incident Management Team (Frye) is assigned. These fires are burning in hardwoods intermixed with pine and brush in several counties surrounding Pineville, KY. Additional aviation and ground resources are allowing for

significant progress to be made in all divisions. The acreage increase is due to improved mapping.

JENNINGS BRANCH, George Washington and Jefferson National Forests. This fire is ten miles northwest of Staunton, VA. Volunteer fire department engines are assisting in the suppression effort.

TIPTON HILL, National Forests in North Carolina. This fire is northwest of Bakersville, NC. Crews are making progress toward containment. Rehabilitation operations are underway.

THOUSANDSTICKS, Daniel Boone National Forest. This fire, which started on 10/30, is two miles northeast of Hyden, KY. No new information was received.

#### OUTLOOK:

A cold front should bring a chance of rain and a slight chance of thunderstorms to central Kentucky, Tennessee and eastward. Behind the front there will be isolated showers in western Kentucky and Tennessee. High temperatures will be in the 60's. Winds behind the front will be southwest to west at five to 15 mph. Ahead of the front, winds are expected to be southeast to south at five to 10 mph. Minimum relative humidity will be 50 to 70 percent, with some drying in western areas by afternoon.
