

INCIDENT MANAGEMENT SITUATION REPORT
MONDAY, NOVEMBER 5, 2001- 0800 MST
NATIONAL PREPAREDNESS LEVEL 2

CURRENT SITUATION:

Initial attack activity was moderate in Southern Area and light elsewhere. Very high to extreme fire indices were reported in California, Georgia, North Carolina and Virginia.

EASTERN AREA SUPPORT:

DUANE STREET SUPPORT, Federal Emergency Management Agency. A Type 1 Incident Management Team (Stam) is assigned. The team is transitioning, with planning operations being turned over to the Fire Department of New York (FDNY) and logistical operations being turned over to the New York Office of Emergency Management (OEM).

SOUTHERN AREA LARGE FIRES:

REDBIRD FALL FIRES, Daniel Boone National Forest. A Type 2 Incident Management Team (Kearney) is assigned and is working under a unified command with Kentucky Division of Forestry. This complex of fires is located nine miles east of Manchester, KY. Crews continue to patrol and provide structure protection.

SOUTHERN DISTRICT COMPLEX, Kentucky Division of Forestry. A Type 2 Incident Management Team (Farson) is assigned. This complex of fires is located near Pikeville, Manchester and London, KY. Fire activity began on 10/19 and a complex was formed on 11/3. The Kentucky National Guard is assisting in containment efforts.

KENTUCKY RIVER COMPLEX, Kentucky Division of Forestry. A Type 2 Incident Management Team (Spicer) is assigned. This complex is located in nine counties surrounding Hazard, KY. The Kentucky National Guard is assisting in containment efforts. No other information was received.

EASTERN DISTRICT COMPLEX, Kentucky Division of Forestry. A Type 2 Incident Management Team (Conley) is assigned. This complex of fires is located in six counties surrounding Betsy Lane, KY. Significant progress has been made toward containment. The Kentucky National Guard is assisting in containment efforts.

OUTLOOK:

A dry cold front will move into the northern part of the southeast United States bringing cooler and drier air. Hurricane Michelle will move northeast toward the Bahamas with wind and rain diminishing over southern Florida, otherwise the area will be mostly sunny to partly cloudy. Temperatures will be in the 60's and mid 70's, except near 80 on the Gulf coast, with minimum relative humidity at 20 to 30 percent in the north and 30 to 40 percent in the south. Winds will be northwest to northeast at 10 to 15 mph, except 15 to 25 mph over Virginia, North Carolina and South Carolina.
