

INCIDENT MANAGEMENT SITUATION REPORT  
WEDNESDAY, NOVEMBER 7, 2001- 0800 MST  
NATIONAL PREPAREDNESS LEVEL 2

CURRENT SITUATION:

Initial attack activity was heavy in the Southern Area and light elsewhere. Very high to extreme fire indices were reported in California, Georgia, North Carolina, Virginia and West Virginia.

EASTERN AREA SUPPORT:

DUANE STREET SUPPORT, Federal Emergency Management Agency. A Type 1 Incident Management Team (Stam) is assigned. The team is transitioning, with planning operations being turned over to the Fire Department of New York (FDNY) and logistical operations being turned over to the New York Office of Emergency Management (OEM). The team is scheduled to demob on 11/8.

SOUTHERN AREA LARGE FIRES:

RIVER #1, Cherokee National Forest. This fire is one-half mile east of the Tellico Ranger Station, TN. The Tellico River Road has been closed. No other information was received.

REDBIRD FALL FIRES, Daniel Boone National Forest. A Type 2 Incident Management Team (Kearney) is assigned and is working under a unified command with the Kentucky Division of Forestry. This complex of fires is nine miles east of Manchester, KY. Two new fires were reported yesterday. Recon and suppression work continue on fires.

SOUTHEASTERN DISTRICT COMPLEX, Kentucky Division of Forestry. A Type 2 Incident Management Team (Farson) is assigned. This complex of fires is located near Pikeville, Manchester and London, KY. Fire activity began on 10/19 and a complex was formed on 11/3. Forty homes are threatened on the Moores Creek Fire in Knox County and are being protected by the Kentucky Division of Forestry crews and dozer units.

KENTUCKY RIVER COMPLEX, Kentucky Division of Forestry. A Type 2 Incident Management Team (Spicer) is assigned. This complex is located in nine counties surrounding Hazard, KY. The Kentucky National Guard is assisting in containment efforts. Three new fires were reported yesterday. Crews continue line construction, burnout and holding actions on uncontained fires.

EASTERN DISTRICT COMPLEX, Kentucky Division of Forestry. A Type 2 Incident Management Team (Conley) is assigned. This complex of fires is located in six counties surrounding Betsy Lane, KY. Helicopters are being used for hot spotting and for initial attack on new fires.

#### OUTLOOK:

A FIRE WEATHER WATCH IS POSTED FOR WESTERN NORTH CAROLINA, NORTHWEST SOUTH CAROLINA, NORTHEAST GEORGIA AND NORTHERN AND CENTRAL FLORIDA FOR LOW RELATIVE HUMIDITY.

A large high pressure will extend over most of the southeast and the area will be fair and dry. Temperatures will be in the upper 60s to the upper 70s, with minimum relative humidity at 10 to 25 percent in the east and 40 to 50 percent in the west. Winds will be variable to 10 mph in the east and southerly at 10 to 20 mph in the west.
