

**INCIDENT MANAGEMENT SITUATION REPORT
THURSDAY, MAY 16, 2002- 0530 MDT
NATIONAL PREPAREDNESS LEVEL 2**

CURRENT SITUATION:

Initial attack activity was moderate in Southwest Area and light elsewhere. Six new large fires were reported, three in Southwest Area and one each in Rocky Mountain, Southern and Eastern Areas. Three large fires were contained, one each in Southern, Southwest and Southern California Areas. Very high to extreme fire indices were reported in Arizona, California, Colorado, Nevada, New Mexico, Texas and Utah.

SOUTHWEST AREA LARGE FIRES:

INDIAN, Prescott National Forest. A Type 1 Incident Management Team (Bateman) will assume command of the fire at 0600 MST today. This fire, burning in ponderosa pine and brush, is five miles south of Prescott, AZ. Spotting, crowning and running were observed. Three communities have been evacuated and six homes were lost. A staging area for evacuees has been established at Prescott Mile High Middle School.

GUADALUPE, New Mexico State Forestry Office, Bernalillo District. This fire, burning on private land in ponderosa pine, juniper and pinon pine, is 30 miles north of Laguna Pueblo, NM. No further information was reported.

SPRINGER, Coconino National Forest. This fire is 20 miles northeast of Pine, AZ. Some torching was observed.

LOS LAMENTOS, New Mexico State Forestry Office, Socorro District. This fire is 40 miles east of Agua Prieta, Mexico and Douglas, AZ. Burning in grass, mesquite, oak and pinon pine, the fire is approaching the United States border. Under international agreement, United States firefighting forces are in place to assist Mexico in suppression efforts along the northern perimeter of the fire. The fire has burned 5000 acres in Mexico and was very active along the north, west and southwest flanks. Until the fire crosses the United States border, acreage and percentage contained will not be reported.

SOUTHERN AREA LARGE FIRES:

BLACKJACK BAY COMPLEX, Okefenokee National Wildlife Refuge. A Unified Command has been established between an interagency Fire Use Management Team (Zimmerman), the Georgia Forestry Commission and the Florida Division of Forestry. This lightning caused complex, consisting of the Blackjack 02, Bay Creek and Number One Island fires, is approximately ten miles northeast of Fargo, GA. Stephen Foster State Park is closed and structure protection measures are in place. Sustained runs and short range spotting were observed along the northern perimeter of the Blackjack 02 fire.

CLEMENTSVILLE COMMAND, Florida Division of Forestry. This fire is near Martin, FL. No new information was reported.

REC AREA COMMAND, Florida Division of Forestry. This fire is near the Miccosukee Indian Reservation. The fire is currently in monitor status. No new information was reported.

ROCKY MOUNTAIN AREA LARGE FIRES:

FURNISH, Colorado State Forest Service, Pueblo Dispatch Center Counties. This fire is in Furnish Canyon, 80 miles east of Trinidad, CO. The fire is burning in pinon pine, juniper, sage and grass in steep, isolated canyons and plateaus. Limited suppression tactics are planned due to difficult access, poor radio communications and low resource values.

OUTLOOK:

*****A FIRE WEATHER WATCH HAS BEEN POSTED IN THE GUADALUPE MOUNTAINS OF WEST TEXAS FOR GUSTY AFTERNOON WINDS, LOW RELATIVE HUMIDITY AND EXTREME FIRE DANGER*****

*****A FIRE WEATHER WATCH HAS BEEN POSTED IN THE FLORIDA PANHANDLE FOR MINIMUM RELATIVE HUMIDITY BELOW 35 PERCENT*****

Southwest Area can expect mostly sunny skies. A cold front over northeastern New Mexico and northwestern Texas will bring partly to mostly cloudy skies with a chance of scattered showers and thunderstorms. High temperatures will be in the 70's in the mountains and 90's across the lowlands. Minimum relative humidity will be 30 percent in the northern panhandle of Texas and 5 to 15 percent elsewhere. Winds will be west to southwest at 5 to 15 mph, and gusty in the fire weather watch area.

High pressure over southeastern Southern Area will bring partly sunny to partly cloudy skies with a chance of showers and thunderstorms in Florida. High temperatures will be in the 90's in Texas and central Florida, and in the 80's elsewhere. Minimum relative humidity will range from 25 to 40 percent. Winds will be southerly at 10 to 15 mph, gusting to 20 mph.

A weak upper level disturbance in conjunction with a cold front over Rocky Mountain Area will bring partly to mostly cloudy skies with scattered showers and thunderstorms. High temperatures will be in the 60's and low 70's in southern Colorado. Elsewhere, high temperatures will be 55 to 65 at lower elevations and 45 to 55 in the mountains. Minimum relative humidity will range from 25 to 35 percent and winds will be westerly at 15 to 25 mph.

A cold front moving southeast across Eastern Area will bring partly to mostly cloudy skies with showers, thunderstorms and heavy rain forecast along the leading edge of the front. Brisk north winds are expected behind the front but should decrease as the afternoon progresses. Ahead of the front, mild temperatures are expected with fairly strong southwest to south winds.

Southern California Area can expect mostly sunny skies. High temperatures will be in the 60's along the coast, 70's in the mountains, 70's to mid 80's inland, and 80's to 90's in the deserts. Minimum relative humidity will range from 10 to 20 percent in the deserts, 20 to 30 percent in the mountains and 30 to 40 percent inland. Winds will be south to west at 6 to 12 mph in the coastal

basins and southwest to northwest at 8 to 18 mph elsewhere.
