

**INCIDENT MANAGEMENT SITUATION REPORT  
MONDAY, MAY 20, 2002- 0530 MDT  
NATIONAL PREPAREDNESS LEVEL 2**

**CURRENT SITUATION:**

Initial attack activity was moderate in the Rocky Mountain and Southwest Areas and light elsewhere. Two new large fires were reported in the Southwest Area. Two large fires were contained, one each in the Northern California and Southwest Areas. Very high to extreme fire indices were reported in Arizona, Colorado, Nevada, New Mexico, Oklahoma, Texas and Utah.

**SOUTHWEST AREA LARGE FIRES:**

TRAM, Coconino National Forest. A Type 2 Incident Management Team (Waldrup) will assume command this morning. This fire is burning in pine and mixed conifer six miles west of Clints Well, AZ. No further information was received.

**SOUTHERN AREA LARGE FIRES:**

BLACKJACK BAY COMPLEX, Okefenokee National Wildlife Refuge. A transfer of command occurred from Zimmerman's Fire Use Management Team to Adams Fire Use Management Team. A Unified Command has been established between the interagency Fire Use Management Team (Adams), the Georgia Forestry Commission and the Florida Division of Forestry. This lightning caused complex, consisting of the Blackjack 02, Bay Creek and Number One Island fires, is ten miles northeast of Fargo, GA. Minimal fire activity was observed.

The Southwest Area can expect partly to mostly sunny skies with scattered, possibly dry, afternoon thunderstorms in central and eastern New Mexico. High temperatures will be in the 70's in the mountains and in the 90's in the southern deserts. Minimum relative humidity will range from 15 to 30 percent in eastern New Mexico and Texas, and 5 to 15 percent in Arizona. Winds will be southwest at 15 to 30 mph, gusting to 45 mph in the Red Flag and Fire Weather Watch areas.

High pressure over northern Florida and southern Georgia will bring a dry northeast flow to the Southern Area. High temperatures will be 70 to 80 and minimum relative humidity will range from 25 to 35 percent. Winds will be northeast at 10 to 20 mph.



## **INSTRUCTIONS AND ASSIGNMENTS NOT CLEAR**

Every firefighter will give and receive briefings at some point on the job. Briefings are an effective way to disseminate information that can make the firefighter s job safer and easier. When giving a briefing, it is important to keep the following questions in mind and remain perceptive to how the audience is receiving the information:

Did they ask questions? Talk about what it is like giving a briefing. Do you get empty stares? What feedback are you looking for to ensure they understand you?

Did they take notes? What kind of information would you like to see people write down?

Did they repeat information back? What other ways can you identify that your briefing is registering?

Did you give all the necessary information? How will you ensure that you covered everything necessary?

Task Location Communications Hazards Who, when, etc.

It is also important for the firefighter who is receiving instructions to be mindful of the following during the briefing:

- Did you really listen? What do you do to make yourself pay attention to everything being said?
- Did you understand the assignment, location, and the nature and location of hazards? Do you expect to figure it out for yourself when you get out there or do you step forward and ask questions?

To reduce the risks, take the time and get it right!

You must know the location of the assignment and:

- What is to be done.
- Who you are to report to and how often to report.
- When you are expected to complete the assignment.
- Hazards.
- Communication plan frequencies.
- Weather and fire behavior.
- Status of adjoining forces.
