

**INCIDENT MANAGEMENT SITUATION REPORT**  
**FRIDAY, MAY 31, 2002- 0530 MDT**  
**NATIONAL PREPAREDNESS LEVEL 2**

**CURRENT SITUATION:**

Initial attack activity was light across the nation. Three new large fires were reported, two in Southern Area and one in Southwest Area. Two large fires were contained, one each in Southern and Rocky Mountain Areas. Very high to extreme fire indices were reported in Alaska, Arizona, California, Colorado, Kansas, Minnesota, Nevada, New Mexico, Oklahoma, Texas and Utah.

**SOUTHWEST AREA LARGE FIRES:**

BULLOCK, Coronado National Forest. A Type 1 Incident Management Team (Humphrey) is assigned. This fire is 15 miles northeast of Tucson, AZ and is burning in grass, oak woodland and chaparral. Active fire behavior with some torching, up slope runs and spotting were observed. Burn out operations are under way from Mount Bigelow to the west.

BORREGO, Santa Fe National Forest. A Type 1 Incident Management Team (Bateman) is assigned. The fire is burning in pinyon pine, juniper and mixed conifer forest two miles southeast of Cordova, NM. Isolated torching of interior islands was observed. Crews are constructing and improving handline in the Pecos Wilderness Area. Burn out operations are under way in the Rio Quemado drainage and along the east flank.

WITCH, Arizona State Land Department, Tucson District. This fire is 27 miles southeast of Wilcox, AZ. The fire exhibited a rapid rate of spread in oak woodland, and some spotting was observed. No further information was received.

**ALASKA AREA LARGE FIRES:**

VINASALE, Alaska State Division of Forestry. A Type 2 Incident Management Team (Ketcher) will assume command of the fire today. Burning in black spruce, taiga and hardwoods, this fire is 15 miles south of McGrath, AK. Extreme fire behavior and significant running were observed as the fire moved north towards McGrath. Crews are building fireline along the west flank. A contingency line is staffed to protect McGrath and structure protection is in place for cabins and burial sites.

WEST FORK CHENA, Alaska State Division of Forestry. A Type 2 Incident Management Team (Jandt) is assigned. This fire is burning in black spruce 50 miles east of Fairbanks, AK. Cooler

temperatures and higher relative humidity have slowed the spread of the fire. Red Squirrel Campground and Angel Rocks Trail are closed. Thick smoke along Chena Hot Springs Road at Granite Tors has resulted in that road being closed.

MP 78 ELLIOTT HIGHWAY, Bureau of Land Management, Tanana Zone. A Type 2 Incident Management Team (Johnson) is assigned. This fire is burning seven miles southwest of Livengood, AK in black spruce, hardwoods, brush and litter. Strong southerly winds resulted in significant runs to the north and northwest. Elliott Highway is closed; cabin protection is in place.

BULL CREEK, Bureau of Land Management, Miles City Field Office. This fire is ten miles southwest of Birney, MT. Crews are constructing handline and mopping up.

#### **SOUTHERN AREA LARGE FIRES:**

BLACKJACK BAY COMPLEX, Okefenokee National Wildlife Refuge. A transfer of command from Adams Fire Use Management Team to Cooks Fire Use Management Team will occur today. A Unified Command between an interagency Fire Use Management Team, the Georgia Forestry Commission and the Florida Division of Forestry is in place. This lightning-caused complex, consisting of the Blackjack 02, Bay Creek and Number One Island fires, is ten miles northeast of Fargo, GA. Very active fire behavior was observed along the southwest flank. Tractor plows are disking a fire break along the southern perimeter.

CHALK CANYON, Texas State Forest Service. This fire, burning in heavy timber and brush, is ten miles southwest of Marathon, TX. No further information was reported.

### OUTLOOK:

High pressure over Southwest Area will bring sunny skies to Arizona and western New Mexico. A low level easterly flow will bring isolated dry thunderstorms to the mountains of New Mexico. High temperatures will be in the 70's to near 90 in the mountains and in the 90's to near 110 at lower elevations. Minimum relative humidity will range from 5 to 10 percent in Arizona and western New Mexico, and 10 to 30 percent elsewhere. Winds will be southeast to southwest at 10 to 15 mph.

Alaska Area can expect scattered afternoon thunderstorms over the eastern interior. High temperatures will be in the upper 50's and 60's. Minimum relative humidity will be in the upper 20 and 30 percent range in the central interior, and higher south of the Alaska Range and in the west. Winds will be southwest to 10 mph.

A high pressure system over Rocky Mountain Area will bring sunny skies with a chance of afternoon showers and isolated dry thunderstorms to the mountains of Colorado. High temperatures in Colorado will be 90 to 95 at lower elevations, and mid 60's to upper 70's in the mountains. Minimum relative humidity in Colorado will range from 7 to 16 percent over lower elevations, and 10 to 20 percent in the mountains. Winds will be variable at 5 to 15 mph.

Low pressure off the Atlantic Coast will bring afternoon showers and thunderstorms to the eastern portion of Southern Area. High temperatures will be in the 90's in southwest Texas, central Oklahoma and southern Florida, and in the 80's elsewhere. Minimum relative humidity will range from 45 to 55 percent. Winds will be light and variable at 5 to 10 mph.
