

**INCIDENT MANAGEMENT SITUATION REPORT  
THURSDAY, SEPTEMBER 05, 2002 0530 MDT  
NATIONAL PREPAREDNESS LEVEL 4**

**CURRENT SITUATION:**

Initial attack activity was moderate in the Southern California and Northern Rockies Areas and light elsewhere. Nationally, 172 new fires were reported. No new large fires were reported. Two large fires were contained, one each in the Southern California and Northwest Areas. Very high to extreme fire indices were reported in Arizona, California, Colorado, Idaho, Kansas, Montana, Nebraska, Nevada, North Dakota, Oregon, South Dakota, Utah, Washington and Wyoming.

**SOUTHERN CALIFORNIA AREA LARGE FIRES:**

CURVE, Angeles National Forest. A Type 1 Incident Management Team (Studebaker) is assigned. This fire is 30 miles north of Asuza, CA and is burning in mixed conifer forest and heavy brush. Active fire behavior was observed due to thunder cells over the fire. Crews are constructing direct attack fireline and burning out. Steep, rugged terrain and limited access are impeding suppression efforts. Fifty eight outbuildings and special use cabins were confirmed lost with another 200 threatened.

LEONA, Angeles National Forest. A Unified Command has been established between the Angeles National Forest (Hutchison) and the Los Angeles County Fire Department (Ryland). This fire is 12 miles west of Palmdale, CA. Extreme fire behavior with rapid rates of spread was observed in grass and brush. Crews and engines are constructing fireline with assistance from aerial resources. Evacuations remain in effect for parts of the Lost Valley and Leona Valley communities. Two residences and 12 outbuildings were confirmed lost.

## **NORTHWEST AREA LARGE FIRES:**

A Unified Command between an Area Command Team (Williams-Rhodes) and the Oregon Department of Forestry (Spiesschaert) is in place to manage the Biscuit fire.

BISCUIT, Siskiyou and Six Rivers National Forests. A Unified Command between a Type 1 Incident Management Team (Dash) and the Oregon Department of Forestry is in place on the west perimeter. The northwest portion of the fire is managed by a Washington Interagency Incident Management Team (Furlong/Gormley), and a Type 2 Incident Management Team (Morcom) is in place on the east perimeter. The fire is 26 miles southwest of Grants Pass, OR. Favorable weather conditions aided containment objectives and minimized fire behavior. Crews are constructing direct attack fireline on the west flank with mop-up and fireline rehabilitation underway in all other areas. Pre-evacuation advisories for Upper Gardner Ridge and Wilderness Retreat were retracted; the pre-evacuation notice for Pistol River remains in effect.

OFFICE BRIDGE, Willamette National Forest. A Type 2 Incident Management Team (Gardner) is assigned. This fire is burning one half mile north of Westfir, OR. Short runs with torching, smouldering and creeping were observed in brush and timber. Crews are constructing fireline on the northeast flank and mopping up the rest of the perimeter. A three hour evacuation notice remains in place for residents of Westfir and Hemlock.

APPLE, Umpqua National Forest. A Type 1 Incident Management Team (Lohrey) is assigned. The Team is also managing the Tiller Complex. This fire is 21 miles east of Glide, OR. Favorable weather conditions moderated fire behavior in heavy timber. Crews are burning out and mopping up. Twenty residences and ten outbuildings remain threatened.

## **ROCKY MOUNTAIN AREA LARGE FIRES:**

COMMISSARY RIDGE, Rock Springs District, Bureau of Land Management. A Type 2 Incident Management Team (Sandman) is assigned. This fire is 20 miles north of Kemmerer, WY. Short crown runs and group tree torching were observed with spotting up to one half mile ahead of the front in mixed conifer forest, sagebrush and grass. Crews, engines and dozers are constructing fireline and providing structure protection. The Spring Creek Ranch and Commissary Ranch subdivisions, summer homes and cabins have been evacuated; local road closures are in effect. One summer home and one outbuilding are confirmed lost.

MT. ZIRKEL COMPLEX, Routt National Forest. A Type 1 Incident Management Team (Bennett) is assigned. This complex, comprised of the Burn Ridge and Hinman fires, is 25 miles north of Steamboat Springs, CO. Isolated torching, creeping and smouldering were observed in heavy dead and down spruce, lodgepole pine and fir. Crews are constructing fireline using Minimum Impact Suppression Techniques (MIST) in the Mt. Zirkel Wilderness Area.

BIG FISH, White River National Forest. A Fire Use Management Team (Cook) is assigned. The Team is also managing the Lost Lakes fire. This lightning-caused Wildland Fire Use Incident, which started on July 19<sup>th</sup>, is 34 miles southwest of Steamboat Springs, CO. The fire is being managed for resource benefit and a confinement strategy is in place. Windy conditions resulted in a run on the northwest flank where active crowning and spotting were observed in heavy dead and down spruce, fir and aspen in the Paradise and Big Fish drainages. Structure protection is in place for several guest ranches.

LOST LAKES, Routt National Forest. A Fire Use Management Team (Cook) is assigned. This lightning-caused Wildland Fire Use Incident, which started on July 8<sup>th</sup>, is 20 miles west of Yampa, CO. The fire is in monitor status and is being managed for resource benefit. Torching, short range spotting and short runs were observed in bug kill spruce and fir near Pyramid Peak.

#### NORTHERN ROCKIES AREA LARGE FIRES:

KRAFT SPRING, Custer National Forest. A Type 2 Incident Management Team (Swope) is assigned. This fire is 30 miles southeast of Ekalaka, MT. Short range spotting was observed in grass and heavy dead and down fuels. Crews and engines are improving established fireline on the north, west and east flanks; structure protection is in place. Steep, inaccessible terrain and strong, shifting winds are impeding suppression efforts.

#### NORTHERN CALIFORNIA AREA LARGE FIRES:

SQUIRREL, Shasta-Trinity Unit, California Department of Forestry and Fire Protection (CDF). A CDF Type 1 Incident Management Team (Durden) is assigned. This fire is east of Whitmore, CA and is burning in brush and timber. Minimal fire behavior was observed. Personnel are patrolling and mopping up. Fifty residences and 20 outbuildings are threatened.

### EASTERN GREAT BASIN AREA LARGE FIRES:

JOHNSON, Fishlake National Forest. This fire is 23 miles southeast of Richfield, UT. Active fire behavior was observed in spruce, fir and aspen. Crews are constructing fireline, hot-spotting and mopping up. Structure protection is in place for several residences, cabins and recreational trailers. Reduction in acreage is due to more accurate mapping.

PINTO RIDGE, Wasatch-Cache National Forest. This lightning-caused Wildland Fire Use Incident, which started on August 8<sup>th</sup>, is burning in subalpine fir with single tree torching observed.

### SOUTHWEST AREA LARGE FIRES:

GOAT, Cimarron District, New Mexico State Forestry. This fire is 15 miles south of Cimarron, NM and is burning in pinyon pine, juniper and oak. Gusting winds resulted in intermittent torching in the interior and creeping. Dozers are constructing fireline on the south flank and engine crews are burning out. Rocky terrain and limited access are impeding suppression efforts.

JONES ROAD, Texas State Forest Service. This fire is 58 miles northeast of Abilene, TX. Very active fire behavior was observed in heavy oak, cedar and mesquite.

## OUTLOOK:

**\*\*\*A RED FLAG WARNING HAS BEEN POSTED IN NORTHEAST WYOMING AND THE BLACK HILLS FOR BREEZY, HOT, DRY AND UNSTABLE CONDITIONS\*\*\***

An upper level low over the Northwest Area will bring partly cloudy skies with isolated showers and wet thunderstorms. High temperatures will be in the 60's to 80's and minimum relative humidity will range from 25 to 35 percent east of the Cascade Mountains and 35 to 65 percent to the west. Winds will be southwest to west at 15 to 25 mph in eastern Oregon.

The Rocky Mountain Area will have partly sunny skies with isolated thunderstorms. High temperatures will be in the upper 60's to 80's in the mountains and mid 80's to lower 90's at lower elevations. Minimum relative humidity will range from 10 to 25 percent. Winds will be from the southwest at 10 to 15 mph with gusts to 50 mph possible near thunderstorms.

The Northern California Area can expect mostly sunny skies with high temperatures in the 60's at the coast and lower 70's to mid 80's inland. Minimum relative humidity will range from 18 to 28 percent. Winds will be south to southwest at 15 to 25 mph.

A southwest flow over the Northern Rockies Area will bring mostly cloudy skies with scattered thunderstorms. High temperatures will be from 85 to 95 in east and 70 to 80 elsewhere. Minimum relative humidity will be range from 50 to 60 percent in North Dakota and 15 to 25 percent in the remainder of the area. In the north, winds will be north at 5 to 15 mph and southwest at 5 to 15 mph elsewhere.

Tropical moisture moving across the Eastern Great Basin Area will bring scattered showers and thunderstorms. High temperatures will be from 65 to 80 in the north and 85 to 101 in the south. Minimum relative humidity will range from 8 to 20 percent in the south and 20 to 40 percent in the north. Winds will be from the southwest at 15 to 30 mph.

The Southwest Area can expect mostly sunny skies with widely scattered thunderstorms. High temperatures will be in the 70's to 80's in the mountains and in the 90's to near 110 at lower elevations. Minimum relative humidity will range from 8 to 20 percent in northwest New Mexico and Arizona and 20 to 40 percent elsewhere. Winds will be south to southwest at 10 to 15 mph with gusts to 25 mph in west Texas.
