

**INCIDENT MANAGEMENT SITUATION REPORT**  
**THURSDAY, OCTOBER 23, 2003 0530 MDT**  
**NATIONAL PREPAREDNESS LEVEL 2**

**CURRENT SITUATION:**

Initial attack activity was light nationwide. Nationally 112 new fires were reported. Five new large fires were reported, one each in the Rocky Mountain, Southern and Southern California Areas and two in the Eastern Great Basin Area. Very high to extreme fire indices were reported in Arizona, California, Colorado, Idaho, Oregon, North Dakota, Utah and Wyoming.

**SOUTHERN CALIFORNIA AREA LARGE FIRES:**

ROBLAR 2, Camp Pendleton Marine Corps Base. A Type 2 Incident Management Team (Domanski) is assigned. This fire is in six foot tall chaparral, six miles west of Fallbrook, CA. Significant spread occurred along the southwest and northeast flanks during periods of extreme fire behavior.

GRAND PRIX, San Bernardino Unit, California Department of Forestry & Fire Protection (CDF). A Type 2 Incident Management Team (Dietrich) is assigned. This fire is in heavy chaparral, two miles west of Mira Loma, CA. Extreme fire behavior with torching and spotting was observed within the perimeter.

PASS, Riverside Unit, California Department of Forestry & Fire Protection (CDF). This fire is in chaparral and grass, three miles northwest of Moreno Valley, CA. Rapid rates of spread and uphill runs were observed. Evacuations were in progress in the Pigeon Pass area.

PARADISE 2, Sequoia & Kings Canyon National Park. This wildland fire, previously reported as part of the Kaweah-Kern Complex, is in mixed conifer and chaparral, seven miles northeast of Three Rivers, CA. Fire activity and spread on the north and east flanks continue. Spotting from roll-out along ridge tops and in drainages was reported.

ALBANITA/HOOKER, Sequoia National Forest. This Wildland Fire Use (WFU) incident is burning in mixed conifer and chaparral ten miles north-northwest of Kennedy Meadows, CA. Backing fire with occasional short runs and small group torching was reported. This will be the last narrative unless significant activity occurs.

### **EASTERN GREAT BASIN AREA LARGE FIRES:**

HILL CITY BLUES 2, Southern Idaho Dispatch, Private, County and Local. This fire is in small stands of aspen, fir and brush, 20 miles east of Fairfield, ID. Wind-driven fire activity was reported.

BEE, Upper Snake River District, Eastern Idaho Area, Bureau of Land Management. This fire is in grass and brush, 15 miles northwest of Soda Springs, ID. Moderate to extreme fire behavior was observed.

### **ROCKY MOUNTAIN AREA LARGE FIRES:**

TWENTY FOUR, Standing Rock Reservation, Bureau of Indian Affairs. This fire is in tall grass and sage brush, six miles southwest of Fort Yates, ND. Multiple blow-ups throughout the day were observed.

TABOR FIRE, Texas Forest Service. This fire is in tall grass and a pine plantation, 30 miles north/northeast of Longview, TX. Rough terrain with ravines and gullies hampered suppression efforts.

## OUTLOOK:

**Fire Weather Watches:** For low humidity and windy conditions beginning tonight through Saturday for southern Humboldt County, the greater Bay Area, the Sacramento Valley and surrounding foothills and slopes.

**Weather Discussion:** A strong cold front will move through the Northern Rockies and northern half of the Great Basin. Offshore flow will develop in the wake of the frontal passage over northern California. Elsewhere, an upper trough moving off the East coast will bring a dry northwest flow to much of the central and southern states. Some precipitation will be noted over the Great Lakes and Northeast.
