

INCIDENT MANAGEMENT SITUATION REPORT
TUESDAY OCTOBER 12, 2004 0530 MDT
NATIONAL PREPAREDNESS LEVEL 2

CURRENT SITUATION:

Initial attack activity was light nationally with 91 new fires reported. One new large fire was reported in the Northern California Area. Very high to extreme fire indices were reported in California, Nebraska and Nevada.

SOUTHERN AREA INCIDENTS:

HURRICANE FRANCES / IVAN RESPONSE, Federal Emergency Management Agency (FEMA). A Type 2 Incident Management Team (Muir) is assigned. The Team is managing a base camp at Saufley Field Naval Air Station in Pensacola, FL.

NORTHERN CALIFORNIA AREA LARGE FIRES:

RUMSEY, California Department of Forestry & Fire Protection (CDF), Sonoma-Lake Napa Unit. A CDF Type 1 Incident Management Team (Streblow) is assigned. This fire is 18 miles south of Williams, CA in brush. Poor accessibility and strong winds have hampered suppression efforts. Wind-driven fire behavior resulted in significant acreage growth.

POWER, Eldorado National Forest. A transfer of command from a Type 2 Incident Management Team (Wendt) to a Type 3 organization will occur today. This fire is 28 miles southeast of Pollock Pines, CA in brush and timber. Minimal fire behavior in the interior with no significant spread was reported.

OUTLOOK:

Red Flag Warning: For Eureka, Sacramento, and Monterey areas through midday Tuesday for moderate or stronger northeast to east winds, low relative humidity levels, and generally poor relative humidity recovery for mid-slope and above.

Weather Discussion: High pressure continues over the Pacific Northwest with an upper low centered over southern California. Gusty winds, warm temperatures and low humidity will persist over northern California.

NO COMMUNICATION LINK WITH CREW MEMBERS, SUPERVISORS & ADJOINING FORCES

Watchout Situation #7 is a danger that must be mitigated by maintaining good communications while working on fires. Firefighters must constantly ask themselves the following questions as situations change on the fireline:

- Can communications be established?
 - Talk about how communications are set up on fires.
 - Review situations where communications were a problem and what was done to fix the problem.
- Is the communication triangle complete?.
 - Review the communication triangle and where it comes up in the "10 Standard Fire Orders" and the "18 Watchout Situations."
 - Discuss ways that firefighters can maintain the communication triangle on the fireline.
- Reduce the risks
 - If the situation is complex, wait until communications are in place.
 - Talk about the fires where crews had to leave the line, didn't go out on the line, or something negative happened because communications were inadequate. Discuss what was done to establish communications.
