Derby, Gallatin NF. IMT 1 (Bennett). Includes Jungle fire. IMT 2 (McNitt) managing Jungle. Fifteen miles south of Big Timber, MT. Timber, grass and heavy dead and down fuels. Group tree torching, sustained runs and spotting. Structures threatened. Evacuation orders and area closures in effect.

Paradise Valley Complex (four fires), Gallatin NF. IMT 2 (Kusicko). Twenty-nine miles southwest of Livingston, MT. Timber. Torching and short runs. Watershed threatened. Structure protection in place.

Hughes 32 Complex (four fires), Idaho Panhandle NF. Sixteen miles northwest of Nordman, ID. Cedar, hemlock and subalpine fir. Group tree torching and spotting. Fire lookout and Canadian power lines threatened.

Meadow, Nez Perce NF. IMT 2 (Turman) ordered. Fifteen miles southeast of Elk City, ID. Timber. Extreme fire behavior. Structures and lookout threatened.

Heavens Gate Complex (four fires), Nez Perce NF. Transfer of command from IMT 1 (Stanich) to IMT 2 (Grant) on 9/5. Ten miles west of Riggins, ID. Grass and timber. Single and group tree torching, spotting and sustained runs. Structure protection in place for a ranch.

Sun Dog, Flathead NF. IMT 2 (Heintz). Eighteen miles north of Whitefish, MT. Timber. Minimal fire activity. Watershed threatened.

Ulm Peak, Idaho Panhandle NF. IMT 2 (Reid). Transfer of command back to local unit today. Twelve miles southwest of Noxon, MT. Subalpine fir, hemlock and brush. Ground fire, single and group tree torching, runs and spotting. Structure and repeater threatened.

Holland Peak, Flathead NF. Five miles east of Condon, MT. Timber. Backing fire and torching.

Ashley Lake, Flathead Agency BIA. Six miles northeast of St. Ignatius, MT. Alpine timber. Single tree torching, creeping and smoldering. Monitor status.

Clarks Canyon, Central Land Office, Montana DNR. Seventeen miles south of Dillon, MT. Grass, timber and sagebrush. No further information received.

Stinky, Yellowstone NP. Thirty-seven miles southeast of Gardiner, MT. Lodgepole pine. Confine/contain. No further information received.

Columbia Complex (six fires), Southeast, Washington DNR. IMT 1 (Lohrey). Fifteen miles northeast of Walla Walla, WA. Grass, brush and mixed conifer. Backing fire, small uphill runs and torching. Residences, a ski area, wind energy site and commercial resources threatened. Evacuation orders and area road closures in effect.

Shake Table Complex (ten fires), Malheur NF. IMT 2 (Hunt). Twelve miles southeast of Dayville, OR. Timber. Isolated torching and short range spotting. Residences, lookout and communication site threatened. Road closures in effect.

Tripod Complex (two fires), Okanogan-Wenatchee NF. IMT 1 (Whitney) and IMT 2 (Gormley). IMT 1 also managing Cedar Creek and Tatoosh Complex. Seven miles northeast of Winthrop, WA. Mixed conifer. Spotting, torching and short crown runs. Numerous residences and other structures threatened.

Middle Fork, Cascade District, Oregon Department of Forestry. IMT 2 (Walker). Fourteen miles northeast of Sweet Home, OR. Timber. Torching, short range spotting and short crown runs. Recreation facilities threatened.

Cascade Crest Complex (three fires), Deschutes NF. IMT 1 (Wilcock). Thirty-five miles northeast of Bend, OR. Timber and heavy dead and down fuels. Occasional single tree torching. Residences, communication sites, fish hatchery and other structures threatened. Recreation sites closed.

Flick Creek, North Cascades NP. FUMT (Weldon). FUMT also managing Tin Pan WFU. One mile east of Stehekin, WA. Lodgepole pine, Douglas fir and spruce. Backing fire with single tree torching. Structures threatened.

Tin Pan WFU, Okanogan-Wenatchee NF. Seven miles west of Lucerne, WA. Timber. Sustained crown runs. Structures threatened.

Quinns Meadow, Northeast, Washington DNR. IMT 2 (Barnett). Twenty-five miles north of Colville, WA. Timber and brush. Smoldering and creeping. Residences threatened. No further information received.

Baker Canyon, Prineville District BLM. Twelve miles north of Madras, OR. Grass. Running, spotting and torching. Structures and historic railroad line threatened.

Dewatto II, South Puget Sound, Washington DNR. IMT 2 (Jennings) will assume command today. Twenty-three miles southwest of Belfair, WA. Timber and heavy dead and down fuels. Torching, spotting and crowning.

Cedar Creek, Okanogan-Wenatchee NF. Eight miles southwest of Mazama, WA. Timber. Isolated torching. Structure protection in place.

Tatoosh Complex (six fires), Okanogan-Wenatchee NF. Twenty-four miles northwest of Mazama, WA. Timber. Crowning and spotting. Structure protection in place.

Mt. Hood Complex (thirteen fires), Mt. Hood NF. Six miles east of Government Camp, OR. Timber and heavy dead and down fuels. Running, spotting and group tree torching. Trails and roads closed.

Jackies Butte, Vale District BLM. Twenty-five miles southeast of Burns Junction, OR. Grass. Wind driven runs.

Rockland, Idaho Falls District, BLM. IMT 2 (Whalen). Five miles east of Rockland, ID. Timber, brush, grass and light slash. Short runs and torching. Residences, cultural sites and power lines threatened.

Deep Creek, Manti-Lasal NF. Five miles south of Levan, UT. Pinyon pine, juniper and brush. Backing fire with short runs. Communications site and power lines threatened.

Green Canyon, Eastern Idaho Area Office Idaho Department of Lands. Six miles southwest of Rockland, ID. Timber. Extreme fire behavior. Structures threatened.

Cull, Arizona Strip Field Office, BLM. Fifteen miles southeast of Mesquite, NV. Grass, brush, pinyon pine and juniper. Smoldering and creeping.

Rattlesnake Complex (two fires), Boise NF. IMT 2 (Saleen). IMT 1 (Muir) ordered. Thirteen miles northeast of Garden Valley, ID. Subalpine fir and pine. Backing fire. Residences, commercial property and campgrounds threatened. Area closures remain in effect.

Red Mountain, Boise NF. IMT 1 (Martin). IMT also managing the Boundary Complex and Trailhead fire. Sixteen miles northeast of Lowman, ID. Subalpine fir and lodgepole pine. Single tree and group torching, and crown runs. Campgrounds, Forest Service guard station and fisheries habitat threatened. Campground closed.

Middle Fork Complex (eight fires), Salmon-Challis NF. FUMT (Perkins). Thirty miles west of Challis, ID. Timber and grass. Isolated tree torching, spotting and running. Residences, ranches and fisheries threatened.

Brown's Canyon, Sawtooth NF. IMT 2 (Suwyn). Five miles southeast of Yost, UT. Pinyon pine, juniper, grass and sagebrush. Surface fire with single tree and group torching.

South Fork Complex (26 fires), Payette NF. IMT 2 (Philbin). Thirteen miles east of McCall, ID. Timber. Moderate fire activity. Town of Yellow Pine, Krassel Work Center, lookouts, power lines and campgrounds threatened. Structure protection in place. Road closures in effect.

Trailhead, Sawtooth NF. Ten miles southwest of Stanley, ID. Lodgepole pine and Douglas fir. Minimal fire activity. Patrol by air.

Battle Mountain, Bridger-Teton NF. Thirty miles northeast of Pinedale, WY. Timber. No further information.

Trout Creek, Payette NF. Fifty miles northeast of McCall, ID. Timber and grass. Minimal fire behavior. No further information.

Payette WFU Complex (thirteen fires), Payette NF. FUMT (Hall). FUMT also managing Trout Creek. Twenty miles northeast of McCall, ID. Timber. Backing fire with isolated torching. No further information.

Dry thunderstorms are possible in the Northwest, northern Great Basin, and western Montana through Wednesday. Wetter storms will develop over the southern Great Basin, Southwest, and southern California. A warming and drying trend will continue over much of the West through mid-week. Dry and unstable conditions (high Haines Index) will exist from eastern portions of Washington and Oregon into western Montana the next couple days.

OPERATIONAL BRIEFINGS

Operational briefings are critical to safe fire operations. To ensure a consistent and effective briefing, a standardized briefing checklist should always be used. The following checklist is printed on the cover of the NWCG Incident Response Pocket Guide:

Situation:

- Fire name, location, map orientation, other incidents in the area
- Terrain influences
- Fuel type and conditions
- Fire weather (previous, current, and expected)
- Fire behavior (previous, current, and expected)

Mission/Execution:

- Command (Incident Commander/immediate supervisor)
- Commander's intent
- Specific tactical assignments
- Contingency plans

Communications:

- Communication Plan (tactical, command, air/ground frequencies, cell phone numbers, etc.)
- Medivac Plan

Service/Support:

- Other resources that may be working adjacent to you and those available to order
- Aviation operations
- Logistics (e.g., transportation, supplies, equipment)

Risk Management:

- Identify known hazards and risks
- Identify control measures to eliminate hazards and reduce risk
- Identify trigger points for disengagement or reevaluation of operational plan
