Columbia Complex (six fires), Southeast, Washington DNR. IMT 1 (Lohrey). Fifteen miles northeast of Walla Walla, WA. Grass, brush and mixed conifer. Active fire behavior with single tree and group torching. Residences, a ski area, wind energy site and commercial resources threatened. Evacuation orders and area road closures in effect.

Twin Lakes Complex (two fires), Wallowa-Whitman NF. IMT 2 (Lunde). Twenty-one miles southeast of Joseph, OR. Timber. Torching, spotting and crown runs. Community of Cornucopia, OR evacuated. Mine sites and fisheries habitat threatened.

Tripod Complex (two fires), Okanogan-Wenatchee NF. IMT 1 (Anderson). IMT also managing Cedar Creek, Tatoosh Complex and Van Peak fires. Seven miles northeast of Winthrop, WA. Mixed conifer. Torching, spotting, crowning and backing fire. Residences and other structures threatened.

Pollalie, Okanogan-Wenatchee NF. IMT 2 (Reed). Fifteen miles northwest of Cle Elum, WA. Subalpine fir, lodgepole pine and brush. Torching, running and spotting fire behavior. Residences, Forest Service structures and campgrounds threatened.

Cascade Crest Complex (three fires), Deschutes NF. IMT 1 (Wilcock). Forty-two miles northwest of Bend, OR. Timber and heavy dead and down fuels. Torching and creeping. Fish hatchery and structures threatened.

Middle Fork, Cascade District, Oregon Department of Forestry. ODF IMT (Walker). Started on private land 14 miles northeast of Sweet Home, OR. Timber. Creeping and smoldering.

7440, South Puget Sound, Washington DNR. IMT 2 (LaFave). Started on Forest Service land 30 miles east of Enumclaw, WA. Timber and slash. Active fire behavior. Communications site threatened. Road closure in effect.

Flick Creek, North Cascades NP. Transfer of command from FUMT (Weldon) to FUMT (Furlong) tomorrow. FUMT also managing Tinpan WFU. One mile east of Stehekin, WA. Lodgepole pine, Douglas fir and spruce. Backing fire, torching and short crown runs. Structures and commercial property threatened.

Shake Table Complex (fifteen fires), Malheur NF. IMT 2 (West). Nine miles southeast of Dayville, OR. Timber. Creeping, smoldering and isolated torching. Residences, lookout and communication site threatened. Road closures in effect.

Jungle Butte Complex (three fires), Yakama Agency, BIA. IMT 2 (Barnett). Nine miles northeast of Glenwood, WA. Timber. Torching, spotting and running fire behavior.

Tinpan, Okanogan-Wenatchee NF. Seven miles west of Lucerne, WA. Timber. Backing fire and short crown runs.

Dewatto II, South Puget Sound, Washington DNR. IMT 2 (Jennings). Twenty-three miles northwest of Belfair, WA. Timber and heavy dead and down fuels. Smoldering and creeping.

Elkhorn Complex (three fires), Wallowa-Whitman NF. IMT 2 (Goheen). Sixteen miles northwest of Baker City, OR. Timber. Running, spotting and group tree torching. Residences, commercial resources and the Anthony Lakes ski area threatened.

Lookout Mountain Complex (four fires), Vale District, BLM. Includes previously reported Lime, Huntington and Iron Mountain fires. Seven miles northeast of Weatherby, OR. Brush and slash. Uphill runs, spotting and torching. Recreation sites threatened.

Cedar Creek, Okanogan-Wenatchee NF. Eight miles southwest of Mazama, WA. Timber. Isolated group tree torching. Structures and commercial property threatened.

Mt. Hood Complex (thirteen fires), Mt. Hood NF. Six miles east of Government Camp, OR. Timber and heavy dead and down fuels. Creeping and smoldering.

Tatoosh Complex (six fires), Okanogan-Wenatchee NF. Twenty-four miles northwest of Mazama, WA. Timber. Extreme fire behavior with crowning and spotting.

Van Peak, Okanogan-Wenatchee NF. Thirty-one miles north of Winthrop, WA. Timber and heavy down fuel. Active fire behavior.

Derby, Gallatin NF. IMT 1 (Bennett). Fifteen miles south of Big Timber, MT. Timber, grass and heavy dead and down fuels. Torching, creeping, backing fire and sustained runs. Structures and mine threatened. Evacuation orders and area closures in effect.

Jungle, Gallatin NF. FUMT (Svalberg). Twenty miles southeast of Livingston, MT. Timber. Fire is a branch of Derby. Torching, creeping and backing fire. Ranches and Forest Service structures threatened.

Paradise Valley Complex (three fires), Gallatin NF. IMT 2 (Kusicko). Twenty-nine miles southwest of Livingston, MT. Timber. Torching and short runs. Structures and watershed threatened. Structure protection in place.

Meadow, Nez Perce NF. IMT 2 (Turman). Fifteen miles southeast of Elk City, ID. Timber. Uphill runs and isolated torching. Residences and other structures threatened. Area road closures in effect.

Hughes 32 Complex (two fires), Idaho Panhandle NF. Sixteen miles northwest of Nordman, ID. Cedar, hemlock and subalpine fir. Active fire behavior. A fire lookout and Canadian power lines threatened. Area trails closed.

Ashley Lake, Flathead Agency BIA. Six miles northeast of St. Ignatius, MT. Timber. Backing fire and short runs.

Heaven's Gate Complex (four fires), Nez Perce NF. IMT 2 (Grant). Ten miles west of Riggins, ID. Grass and timber. Active fire behavior. Structures threatened. Numerous roads closed.

Holland Peak, Flathead NF. Five miles east of Condon, MT. Timber. Backing fire, torching and spotting. Residences threatened. Voluntary evacuated in effect.

Sun Dog, Flathead NF. Eighteen miles north of Whitefish, MT. Timber. Crown fire. Watershed threatened.

Ulm Peak, Idaho Panhandle NF. Twelve miles southwest of Noxon, MT. Subalpine fir, hemlock and brush. Torching, crowning and spotting. Structure and repeater threatened.

Long Canyon Creek, Idaho Panhandle NF. Eighteen miles northwest of Bonners Ferry, ID. Subalpine fir and spruce. Creeping and smoldering. Area closures in effect.

Corral, Clearwater NF. Twenty-six miles northeast of Kooskia, ID. Timber and brush. Last narrative report.

Kettle 2, Clearwater NF. Thirty-five miles east of Kooskia, ID. Timber. Last narrative report.

Kettle Lake, Clearwater NF. Thirty-five miles east of Kooskia, ID. Timber. Last narrative report.

Powell WFU Complex (three fires), Clearwater NF. Seven miles southeast of Powell, ID. Mixed conifer and grass. Group tree torching and short crown runs. Last narrative report.

Hanson Meadows, Clearwater NF. Forty-five miles northeast of Pierce, ID. Brush and heavy timber. Active burning with short uphill runs. Last narrative report.

Sled, Clearwater NF. Forty miles northeast of Pierce, ID. Heavy timber. Active ground fire and group torching with short uphill runs. Forest Road 581 closed. Last narrative report.

Rival Nanny Complex, Lewis and Clark NF. Twenty-one miles west of Bynum, MT. Timber. Formerly named Rival Creek. Spotting, torching and running. Last narrative report.

Rockland, Idaho Falls District, BLM. IMT 2 (Whalen). Five miles east of Rockland, ID. Timber, brush and grass. Short runs and torching. Residences and cultural sites threatened.

East Roaring, Boise NF. IMT 2 (Suwyn). Thirteen miles northeast of Pine, ID. Timber. Moderate fire behavior with single and group tree torching. Structures, Forest Service guard station and campgrounds threatened. Road closures in effect.

Middle Fork Complex (eight fires), Salmon-Challis NF. FUMT (Perkins). Thirty miles west of Challis, ID. Timber and grass. Isolated tree torching, spotting and backing fire. Residences, ranches and fisheries threatened.

Rattlesnake Complex (two fires), Boise NF. IMT 1 (Muir). Thirteen miles northeast of Garden Valley, ID. Subalpine fir, pine and grass. Moderate fire behavior, group tree torching and spotting. Residences, commercial property and Forest Service guard station threatened.

Red Mountain, Boise NF. IMT 1 (Martin) and IMT 1 (Broyles). IMT also managing the Boundary Complex and Trailhead fire. Sixteen miles northeast of Lowman, ID. Subalpine fir and lodgepole pine. Active crown runs with short range spotting. Campgrounds, Forest Service guard station and cultural sites threatened.

Knapp #2, Salmon-Challis NF. Sixteen miles northwest of Stanley, ID. Grass, brush and heavy timber. Torching and spotting.

Cinder, Twin Falls District, BLM. Started on private land twelve miles east of Dietrich, ID. Grass and sagebrush. Running fire behavior.

South Fork Complex (26 fires), Payette NF. IMT 2 (Philbin) and FUMT (Reinarz). Thirteen miles east of McCall, ID. Timber and brush. Group tree torching and small crown runs. Town of Yellow Pine, lookouts and campgrounds threatened.

Green Canyon, Eastern Idaho Area Office, Idaho Department of Lands. IMT 2 (Lineback). Six miles southwest of Rockland, ID. Timber. Isolated torching and backing fire.

Snowshoe, Idaho Falls District, BLM. Seventeen miles northwest of Saint Anthony, ID. Brush and grass. Active, wind driven fire behavior.

Dune, Idaho Falls District, BLM. Nine miles north of Saint Anthony, ID. Brush and grass. No further information received.

Boundary Complex (three fires), Salmon-Challis NF. Fourteen miles southeast of Landmark, ID. Timber with heavy dead and down fuels. Active crown runs with short range spotting. Ranch and mine sites threatened. Structure protection in place.

Trout Creek, Payette NF. FUMT (Hall). FUMT also managing Payette WFU Complex. Fifty miles northeast of McCall, ID. Timber and grass. Minimal fire behavior.

Payette WFU Complex (thirteen fires), Payette NF. Twenty miles northeast of McCall, ID. Timber. Backing fire with isolated torching.

Battle Mountain, Bridger-Teton NF. Thirty miles northeast of Pinedale, WY. Timber. Minimal fire behavior.

Valley, South Central Area, Utah State DFF. Ten miles west of Kanosh, UT. Pinion pine, juniper, Sagebrush and cheat grass. Minimal fire activity.

Amazon, Elko Field Office, BLM. IMT 1 (Oltrogge). Eight miles northwest of Tuscarora, NV. Sagebrush and grass. Wind-driven short range spotting, rapid growth. Structures, fisheries and grazing land threatened.

Scenic, Las Vegas Field Office, BLM. Five miles north of Blue Diamond, NV. Brush and grass. Minimal fire activity. Red Rock visitor area closed.

Oreana, Ely Field Office, BLM. Twenty miles north of Hiko, NV. Grass, sagebrush, pinyon pine and juniper. Moderate to extreme fire behavior.

Cloudy, Ely Field Office, BLM. Twenty miles north of Hiko, NV. Grass and sagebrush. Creeping and wind-driven runs.

Dusky, Ely Field Office, BLM. Twenty miles south of Caliente, NV. Sagebrush, grass and pinyon pine. Tree torching.

Deer, Elko Field Office, BLM. Transfer command from IMT 2 (Thomas) to local unit today. Twenty-five miles southwest of Jackpot, NV. Sagebrush, grass, mahogany and aspen. Smoldering.

Power lines, communities of Big Flat, Helena and Big Bar and watershed threatened. Highway 299 closed.

Uncles Complex (2 fires), Klamath NF. IMT 2 (Kaage). Eighteen miles northeast of Orleans, CA. Old growth timber and brush. Uphill runs, torching, flanking and short range spotting. Structures and fisheries threatened.
