Area Command Team (Zimmerman) is assigned to assist the Northern Rockies with analyzing assessments for long duration fires and emerging incidents.

Jocko Lakes, Flathead Agency, BIA. IMT 2 (McNitt) and IMT 1 (Wilcock). Twenty-six miles northeast of Missoula, MT. Timber with dead and down lodgepole. Active fire behavior with short runs. Communities and structures threatened. Evacuations and highway restrictions in effect.

Skyland, Flathead NF. Transfer of command from IMT 2 (LaFave) to IMT 1 (Pendleton) on 8/8. Thirty-two miles east of Kalispell, MT. Timber and grass. Isolated torching and creeping. Structures threatened. Evacuations in effect.

Chippy Creek, Northwestern Land Office, Montana DNR. IMT 2 (Raley). Forty-two miles southwest of Kalispell, MT. Timber, dead and down lodgepole and logging slash. Backing with short uphill runs. Structures threatened.

Ahorn, Lewis and Clark NF. IMT 1 (Whitney). Thirty miles west of Augusta, MT. Timber. Smoldering, creeping with isolated torching. Structures threatened.

Meriwether, Helena NF. IMT 1 (Oltrogge). Thirty-seven miles northwest of Helena, MT. Timber, brush and grass. Active backing fire with occasional torching. Structures threatened.

Rattlesnake, Nez Perce NF. IMT 2 (Secrest). Twenty-five miles south of Elk City, ID. Timber and grass. Active surface fire with group torching and short crown runs. Communities of Comstock and Dixie threatened.

Sawmill Complex (three fires), Lolo NF. IMT 2 (Heintz). Twenty-two miles southeast of Missoula, MT. Timber. Active fire behavior, uphill runs, torching and spotting. Structures threatened. Evacuations in effect.

Echo Springs, West St. Joe Area Office, Idaho Department of Lands. IMT 2 (Kaage). Six miles southwest of St. Maries, ID. Timber and logging slash. Isolated torching and creeping. Structures threatened.

Brush Creek, Flathead NF. IMT 2 (Koehler). Twenty-five miles west of Whitefish, MT. Timber. Isolated torching. Structures threatened.

Rombo Mountain, Bitterroot NF. FUMT (Svalberg). Eighteen miles south of Darby, MT. Bug-killed timber. Group tree torching with short-range spotting. Structures threatened.

Bridge, Clearwater NF. Forty-five miles southwest of Missoula, MT. Timber. Smoldering, creeping and isolated torching.

Poe Cabin, Craig Mountain Area Office, Idaho Department of Lands. IMT 2 (Sciacca). Twenty-three miles southwest of Grangeville, ID. Timber and grass. Moderate fire activity with torching and short-range spotting.

Mile Marker 124, Southwestern Land Office, Montana DNR. IMT 2 (Angell). Nineteen miles southeast of Missoula, MT. Timber. Smoldering. Reduction in acreage due to more accurate mapping.

Fool Creek, Lewis and Clark NF. Thirty miles northwest of Choteau, MT. Timber and snags. Short crown runs, group torching and short-range spotting. Structures threatened.

Owl, Yellowstone NP. Forty-five miles south of Bozeman, MT. Timber and grass. Smoldering. Structures threatened..

Chimney Complex, Craig Mountain Area Office, Idaho Department of Lands. Nineteen miles south of Lewiston, ID. Timber and grass. Creeping, smoldering and isolated torching.

Garceau, Flathead Agency, BIA. Fifty-five miles south of Whitefish, MT. Timber and grass. No further information received.

Conger Creek, Lolo NF. Twenty miles north of Ovando, MT. Timber. Moderate fire behavior with torching and spotting. Structures threatened.

Pattengail Creek, Beaverhead/Deerlodge NF. Ten miles northeast of Wisdom, MT. Timber with dead and downed fuels. Surface fire with isolated torching.

Tin Cup, Bitterroot NF. Four miles west of Darby, MT. Logging slash. Uphill runs, torching and crowning. Structures threatened. Evacuations in effect.

Porcupine, Gallatin NF. Thirty-one miles north of Livingston, MT. Timber. No new information.

Area Command Team (Ribar) is assigned to manage large fires for the Boise and Payette National Forests.

Cascade Complex (four fires), Boise NF. IMT 1 (Opliger and Broyles). Three miles northeast of Cascade, ID. Timber. Moderate fire behavior with torching and short-range spotting. Community of Yellow Pine and numerous structures threatened.

East Zone Complex (three fires), Payette NF. Transfer of command from IMT 1 (Pincha-Tulley) to NIMO (Ferguson) on 8/8. Includes previously reported Horton fire. Thirty miles northeast of McCall, ID. Timber, brush

and grass. Active fire behavior with wind-driven runs, crowning, and long-range spotting. Communities of Secesh and Warren, historic sites and bridges threatened.

Middle Fork Complex (four fires), Boise NF. IMT 2 (Harvey). Fifteen miles northeast of Garden Valley, ID. Timber and brush. Active surface fire with, torching and spotting. Structures threatened.

Trapper Ridge, Boise NF. IMT 2 (Lund). Twenty-eight miles northeast of Idaho City, ID. Timber and hardwood. Uphill runs, torching and short-range spotting. Structures threatened.

Raines, Payette NF. Transfer of command from FUMT (Ourada/Soper) to NIMO (Ferguson) on 8/8. FUMT is also managing the Krassel Complex. Thirty-eight miles northeast of McCall, ID. Timber, grass and heavy dead and down fuels. Active fire behavior with torching and short runs. Structures threatened.

Shower Bath, Salmon-Challis NF. IMT 2 ordered. Eighteen miles northwest of Challis, ID. Timber. Wind-driven fire behavior.

Walcott, Twin Falls District, BLM. Thirty miles northeast of Burley, ID. Brush and grass. Extreme fire behavior with wind-driven runs.

Hubbard, Idaho Falls District, BLM. Started on private land twenty-two miles northwest of Malad City, ID. Grass and brush. Minimal fire behavior. Reduction in acreage due to more accurate mapping.

Granite Creek, Bridger-Teton NF. Fifteen miles southeast of Jackson, WY. Timber and dead and down fuels. Smoldering.

Krassel Complex (seven fires), Payette NF. Forty-four miles northeast of Yellow Pine, ID. Timber, grass and heavy dead and down fuels. Active fire behavior.

Red Bluff, Salmon-Challis NF. Previously reported WFU. Thirty-one miles northwest of Challis, ID. Timber. Smoldering and creeping. Last narrative report unless significant activity occurs.

Dead Eye, Sawtooth NF. Nineteen miles southeast of Twin Falls, ID. Grass and sage brush. Active fire behavior with moderate rates of spread.

WSA Lightning Complex (three fires), Warm Springs Agency, BIA. IMT 2 (Goheen). Twenty-one miles southwest of Warm Springs, OR. Bug-killed timber and brush. Active fire behavior with torching and spotting.

Shelton, Oregon Department of Forestry. Oregon IMT (Savage). Ten miles southeast of Fossil, OR. Timber, brush and grass. Active burning in heavy fuels with torching. Structures threatened.

Trout Meadows, Umatilla NF. IMT 2 (Paul). Thirty-two miles southwest of La Grande, OR. Timber and grass. Active fire behavior with running, group torching and spotting. Structures threatened.

Crow Creek, Okanogan/Wenatchee NF. Washington IMT 2 (Barnett). Sixteen miles southwest of Cle Elum, WA. Timber. Isolated torching, creeping and smoldering.

Colman Mountain, Burns District, BLM. Thirty-seven miles west of Burns, OR. Sage brush, juniper and grass. Active fire behavior with significant runs.

Butte Fire, Vale District, BLM. Sixteen miles south of Juntura, OR. Grass and brush. Wind-driven fire behavior. Structures and power lines threatened.

Tolo, North Cascades NP. Thirty-three miles west of Winthrop, WA. Timber. Backing fire with intermediate torching and short-range spotting.
