Area Command Team (Zimmerman) is assigned to assist the Northern Rockies with analyzing assessments for long duration fires and emerging incidents.

Tin Cup, Bitterroot NF. IMT 2 (Kaage). Four miles west of Darby, MT. Timber and logging slash. Active ground fire with torching and short crown runs. Structures threatened. Evacuations in effect.

Jocko Lakes, Flathead Agency, BIA. IMT 1 (Wilcock). Twenty-six miles northeast of Missoula, MT. Timber with dead and down lodgepole pine. Group tree torching and short-range spotting. Community of Seeley Lake and numerous structures threatened. Evacuations and Highway 83 restrictions in effect.

Chippy Creek, Northwestern Land Office, Montana DNR. IMT 2 (Raley). Forty-two miles southwest of Kalispell, MT. Timber, dead and down lodgepole and logging slash. Short uphill runs, backing, creeping and smoldering. Residences threatened. Evacuations in effect.

Skyland, Flathead NF. IMT 1 (Pendleton). Thirty-two miles east of Kalispell, MT. Timber and grass. Moderate fire activity. Structures threatened.

Sawmill Complex (three fires), Lolo NF. IMT 2 (Heintz). Twenty-two miles southeast of Missoula, MT. Timber. Active fire behavior with crown runs, group tree torching and spotting. Structures threatened.

Rattlesnake, Nez Perce NF. IMT 2 (Secrest). Twenty-five miles south of Elk City, ID. Timber and grass. Active surface fire with short runs and group tree torching. Community of Comstock and outlying structures threatened.

Ahorn, Lewis and Clark NF. IMT 1 (Whitney). Thirty miles west of Augusta, MT. Timber. Isolated and group tree torching. Structures threatened. Evacuations in effect.

Brush Creek, Flathead NF. IMT 2 (Koehler). Twenty-five miles west of Whitefish, MT. Timber. Active surface fire with single tree torching. Structures threatened. Evacuations in effect.

Meriwether, Helena NF. IMT 1 (Oltrogge). Thirty-seven miles northwest of Helena, MT. Timber, brush and grass. Active fire with isolated interior torching. Structures threatened.

Rombo Mountain, Bitterroot NF. FUMT (Svalberg). Eighteen miles south of Darby, MT. Bug-killed timber. Uphill crown runs, torching and spotting. Structures threatened.

Fool Creek, Lewis and Clark NF. Thirty miles northwest of Choteau, MT. Timber and snags. Isolated torching, crowning and spotting. Structures threatened.

Poe Cabin, Craig Mountain Area Office, Idaho Department of Lands. IMT 2 (Sciacca). Twenty-three miles southwest of Grangeville, ID. Timber and grass. Minimal fire activity with creeping and smoldering.

Bridge, Clearwater NF. Forty-five miles southwest of Missoula, MT. Timber. Interior pockets burning out with little perimeter growth.

Conger Creek, Lolo NF. Twenty miles north of Ovando, MT. Timber. Moderate fire behavior with torching, spotting and backing. Structures threatened.

Pattengail Creek, Beaverhead/Deerlodge NF. Ten miles northeast of Wisdom, MT. Timber with dead and downed fuels. Isolated torching and short uphill runs.

Chimney Complex, Craig Mountain Area Office, Idaho Department of Lands. Nineteen miles south of Lewiston, ID. Timber and grass. Creeping, smoldering and occasional torching.

Garceau, Flathead Agency, BIA. Fifty-five miles south of Whitefish, MT. Timber and grass. No further information received.

Area Command Team (Loach) is assigned to manage large fires for the Boise and Payette National Forests.

Cascade Complex (six fires), Boise NF. IMT 1 (Broyles) and IMT 2 (Suwyn). Suwyn's IMT will manage the Landmark Complex (two fires). Three miles northeast of Cascade, ID. Timber. Moderate fire behavior with torching and short-range spotting. Community of Yellow Pine and numerous outlying structures threatened.

East Zone Complex (three fires), Payette NF. NIMO (Ferguson). NIMO team also managing the Raines fire. Thirty miles northeast of McCall, ID. Timber, brush and grass. Active fire behavior with group torching, spotting and uphill runs. Communities of Secesh and Warren, historic sites and bridges threatened.

Shower Bath, Salmon-Challis NF. IMT 2 (Saleen). Eighteen miles northwest of Challis, ID. Timber. Active fire with uphill runs, torching, crowning and long-range spotting. Structures threatened. Reduction in acreage due to more accurate mapping.

Middle Fork Complex (three fires), Boise NF. IMT 2 (Lund). IMT also managing the Trapper Ridge WFU. Fifteen miles northeast of Garden Valley, ID. Timber and brush. Group torching and spotting. Structures threatened. Reduction in acreage due reassignment of Skunk fire to the Cascade Complex.

Trapper Ridge, Boise NF. Twenty-eight miles northeast of Idaho City, ID. Timber. Active ground fire with group torching and spotting. Structures threatened.

Raines, Payette NF. Thirty-eight miles northeast of McCall, ID. Timber, grass and heavy dead and down fuels. Active fire behavior with group torching and short runs. Structures threatened. Reduction in acreage due to more accurate mapping.

Krassel Complex (seven fires), Payette NF. FUMT (Ourada/Soper). Forty-four miles northeast of Yellow Pine, ID. Timber, grass and heavy dead and down fuels. Active fire behavior with torching and short crown runs.

Granite Creek, Bridger-Teton NF. Fifteen miles southeast of Jackson, WY. Timber with heavy dead and down fuels. Creeping and smoldering.

WSA Lightning Complex (three fires), Warm Springs Agency, BIA. IMT 2 (Goheen). Twenty-one miles southwest of Warm Springs, OR. Bug-killed timber and brush. Active fire behavior with short uphill runs, group tree torching and short-range spotting.

Trout Meadows, Umatilla NF. IMT 2 (Paul). Thirty-two miles southwest of La Grande, OR. Timber. Minimal fire behavior. Structures threatened.

Domke Lake Complex, Okanogan/Wenatchee NF. IMT 2 (Schulte). Thirty-six miles northwest of Chelan, WA. Bug-killed timber. Wind-driven fire activity. Structures threatened.

Easton Ridge, Southeast District, Washington State DNR. Washington IMT 2 (Gormley). Three miles southwest of Easton, WA. Timber. Creeping and smoldering.

Battle Creek Complex, Wallowa-Whitman NF. Transfer of command from IMT 2 (Batten) back to local unit tomorrow. Twenty-seven miles northeast of Joseph, OR. Timber, brush and grass. Creeping and smoldering.

Shelton, Oregon Department of Forestry. Oregon IMT (Savage). Ten miles southeast of Fossil, OR. Timber, brush, and grass. Smoldering.

Spear Springs, Burns Fire Zone, Malheur NF. IMT 2 (West). Twenty-one miles north of Burns, OR. Timber. Minimal torching and creeping.

Coleman Mountain, Burns District, BLM. IMT 1 (Hoff). IMT also managing Juniper Ranch fire. Thirty-seven miles west of Burns, OR. Sage brush, juniper and grass. Running fire behavior with interior torching and creeping. Structures threatened.

Juniper Ranch, Burns District, BLM. Twenty-seven miles northwest of Burns Junction, OR. Brush and grass. fire behavior with interior torching and creeping. Structures threatened.

Tolo, North Cascades NP. Thirty-three miles west of Winthrop, WA. Timber. Creeping and smoldering.

Butte Fire, Vale District, BLM. Sixteen miles south of Juntura, OR. Grass and brush. Smoldering.

Spot Weather Forecast

Spot weather forecasts should be requested for those fires that have potential for extreme fire behavior, exceed initial attack, or are located in areas where Red Flag Warnings have been issued.

🔴 Basic elements needed for a spot weather forecast include:

- Name of fire and management agency
- Request time and date
- Location by ¼ section
- Drainage name
- Exposure
- Size
- Elevation (top and bottom)
- Fuel type
- Fire character (ground, crown, etc.)
- Weather conditions (place, elevation, observation time, wind direction, wind velocity, dry bulb, wet bulb, remarks)
