Area Command Team (Zimmerman) is assigned to assist the Northern Rockies with analyzing assessments for long duration fires and emerging incidents.

**Black Cat**, Southwestern Land Office, Montana DNR. IMT 1 (Martin). Started on private land four miles east of Frenchtown, MT. Logging slash. Active fire behavior with active runs, torching and spotting. Structures, Highway 93 and power lines threatened. Evacuations in effect. Hwy 93 temporarily closed.

**Jocko Lakes**, Flathead Agency, BIA. IMT 1 (Wilcock). IMT also managing the Ovando Point fire. Twenty-six miles northeast of Missoula, MT. Timber with dead and down lodgepole pine. Single and group tree torching with spotting. Numerous structures threatened. Evacuations in effect.

**Chippy Creek**, Northwestern Land Office, Montana DNR. IMT 1 (Bennett). Forty-two miles southwest of Kalispell, MT. Timber, dead and down lodgepole and logging slash. Surface fire, smoldering with isolated torching. Residences threatened. Evacuations in effect.

**Sawmill Complex** (three fires), Lolo NF. IMT 2 (McNitt). Twenty-two miles southeast of Missoula, MT. Timber and grass. Sustained crown runs. Structures threatened. Evacuations in effect.

**WH Complex** (2 fires), Gallatin NF. IMT 1 (Stanich). Twenty-seven miles south of Livingston, MT. Timber. Creeping and smoldering. Structures threatened. Evacuations in effect.

**Rat Creek**, Beaverhead/Deerlodge NF. IMT 2 (Kaage). IMT is also managing Pattengail Creek fire. Twenty five miles west of Wisdom, MT. Timber. Short crown runs, single and group tree torching, with backing fire. Structures threatened.

**Fool Creek**, Lewis and Clark NF. IMT 1 (Whitney). IMT also managing the Ahorn fire. Thirty miles northwest of Choteau, MT. Timber and snags. Active sustained crown runs. Structures threatened. Evacuations in effect.

**Columbine 1**, Yellowstone NP. IMT 2 (Grant). Fifty-three miles west of Cody, WY. Timber. Smoldering. East Entrance Highway reopened today.

**Powder River Complex** (10 fires), Miles City Field Office, BLM. IMT 2 (Johnson). Thirty-five miles southeast of Ashland, MT. Timber, brush and grass. Minimal fire activity with torching.

**Rombo Mountain**, Bitterroot NF. FUMT (Svalberg). Eighteen miles south of Darby, MT. Bug-killed timber. Active fire behavior with short crown runs and group tree torching. Structures threatened.

**Brush Creek**, Flathead NF. IMT 2 (Hill). Twenty-five miles west of Whitefish, MT. Timber with heavy dead and down fuels. Active fire with occasional torching. Structures threatened. Evacuations in effect.

**Skyland**, Flathead NF. Transfer of command from IMT 1 (Pendleton) to IMT 2 (Heintz) scheduled for 8/19. Thirty-two miles east of Kalispell, MT. Timber and grass. Active interior burning. Increase in acreage due to burn out operations. Structures threatened.

**Rattlesnake**, Nez Perce NF. IMT 2 (Kusicko). Twenty-five miles south of Elk City, ID. Timber and grass. Short runs and single tree torching. Community of Concord and outlying structures threatened.

**Poe Cabin**, Craig Mountain Area Office, Idaho Department of Lands. Transfer of command from IMT 2 (Sciacca) to FUMT (Bonefeld) today. Twenty-three miles southwest of Grangeville, ID. Timber and grass. Moderate fire behavior with downslope runs and single tree torching.

**Boundary Junction**, Clearwater NF. Fifteen miles southeast of Pierce, ID. Timber, brush and grass. Moderate fire behavior with some torching. Reduction in acreage due to more accurate mapping.

**Bridge**, Clearwater NF. Forty-five miles southwest of Missoula, MT. Timber and brush. Minimal fire activity.

**Ahorn**, Lewis and Clark NF. Transfer of command from IMT 1 (Whitney) to FUMT (Lineback) today. Thirty miles west of Augusta, MT. Timber. Surface fire with backing and creeping. Structures threatened. Evacuations in effect.

**Meriwether**, Helena NF. Thirty-seven miles northwest of Helena, MT. Timber, brush and grass. Surface fire with isolated torching. Structures threatened.

**Muskrat Lake**, Fort Berthold Agency, BIA. Fifty-eight miles southwest of Minot, ND. Grass. Active wind driven fire with spotting.

**Calbick**, Flathead NF. Twenty miles south of East Glacier, MT. Timber. Short upslope runs with group tree torching.

**Conger Creek**, Lolo NF. Twenty miles north of Ovando, MT. Timber. Slow rates of spread.

**Pattengail Creek**, Beaverhead/Deerlodge NF. Ten miles northeast of Wisdom, MT. Timber with dead and down fuels. Short crown runs with single and group tree torching. Structures threatened.

**Slick**, Clearwater NF. Seventeen miles northeast of Pierce, ID. Timber. Active fire behavior with single and group tree torching. Last narrative report unless significant activity occurs.

**Promontory Complex** (three fires), Yellowstone NP. Previously reported WFU incident. Sixty three miles west of Cody, WY. Timber. Crowning, torching and spotting. Last narrative report unless significant activity occurs.

**Signal Rock 07**, Beaverhead/Deerlodge NF. Twenty-three miles southwest of Philipsburg, MT. Timber. No new information. Last report unless new information is received

**Bitterroot Fire Use Complex** (13 fires), Bitterroot NF. FUMT (Perkins). Fifteen miles west of Darby, MT. Timber and grass. No new information.

**Ovando Point**, Lolo NF. Eight miles northeast of Ovando, MT. Timber. No new information.

Area Command Team (Loach) is assigned to manage large fires for the Boise and Payette National Forests.

**Duncan Canyon**, Bear River Area, Utah DOF. Thirty-six miles west of Snowville, UT. Timber and grass. Active fire behavior.

**Moonshiner**, Idaho National Laboratory, DOE. Thirty miles west of Idaho Falls, ID. Juniper, brush and grass. Running and spotting. Laboratory facilities and radio towers threatened.

**Mitchell**, Idaho Falls District, BLM. IMT 2 (Whalen). IMT also managing the Cleveland fire. Ten miles north of Holbrook, ID. Timber, brush and grass. Upslope surface runs with group tree torching. Structures threatened.

**Castle Rock**, Sawtooth NF. Ten miles west of Ketchum, ID. Heavy logging slash. Extreme fire behavior with running, torching and spotting. Numerous structures threatened.

**Dig Dug**, Salt Lake Field Office, BLM. Nine miles northwest of Dugway, UT. Juniper and grass. Active fire behavior with spotting and torching. Campground evacuated.

**Cascade Complex** (three fires), Boise NF. Transfer of command from IMT 1 (Broyles) to IMT 1 (Muir) today. Twenty-five miles southeast of McCall, ID. Timber. Active behavior with long-range spotting. Community of Warm Lake, Paradise Valley and power line for Warm Lake threatened. Warm Lake Road intermittently closed. Evacuation of the Warm Lake area in effect.

**East Zone Complex** (three fires), Payette NF. NIMO (Ferguson). Twenty-five miles northeast of McCall, ID. Timber litter. Very active fire behavior with torching, spotting and short crown runs. Communities of Secesh, Warren and South Fork threatened. Evacuations in effect for Secesh and Warren.

**Shower Bath**, Salmon-Challis NF. IMT 2 (Saleen). IMT also managing the Red Bluff fire. Eighteen miles northwest of Challis, ID. Pine and fir with heavy dead and down fuels. Isolated running and torching in heavy timber. Structures threatened.

**Red Bluff**, Salmon-Challis NF. Thirty-one miles northwest of Challis, ID. Timber and grass. Moderate fire behavior with isolated running and torching. Structures threatened.

**Landmark Complex** (two fires), Boise NF. IMT 2 (Suwyn). Seven miles south of Yellow Pine, ID. Timber. Active fire with crowning and torching. Structures threatened.

**Middle**, Bridger-Teton NF. IMT 2 (Barnett). Nine miles east of Alpine, WY. Timber. Minimal fire activity due to wetting rain.

**Clear Sage**, Salmon Challis NF. Twenty five miles northwest of Salmon, ID. Brush. Spotting and creeping.

**Hardscrabble**, Bridger-Teton NF. FUMT (Reinarz). Thirty miles northwest of Dubois, WY. Bug-killed timber. Minimal fire activity due to wetting rain.

**Cleveland**, Idaho Falls District, BLM. Twelve miles northeast of Preston, ID. Brush and slash. Creeping.

**Bear Den Butte**, Twin Falls District, BLM. Started on private land 35 miles north of Minidoka, ID. Grass. Running fire.

**Duffy**, Bear River Area, Utah DOF. Twenty-five miles west of Snowville, UT. Grass. Torching. Structures threatened.

**Phillips**, Twin Falls District, BLM. Three miles northeast of Carey, ID. Grass. Interior torching. Reduction in acreage due to more accurate mapping.

**Granite Creek**, Bridger-Teton NF. Fifteen miles southeast of Jackson, WY. Timber with heavy dead and down fuels. No further information received.

**Trapper Ridge**, Boise NF. Transfer of command from IMT 2 (Lund) back to local unit today. Twenty-eight miles northeast of Idaho City, ID. Timber. Short runs with torching.

**Krassel Complex** (seven fires), Payette NF. FUMT (Ourada/Soper). Forty-four miles northeast of Yellow Pine, ID. Timber, grass and heavy dead and down fuels. Active surface fire with group tree torching and short crown runs.

**Wood**, Idaho Falls District, BLM. Forty-four miles south of Pocatello, ID. Grass. Interior smoldering. Reduction in acreage due to more accurate mapping.

**WSA Lightning Complex** (two fires), Warm Springs Agency, BIA. IMT 2 (Goheen). IMT also managing the Highway Nine fire. Twenty-one miles southwest of Warm Springs, OR. Bug-killed timber and brush. Isolated torching and backing fire.

**Ukiah Complex** (6 fires), Umatilla NF. IMT 2 (Paul and Batten). Batten IMT managing the Otter Creek fire. Six miles northeast of Ukiah, OR. Timber. Active fire behavior. Residences threatened. Highway 244 and 395 intermittently closed.

**Domke Lake Complex**, Okanogan/Wenatchee NF. IMT 2 (Schulte). Thirty-six miles northwest of Chelan, WA. Timber and dead and down fuels. Creeping with occasional torching. Evacuation notification for Lucerne and Holden Village.

**Irish Spring**, Vale District, BLM. IMT 2 (West). Twenty one miles southwest of Ironside, OR. Brush. Extreme rate of spread with medium range spotting. Structures threatened.

**Pend'D Oreille**, Colville NF. Canadian IMT (Lavesque). Burning in Canada and the U.S. eleven miles northwest of Metaline Falls, WA. Timber. No new information.

**Wantoma**, Mid Columbia Refuge, FWS. IMT 2, (Gormley). Twelve miles east of Benton City, WA. Grass. Smoldering. Structures and Native American cultural sites threatened.

**Highway Nine**, Warm Springs Agency, BIA. Three miles west of Siminasho, WA. Timber and Grass. Active fire with crowning and group torching with high rates of spread in grass.

**Battle Creek Complex**, Wallowa-Whitman NF. Twenty-seven miles northeast of Joseph, OR. Timber. Creeping with isolated torching.

**Marshall Group**, Washington DNR. Fourteen miles southwest of Spokane, WA. Timber and grass. Structures threatened. No new information.
