Black Rock Gulch, Arizona Strip Field Office, BLM. IMT 2 (Lund). Thirty miles south of St. George, UT. Timber litter and grass. Extreme fire behavior. Communications site and structures remain threatened. Evacuations in effect.

Neola North, Uintah and Ouray Agency, BIA. IMT 1 (Martin). Three miles north of Neola, UT. Brush and timber. Torching and spotting. Numerous residences and a municipal watershed remain threatened. Evacuations in effect.

Red Bridge, Twin Falls District, BLM. IMT 2 (Harvey). Ten miles south of Shoshone, ID. Running with fire whirls and spotting. Numerous structures threatened. Evacuations in effect.

Milford Flat, Southwest Area, Utah State Division of Forestry Fire & State Lands. Three miles north of Milford, UT. Grass. Extreme fire behavior. Structures, railroad bridges and geo-thermal power plant threatened. Evacuations in effect.

Black Hawk, Idaho Falls District, BLM. Started on state land seven miles east of Idaho Falls, ID. Grass and brush. Rapid rates of spread. Numerous structures threatened. Evacuations in effect.

Jungle, Manti-Lasal NF. FUMT (Ourada/Soper). Thirteen miles west of Ferron, UT. Timber litter. Isolated torching and spotting. Residences remain threatened.

Nichol, Boise District, BLM. Nine miles southwest of Mountain Home, ID. Grass and brush. Active fire behavior.

Bruneau Arm Complex, Boise District, BLM. Five miles north of Bruneau, ID. Grass and brush. Active fire behavior. Residences threatened.

Black Pine 2, Sawtooth NF. Eleven miles southeast of Malta, ID. Grass and brush. Running. Structures threatened.
