Area Command Team (Loach) assigned to manage large fires for the Elko Field Office, BLM.

Hepworth Complex (three fires), Elko Field Office, BLM. IMT 2 (Saleen). Ten miles north of Wells, NV. Grass, brush, juniper and hardwoods. Active fire behavior. Structures remain threatened.

Red House Complex (five fires), Elko Field Office, BLM. Twenty miles north of Carlin, NV. Brush and grass. Rapid rates of spread.

Boo Hoo Complex, Elko Field Office, BLM. IMT 1 (Molumby). Twenty miles south of Elko, NV. Brush and grass. This Complex will be merged with the Red House Complex.

Marge, Elko Field Office, BLM. Ten miles west of Elko, NV. Brush and grass with pinyon pine and juniper. Reduction in acreage due to more accurate mapping. No further information received. Fire will be merged with Red House Complex.

Mendive, Elko Field Office, BLM. Fifty-eight miles northwest of Wells, NV. Brush, grass and juniper. Minimal fire activity.

Winecup Complex (10 fires), Elko Field Office, BLM. IMT 1 (Broyles). Twenty-five miles southeast of Jackpot, NV. Brush and grass. Extreme plume-dominated fire behavior. Ranches and structures threatened and evacuations in progress.

Antelope Complex (four fires), Battle Mountain Field Office, BLM. IMT 1 (Muir). Thirty-six miles north of Austin, NV. Complex contains previously reported Paris, Dunphy, Cain Mountain and Raven fires. Pinyon pine, juniper and grass. Wind driven fire behavior.

Hawken, Humbolt-Toiyabe NF. IMT 1 (Martin). Started on private land four miles southwest of Reno, NV. Brush, grass and timber. Minimal fire behavior.

Cathedral, Humboldt-Toiyabe NF. IMT 2 (Woychak). Twenty-five miles southwest of Ely, NV. Timber litter, brush, grass and juniper. Minimal activity with isolated torching. Historical structures remained threatened. Reduction in acreage due to more accurate mapping.

Independence Valley, Elko Field Office, BLM. Twenty miles south of Wells, NV. Brush and grass. Isolated torching. Structures remain threatened.

Barrel Springs, Winnemucca Field Office, BLM. Fifteen miles south of Winnemucca, NV. Pinyon pine, juniper, brush and grass. No new information.

Kelly Creek, Winnemucca Field Office, BLM. Thirty miles southeast of Paradise Valley, NV. Brush and grass. No new information.

Tippets, Ely Field Office, BLM. Fifty-eight miles northwest of Ely, NV. Brush, grass and juniper. Extreme fire behavior.

Castle Place, Elko Field Office, BLM. Fourteen miles northwest of Midas, NV. Brush and grass. No new information.

Telegraph, Ely Field Office, BLM. Twenty-five miles north of Ely, NV. Brush and grass. Wind driven runs. Last narrative report unless significant activity occurs.

Pine Valley East, Lake Mead National Recreation Area, NPS. Fifty-four miles southeast of Mesquite, NV. Brush and grass. Active fire behavior.

Willow Creek Ridge, Elko Field Office, BLM. Eighty miles northwest of Elko, NV. Brush, pinyon pine and grass. No new information. Last report unless new information is received.

Dakota Hill (five fires), Zion NP. IMT 2 (Sciaccia). Twelve miles north of Springdale, UT. Hardwood litter, dead and down timber, grass. Extreme fire behavior with running, crowning and torching. Numerous structures and communities remain threatened. Evacuation orders remain in place. Road closures in effect.

East Zone Complex (three fires), Payette NF. IMT 2 (Heintz). Twenty-five miles northeast of McCall, ID. Timber litter. Active fire behavior with running, spotting and torching. Bridges, a campground and numerous structures remain threatened.

Salt Creek, South Central Area, Utah Division of Forestry. Five miles east of Nephi, UT. Timber, grass and brush. Extreme fire behavior with torching, running and backing fire. Roads and structures remain threatened. Campgrounds and residences remain evacuated.

Rowland, Twin Falls District, BLM. Nine miles southwest of Murphy Hot Springs, ID. Grass, brush, and timber. Wind-driven running and spotting. Structures and power lines remained threatened. Road closures in effect. Communities of Murphy Hot Springs and Jarbidge evacuated.

Paradise, Cedar City Field Office, BLM. Ten miles northwest of Modena, UT. Grass, brush and timber. Torching and running. Evacuation order remains in effect.

Elk Mountain, Twin Falls District, BLM. IMT1 (Hawkins). Twenty-three miles northwest of Jackpot, NV. Includes previously reported Smiths Crossing fire. Grass and brush. Extreme wind-driven fire behavior with running and spotting. Power lines, communities and residences remain threatened.

Kimbell, Salt Lake Field Office, BLM. Seven miles northwest of Grantsville, UT. Timber and grass. Running and torching. Structures threatened. Highway 138 closed.

Dairy Valley, Salt Lake Field Office, BLM. Three miles southwest of Etna, UT. Short grass. Running, torching and high rates of spread. Structures threatened.

Tongue Complex (three fires), Boise District, BLM. IMT 2 (Johnson). Forty-five miles south of Silver City, ID. Brush, grass and juniper. Running fire behavior. Structures remain threatened. Reduction in acreage due to more accurate mapping.

Granite, Bridger-Teton NF. Fifteen miles southeast of Jackson, WY. Timber and grass. Extreme fire behavior with torching, running and spotting.

Radio, Arizona Strip Field Office, BLM. Twenty miles southwest of St. George, UT. Brush, pinyon pine and juniper. Running and spotting. Structures and communications sites remain threatened.

Middle Fork Complex (22 fires), Boise NF. IMT 2 (Whalen). Eighteen miles northeast of Lowman, ID. Timber. No further information received.

Cascade Complex (17 fires), Boise NF. IMT 2 (Suwyn). Ten miles south of Yellow Pine, ID. Timber. Active fire behavior with single and group tree torching. Structures threatened.

Wood Creek, Boise District, BLM. Eighteen miles southeast of Boise, ID. Grass and brush. Minimal fire activity.

Gun Canyon, Twin Falls District, BLM. Seven miles east of Declo, ID. Grass, sage and juniper. Creeping with interior torching.

Black Pine 2, Sawtooth NF. Transfer of command from IMT 2 (Grant) back to local unit today. Started on private land eleven miles southeast of Malta, ID. Grass, brush and juniper. Minimal fire behavior.

Sullivan Clark, Arizona Strip Field Office, BLM. Twenty-seven miles southeast of Mesquite, NV. Grass, pinyon pine and juniper. Smoldering, creeping, and torching.

Monarch, Salt Lake Field Office, BLM. Twenty-eight miles northwest of Grantsville, UT. Timber, grass and brush. Extreme rates of spread in juniper pockets. Communication site, power lines and structures threatened.

Van Horn, Salmon-Challis NF. Fifteen miles north of Challis, ID. Timber litter, snags, dead and down timber. Creeping and torching. Structures remain threatened.

Trapper Ridge, Boise NF. FUMT (Hahnenberg). Four miles northeast of Graham Airstrip, ID. Hardwood litter. Active fire behavior with rapid rates of spread, torching and crowning.

Krassel Complex (4 fires), Payette NF. FUMT (Perkins). Forty-four miles northeast of Yellow Pine, ID. Grass, brush, timber litter and downed logs. Moderate fire activity with torching and creeping.

Jim Canyon, Sawtooth NF. Seven miles west of Curlew, ID. Brush, juniper and grass. Interior torching.

Poe Cabin, Craig Mountain Area Office, Idaho Department of Lands. IMT 1 (Stanich). Six miles southwest of White Bird, ID. Timber and grass. Extreme fire behavior with torching, running and spotting. Structures threatened. Evacuations in effect.

Chimney Complex, Craig Mountain Area Office, Idaho Department of Lands. IMT 2 (Kusicko). Nineteen miles south of Lewiston, ID. Timber and grass. Active fire behavior with group torching and running. Numerous structures remain threatened.

Ahorn, Lewis and Clark NF. IMT 1 (Bennett). IMT is also managing Novak and Little Wolf Creek fires. Thirty miles west of Augusta, MT. Timber litter. Moderate fire behavior. Structures remain threatened.

Novak, Central Land Office, Montana DNR. Ten miles southwest of Cascade, MT. Timber, brush and grass. Torching and crowning. Structures threatened.

Little Wolf Creek, Central Land Office, Montana DNR. Forty-six miles west of Great Falls, MT. Timber, brush and grass. Crown fire with torching. Structures threatened. Subdivision evacuated.

Rattlesnake, Nez Perce NF. IMT 2 (Turman). IMT is also managing the Concord WFU. Twenty-five miles south of Elk City, ID. Timber and grass. Active fire behavior with short runs and isolated torching. Structures remain threatened.

Fool Creek, Lewis and Clark NF. Transfer of command from FUMT (Svalberg) to FUMT (Hall) will occur today. Thirty miles northwest of Choteau, MT. Timber litter. Creeping and smoldering. Structures remain threatened.

Pattengail Creek, Beaverhead/Deerlodge NF. IMT 2 (Secrest). Ten miles northeast of Wisdom, MT. Timber. Active fire behavior with group torching and short range spotting.

Concord, Nez Perce NF. Twenty miles southwest of Elk City, ID. Timber litter. Moderate fire activity with isolated torching and spotting.

Monument Complex, Umatilla NF. IMT 2 (West). Five miles north of Monument, OR. Timber, hardwoods, juniper and grass. Torching and running. Power lines and structures remain threatened.

Battle Creek Complex (three fires), Wallowa-Whitman NF. IMT 1 (Hoff). Twenty-eight miles northeast of Enterprise, OR. Timber, grass and timber litter. Active fire behavior with torching, crowning and long range spotting. Historic structures, residences and power lines remain threatened.

Egley Complex (seven fires), Burns Fire Zone, Malheur NF. IMT 1 (Pendleton). IMT is also managing the Bellows Creek fire. Ten miles north of Riley, OR. Timber litter, grass and brush. Moderate fire behavior with torching.

WSA Lightning Complex (three fires), Warm Springs Agency, BIA. Washington IMT 2 (Jennings). Twenty-one miles southwest of Warm Springs, OR. Timber litter and brush. Wind driven fire behavior with torching. Structures remain threatened.

Juniper Reservoir, Vale District, BLM. IMT 2 (Reinarz). Fifty-four miles west of Vale, OR. Brush and slash. Torching creeping and short runs. Structures remain threatened.

Trout Creek, Wallowa-Whitman NF. IMT 2 (Blume). Twenty-nine miles northeast of Baker City, OR. Timber and grass. Torching, spotting, creeping and smoldering. Structures threatened.

Ball Point, Mt. Hood NF. IMT 2 (Goheen). Twenty-three miles southwest of The Dalles, OR. Timber litter and logging slash. Smoldering.

Tolo, North Cascades NP. FUMT (Bonefeld). Thirty-three miles west of Winthrop, WA. Timber litter and hardwoods. Smoldering and creeping. **FUMT arrived and inbriefed**

Windy Ridge (three fires), Colville NF. Washington IMT 2 (Reed). Seven miles northwest of Metaline Falls, WA. Timber litter and logging slash. Minimal fire behavior. Reduction in acreage due to more accurate mapping.

Bellows Creek, Burns Fire Zone, Malheur NF. Twenty-three miles north of Burns, OR. Timber, grass and brush. Moderate fire behavior with torching. Structure threatened.

Old Maid, Vale District, BLM. Seventeen miles northwest of Jordan Valley, OR. Grass, brush and timber. High winds caused significant runs. Residence threatened. Road closures in effect.

Looney Spring, Malheur NF. Twelve miles west of Unity, OR. Timber litter. Minimal fire behavior.

Rattlesnake Command, Washington DNR. Twelve miles northwest of Benton City, WA. Grass and sage. Last report unless new information is received.

Juniper Canyon, Vale District, BLM. Nineteen miles east of Umatilla, OR. Brush. Last report unless significant activity occurs.

ASH PIT HAZARDS

Ash pits are an inherent and invisible risk to wildland firefighters that can cause severe burns and injuries. Ash pits are created when organic combustibles consume underground and empty space is created that is undetectable from the surface.

Environmental factors that increase the risk of ash pit formation after a wildfire:

- Extensive root systems of trees and shrubs.
- Deep duff or peat, the organic layer covering mineral soil.
- Landscapes that have once been cultivated or manipulated by heavy equipment ie, old dozer piles, sawmills, timber sale yards or decking areas.
- Small rodent holes that have become filled with decadent combustible debris ie, beaver holes near dams and stream beds, Badger and Coyote dens.
- White ash is sometimes an indicator as are groups of hovering insects.

Mitigation measures to consider:

- Identification of high risk landscape.
- Identify and flag all hazardous discovered ash pits.
