Area Command Team (Loach) is assigned to manage large fires for the Elko Field Office, BLM.

Winecup Complex (nine fires), Elko Field Office, BLM. IMT 1 (Broyles). Six miles west of Jackpot, NV. Brush and grass. Extreme plume-dominated fire behavior. Ranches, structures and utility infrastructures threatened.

Hepworth Complex (four fires), Elko Field Office, BLM. IMT 2 (Saleen). Ten miles north of Wells, NV. Grass, brush, juniper and hardwoods. Independence Valley fire added to this Complex. Active fire behavior. Structures remain threatened. Portion of acreage increase due to addition of new fires to the Complex.

Cathedral, Humboldt-Toiyabe NF. IMT 2 (Woychak). Twenty-five miles southwest of Ely, NV. Pinyon pine and Juniper. Minimal fire behavior. Historical structures remained threatened.

Red House Complex (three fires), Elko Field Office, BLM. IMT 1 (Molumby). Twenty miles north of Carlin, NV. Complex includes previously reported Boo Hoo Complex and Marge fire. Brush and grass. Moderate fire behavior with isolated torching and creeping. Structures threatened.

Antelope Complex (four fires), Battle Mountain Field Office, BLM. IMT 1 (Muir). Thirty-six miles north of Austin, NV. Brush and grass. Structures remain threatened.

Hawken, Humbolt-Toiyabe NF. Transfer of command from IMT 1 (Martin) back to local unit today. Started on private land four miles southwest of Reno, NV. Brush, grass and timber. Minimal fire behavior with interior torching.

Tippets, Ely Field Office, BLM. Fifty-eight miles northwest of Ely, NV. Brush, grass and juniper. Isolated torching. Reduction in acreage due to more accurate mapping.

Pine Valley East, Lake Mead National Recreation Area, NPS. Fifty-four miles southeast of Mesquite, NV. Brush and grass. Interior torching.

Castle Place, Elko Field Office, BLM. Fourteen miles northwest of Midas, NV. Brush and grass. No new information. Last report unless new information is received.

Dakota Hill (five fires), Zion NP. IMT 2 (Sciaccia). Twelve miles north of Springdale, UT. Hardwood litter, dead and down timber, grass. Active fire behavior with running crown fire, backing fire and torching. Numerous structures and communities remain threatened. Road closures remain in effect.

Paradise, Cedar City Field Office, BLM. Ten miles northwest of Modena, UT. Grass, brush and timber. Torching and running. Structures remain threatened.

Salt Creek, South Central Area, Utah Division of Forestry. IMT 1 (Ruggiero). Five miles east of Nephi, UT. Timber, grass and brush. Extreme fire behavior with torching, running and spotting. Roads and structures remain threatened. Residences remain evacuated.

East Zone Complex (three fires), Payette NF. IMT 2 (Heintz). Twenty-five miles northeast of McCall, ID. Timber litter. Active fire behavior with running and torching. Bridges, a campground and numerous structures remain threatened.

Murphy Complex, Twin Falls District, BLM. IMT 1 (Hawkins). Fifty-six miles southwest of Twin Falls, ID. Brush and juniper. Complex includes previously reported Rowland and Elk Mountain fires. Very active running fire with isolated torching. Evacuation of several communities remains in effect. Numerous communities and Mountain Home AFB Training Range facilities and ranches are threatened.

Kimbell, Salt Lake Field Office, BLM. Seven miles northwest of Grantsville, UT. Timber and grass. Running and torching. Structures remain threatened.

North Fork, South Idaho Timber Protective Association. Fourteen miles southeast of Donnelly, ID. Timber. Crowning and running.

Dairy Valley, Salt Lake Field Office, BLM. Three miles southwest of Etna, UT. Grass. Running with high rates of spread. Structures threatened. Evacuations in effect. Has burned into the Wine Cup complex in Nevada.

Cascade Complex (17 fires), Boise NF. IMT 2 (Suwyn). Ten miles south of Yellow Pine, ID. Timber. Running fire behavior with crown fire. Structures remain threatened Road closures in effect.

Middle Fork Complex (22 fires), Boise NF. IMT 2 (Whalen). Eighteen miles northeast of Lowman, ID. Timber and brush. Torching, spotting and running. Structures remain threatened. Road closures in effect.

Van Horn, Salmon-Challis NF. Fifteen miles north of Challis, ID. Timber litter, snags, dead and down timber. Torching, short crown runs. Structures remain threatened.

Monarch, Salt Lake Field Office, BLM. Twenty-eight miles northwest of Grantsville, UT. Timber, grass and brush. Torching and running.

Granite, Bridger-Teton NF. Fifteen miles southeast of Jackson, WY. Timber and grass. Active fire behavior with spotting.

Trapper Ridge, Boise NF. FUMT (Hahnenberg). Four miles northeast of Graham Airstrip, ID. Hardwood litter. Active fire behavior with torching and spotting.

Tongue Complex (three fires), Boise District, BLM. IMT 2 (Johnson). Forty-five miles south of Silver City, ID. Brush, grass and juniper. Minimal fire activity. Structures remain threatened. Reduction in acreage due to more accurate mapping.

Black Pine 2, Sawtooth NF. Started on private land eleven miles southeast of Malta, ID. Grass, brush and juniper. Minimal fire behavior with isolated torching and creeping.

Krassel Complex (4 fires), Payette NF. FUMT (Perkins). Forty-four miles northeast of Yellow Pine, ID. Grass, brush, timber litter and downed logs. Spreading and isolated torching.

Jim Canyon, Sawtooth NF. Seven miles west of Curlew, ID. Brush, juniper and grass. No new information.

Gun Canyon, Twin Falls District, BLM. Seven miles east of Declo, ID. Grass, sage and juniper. No new information.

Poe Cabin, Craig Mountain Area Office, Idaho Department of Lands. IMT 1 (Stanich). Six miles southwest of White Bird, ID. Tall grass. Active fire behavior and short up-slope runs. Communities and structures remain threatened. Evacuations and road closures remain in effect.

Chimney Complex, Craig Mountain Area Office, Idaho Department of Lands. IMT 2 (Kusicko). Nineteen miles south of Lewiston, ID. Timber and grass. Active fire behavior with group torching and running. Numerous structures remain threatened. Evacuations in effect.

Predictive Services Discussion: Thunderstorm activity increasing in the West. High pressure building over the Rockies, will spread monsoon moisture into the Great Basin, western Wyoming and the southern California mountains and deserts for mainly wet thunderstorms today. However, drier storms are expected over the northern portion of the Great Basin and Wyoming. Dry weather will prevail over the northern Rockies and most of California. A warming trend is expected over much of the West.

ASH PIT HAZARDS

Ash pits are an inherent and invisible risk to wildland firefighters that can cause severe burns and injuries. Ash pits are created when organic combustibles consume underground and empty space is created that is undetectable from the surface.

● Environmental factors that increase the risk of ash pit formation after a wildfire:

- Extensive root systems of trees and shrubs.
- Deep duff or peat, the organic layer covering mineral soil.
- Landscapes that have once been cultivated or manipulated by heavy equipment ie, old dozer piles, sawmills, timber sale yards or decking areas.
- Small rodent holes that have become filled with decadent combustible debris ie, beaver holes near dams and stream beds, Badger and Coyote dens.
- White ash is sometimes an indicator as are groups of hovering insects.

● Mitigation measures to consider:

- Identification of high risk landscape.
- Identify and flag all hazardous discovered ash pits.
