Sweat Farm Road, Georgia Forestry Commission. IMT 2 (Floyd) and NIMO (Ferguson). Started on private land 10 miles southeast of Waycross, GA. Southern rough and timber. Spotting with moderate rates of spread. City of Folkston threatened. Evacuation remain in effect. U.S. Highway remains closed.

Big Turnaround Complex, Okefenokee NWR. IMT 1 (Ruggiero) and IMT 2 (Wilder). Ten miles southeast of Waycross, GA. Southern rough, timber and gallberry. Backing fire. Evacuations remain in effect. Private timber plantations threatened.

Roundabout, Georgia Forestry Commission. Started on private land four miles west of Pearson, GA. Southern rough and timber. Moderate fire activity.

Pinnacle, National Forests in North Carolina. IMT 2 (Raley). Fifteen miles east of North Cove, NC. Hardwood litter and timber. Spotting.

Knee Knocker Swamp, Georgia Forestry Commission. One mile northwest of Nahunta, GA. Southern rough. Moderate fire activity. Numerous structure threatened.

Army Trail, Daniel Boone NF. Nine miles southwest of Hyden, KY. Hardwood litter. Upslope runs and backing fire.
