Area Command Team (Rounsaville) assigned to manage large federal fires in Georgia and Florida.

Florida Bugaboo, National Forests in Florida. IMT 1 (Quesinberry). Baker County, FL. Southern rough. Running and spotting. Numerous structures in several communities remain threatened.

Bugaboo Scrub, Okefenokee NWR. Sixteen miles west of Folkston, GA.. Southern rough and timber. Extreme fire activity with torching. Numerous structures remain threatened.

Dairy Road, Florida DOF. Seven miles northwest of Keystone Heights, FL. Timber and brush. Extreme fire behavior. Numerous residences threatened. Reduction in acreage due to more accurate mapping.

Floyds Island Prairie, Okefenokee NWR. IMT 1 (Ruggiero). IMT also managing Big Turnaround Complex. Sixteen miles west of Folkston, GA. Southern rough. Extreme fire activity. Fire has merged with Big Turnaround Complex. This will be the last report.

Big Turnaround Complex, Okefenokee NWR. Ten miles southeast of Waycross, GA. Southern rough and timber. Extreme fire activity with isolated torching. Folkston and surrounding communities remain threatened.

Balsa, Florida DOF. Started on private land five miles east of Naples, FL. Palmetto and brush. No further information received.

Airport Road, Florida DOF. IMT 2 (Utley). IMT also managing the Red Oak and Lee House. Three miles southwest of Ormond Beach, FL. Hardwood litter. Smoldering.

Roundabout Swamp, Georgia Forestry Commission. Started on private land four miles west of Pearson, GA. Southern rough and timber. Active fire behavior and reburning.

Sweat Farm Road, Georgia Forestry Commission. IMT 2 (Hannemann). Started on private land 10 miles west of Waycross, GA. Southern rough and timber. Backing fire and reburning. State park remains threatened.

Knee Knocker Swamp, Georgia Forestry Commission. One mile northwest of Nahunta, GA. Southern rough and logging slash. Structures remain threatened.

Lee House, Florida DOF. Started on private land three miles southeast of Cassia, FL. Southern rough. Smoldering.

Fakahatchee, Florida DOF. Six miles southwest of Miles City, FL. Timber and palmetto. Backing fire. No further information received.

Middle of Nowhere, Florida DOF. Charlotte County, FL. Southern rough. Spotting. No further information received.

Strickland, Big Cypress National Preserve. Sunniland, FL. Souther rough. Structures threatened. No further information received.

Cherokee Road, Florida DOF. Four miles southeast of Gateway, FL. Palmetto and pine. Minimal fire activity.

Dregger, Georgia Forestry Commission. Five miles south of Glennville, GA. Southern rough and palmetto. Minimal fire activity. No new information.

Midrest, Big Cypress National Preserve. Forty miles east of Naples, FL. Southern rough. No further information received.

Black Creek, Florida DOF. Started on private land seven miles southeast of Freeport, FL. Timber. Spotting. Residences threatened.

FT6, Big Cypress National Preserve. Fifty-four miles southeast of Naples, FL. No further information received.

Red Oak, Florida DOF. Started on private land two miles southwest of Pine Lakes, FL. Brush. Smoldering.

Target, Florida DOF. Ten miles southeast of Saint Cloud, FL. Southern rough. Reduction in acreage due to more accurate mapping. No further information.

Trail, Big Cypress National Preserve. Fifty mile east of Naples, FL. Southern rough. Minimal fire activity.

Green Valley, Florida DOF. Started on private land thirteen miles north of Winter Haven, FL. Brush. Smoldering. No further information received.

threatened. Mandatory evacuations along the Gunflint Trail, from Poplar Fire Station #1 to the end of Gunflint Trail.

South Boundary #262, Red Lake Agency. Six miles southwest of Red Lake, MN. Timber. No new information.

Cherry, Minnesota Department of Natural Resources IMT 2 (Mannelin). Grass and timber. Torching. Residences threatened.
