Cascade Complex, Boise NF. IMT 2 (Whalen). Twenty-seven miles east of Cascade, ID. Timber. Smoldering, surface burning and isolated torching. Structures, power lines, cultural sites and historical cabins threatened. Evacuations and road closures in effect.

East Zone Complex (4 fires), Payette NF. IMT 1 (Broyles) and NIMO (Gelobter). IMT also managing Donnelly zone of the Grays Creek fire and the Big Creek portion of the Krassel Complex WFU. Twenty-five miles northeast of McCall, ID. Timber. Minimal fire activity. Numerous structures threatened. Road closures and evacuations in effect.

French Creek, Manti-Lasal NF. Thirty-one miles southwest of Spanish Fork, UT. Timber, sage and grass. Last report unless significant activity occurs.

Big Creek, Wasatch-Cache NF. Eighteen miles southwest of Tooele, UT. Grass. Intermittent torching and short runs. Last narrative report unless significant activity occurs.

Fool Creek, Lewis and Clark NF. Thirty miles northwest of Choteau, MT. Timber and snags. Creeping and smoldering with isolated torching.

Conger Creek, Lolo NF. Twenty miles north of Ovando, MT. Timber. Minimal fire activity with isolated torching. Closures in effect.

Jocko Lakes, Flathead Agency, BIA. IMT 2 (McNitt). Previously reported fire. Twenty-six miles northeast of Missoula, MT. Timber with dead and down lodgepole pine. Smoldering with isolated tree torching.

Elkhorn Substation, Dakota Prairie National Grasslands. Twelve miles west of Fairfield, ND. Timber and grass. No new information.

Corporal, Flathead NF. Forty-seven miles southeast of Kalispell, MT. Timber. No new information. Last report unless new information is received.

Spot Weather Forecast

Spot weather forecasts should be requested for those fires that have potential for extreme fire behavior, exceed initial attack, or are located in areas where Red Flag Warnings have been issued.

● Basic elements needed for a spot weather forecast include:

- Name of fire and management agency
- Request time and date
- Location by ¼ section
- Drainage name
- Exposure
- Size
- Elevation (top and bottom)
- Fuel type
- Fire character (ground, crown, etc.)
- Weather conditions (place, elevation, observation time, wind direction, wind velocity, dry bulb, wet bulb, remarks)
