Cathedral, Texas Forest Service. Started on private land ten miles northwest of Marathon, TX. Grass and brush. Moderated fire behavior with some smoldering. Numerous residences threatened. Precipitation occurred over the fire area yesterday.

Ogle Hollow, Great Smoky Mountains NP. Ten miles southeast of Maryville, TN. Hardwood litter. Backing and flanking fire. Precipitation occurred over the fire area yesterday.

Sunrise, National Forests in North Carolina. IMT 2 (Wilder). Fifteen miles northwest of Morgantown, NC. Hardwood litter. Smoldering. Structures threatened.

High Cliff, Tennessee DOF. Three miles west of Jellico, TN. Logging slash. No new information. Last report unless new information is received.

Camelot, Tennessee DOF. Four miles northwest of Rogersville, TN. Hardwood litter. No new information. Last report unless new information is received.
