Area Command Team (Lohrey) is managing fire complexes on the Shasta-Trinity and Mendocino National Forests. Area Command Team (Zimmerman) is managing fire complexes on the Six Rivers and Klamath National Forests.

Craig, Butte Unit, Cal Fire. Cal Fire IMT 1 (Streblow). Twelve miles east of Oroville, CA. Brush. Upslope runs, torching and long-range spotting. Residences and cultural resources threatened. Evacuations and road closures in effect.

Rich, Plumas NF. IMT 1 (Hoff). Twenty miles west of Quincy, CA. Timber. Backing fire. Residences threatened. Restricted traffic flow on state highway 70.

Panther, Klamath NF. IMT 1 (McGowan). Fourteen miles southwest of Happy Camp, CA. Timber and brush. Backing and isolated group tree torching.

Ukonom Complex, Six Rivers NF. IMT 1 (Wilcock). IMT is also managing the Siskiyou Complex and the Blue 2 fire. Ten miles east of Orleans, CA. Timber. Moderate fire activity with backing, flanking, short upslope runs and isolated torching. Structures, cultural sites and telecommunication facility threatened.

Iron and Alps Complexes (2 fires), Shasta-Trinity NF. IMT 2 (Kaage). One mile north of Junction City, CA. Heavy timber, brush and grass. Flanking and backing fire with torching. Numerous residences and structures threatened.

Bear Wallow Complex (2 fires), Klamath NF. IMT 2 (Swartzlander). Confine/contain management strategy. Thirteen miles southeast of Happy Camp, CA. Timber and brush. Surface fire with torching, sporadic crowning and spotting. Structures threatened. Voluntary evacuations and road closures in effect.

Yolla Bolly Complex (3 fires), Mendocino NF. IMT 1 (Larsen). IMT 2 (Blume) ordered. Forty-seven miles southwest of Redding, CA. Timber. Active fire behavior with short uphill runs, torching and short-range spotting. Cultural sites threatened.

Siskiyou Complex, Klamath NF. Eighteen miles southwest of Happy Camp, CA. Conifer and hardwood overstory with heavy timber litter. Moderate fire behavior with backing, flanking, short upslope runs and torching. Cultural sites threatened.

Blue 2, Six Rivers NF. Twelve miles east of Klamath, CA. Timber. Backing, smoldering, creeping and isolated group tree torching. Cultural and communications sites threatened. Trail and road closures in effect.

Lime Complex (2 fires), Shasta-Trinity NF. Transfer of command from IMT 1 (Hughes) to IMT 2 (Woychak) yesterday. Fourteen miles west of Hayfork, CA. Timber. Creeping and smoldering with occasional group tree torching and short-range spotting.

Canyon Complex (3 fires), Plumas NF. IMT 2 (Sciacca). Sixteen miles northeast of Paradise, CA. Timber. Minimal fire behavior with short interior runs and isolated tree torching.
