A NIMO Team (Cable) is assigned as a planning and operational group in support of the National Multi-Agency Coordinating Group at Boise, ID.

Eight MAFFS C-130 air tankers are supporting the State of California. All aircraft are based at McClellan Airport in Sacramento, California. The Mission Commander is LTC Mike Barkdull, 153rd Airlift Wing, Cheyenne, Wyoming. Three aircraft are provided by the 145th Airlift Wing, Charlotte, North Carolina, three from the 302nd Airlift Wing, Colorado Springs, Colorado and two from the 153rd Airlift Wing, Cheyenne, Wyoming.

Australia, New Zealand and Canada are providing 59 fire specialists and managers to assist with fire suppression operations in California. Canada is also providing two crews to California.

Area Command Team (Loach) is managing fire complexes on the Shasta-Trinity, Mendocino and Six Rivers National Forests. NIMO Team (Whitney) is supporting the ONCC Multi-Agency Coordinating Group. Area Command Team (Anderson) is managing fire complexes on the Six Rivers and Klamath National Forests.

SHU Lightning Complex (2 fires), Shasta-Trinity Unit, Cal Fire. Cal Fire IMT 1 (Kerschen). Shasta and Trinity counties, CA. Timber, brush and grass. Active fire behavior. Residences threatened and road closures in effect.

Lime Complex (9 fires), Shasta-Trinity NF. IMT 1 (Wilcock). Fourteen miles west of Hayfork, CA. Timber. Creeping with short runs and isolated torching. Residences, ranches and youth camps threatened.

Iron and Alps Complexes (7 fires), Shasta-Trinity NF. IMT 1 (Broyles and Opliger). One mile north of Junction City, CA. Heavy timber, brush and grass. Active fire behavior with slope driven runs, isolated torching and long range spotting. Several communities threatened and evacuations in effect.

American River Complex, Tahoe NF. IMT 1 (Muir). Eleven miles northeast of Foresthill, CA. Timber, brush and chaparral. Backing, creeping and smoldering with single and group tree torching. Residences threatened and road closures in effect.

Canyon Complex (6 fires), Plumas NF. IMT 1 (Pendleton). Sixteen miles northeast of Paradise, CA. Timber. Active fire behavior with single and group tree torching and spotting. Communities and archeological sites threatened. National forest closures in effect.

Soda Complex, Mendocino NF. Unified command between IMT 2 (Fiorella) and Cal Fire (Bradley). Fifteen miles northwest of Upper Lake, CA. Timber. Active backing fire with upslope runs and torching. Residences threatened.

Hell's Half, Six Rivers NF. IMT 1 (Quesinberry). Eight miles southwest of Burnt Ranch, CA. Timber. Moderate surface fire with isolated torching. Communities threatened. Evacuations in effect.

Cub Complex, Lassen NF. IMT 2 (Kaage). Sixteen miles southwest of Chester, CA. Timber. Active surface fire with isolated torching. Restricted traffic flow on state highway 32.

Siskiyou Complex (2 fires), Klamath NF. IMT 2 (Swartzlander). Eighteen miles southwest of Happy Camp, CA. Conifer and hardwood overstory with heavy timber litter. Minimal surface fire with isolated torching. Residences and cultural sites threatened. Forest road, campground and trail closures in effect.

Ukonom Complex, Six Rivers NF. IMT 2 (Paul). Ten miles east of Orleans, CA. Timber. Active fire behavior with backing, short upslope runs and torching. Structures threatened. Road closures in effect.

BTU Lightning Complex, Butte Unit, Cal Fire. Cal Fire IMT 1 (Morris). Twenty-seven miles north of Yuba City, CA. Timber, brush and logging slash. Increased fire activity with isolated runs.

Blue 2, Six Rivers NF. IMT 2 (Svalberg). Twelve miles east of Klamath, CA. Timber. Active surface fire with isolated torching and short range spotting. Cultural sites threatened.

Bear Wallow Complex (2 fires), Klamath NF. IMT 2 (Johnson). Confine/contain management strategy. Thirteen miles southeast of Happy Camp, CA. Timber and brush. Backing fire with single and group tree torching.
