A NIMO Team (Cable) is assigned as a planning and operational group in support of the National Multi-Agency Coordinating Group at Boise, ID.

Four MAFFS C-130 air tankers are supporting the State of California. All aircraft are based at McClellan Airport in Sacramento, California. The Mission Commander is LTC Mike Barkdull, 153rd Airlift Wing, Cheyenne, Wyoming. One aircraft is provided by the 145th Airlift Wing, Charlotte, North Carolina and three from the 302nd Airlift Wing, Colorado Springs, Colorado.

Australia, New Zealand and Canada are providing 59 fire specialists and managers to assist with fire suppression operations in California. Canada is also providing two crews to California.

Area Command Team (Loach) is managing fire complexes on the Shasta-Trinity, Mendocino and Six Rivers National Forests. NIMO Team (Whitney) is supporting the ONCC Multi-Agency Coordinating Group. Area Command Team (Anderson) is managing fire complexes on the Six Rivers and Klamath National Forests. Area Command Team (Lohrey) has been ordered to replace Loach's Area Command Team.

Lime Complex (10 fires), Shasta-Trinity NF. Transfer of command from IMT 1 (Wilcock) to IMT 1 (Hughes) tomorrow. Fourteen miles west of Hayfork, CA. Timber. Active fire behavior with short runs and spotting. Residences, ranches and youth camps threatened.

Iron and Alps Complexes (6 fires), Shasta-Trinity NF. IMT 1 (Opliger). One mile north of Junction City, CA. Heavy timber, brush and grass. Moderate surface fire with occasional torching and short-range spotting. Several communities threatened. Evacuations in effect.

Canyon Complex (6 fires), Plumas NF. IMT 1 (Pendleton). Sixteen miles northeast of Paradise, CA. Timber. Backing fire with slope-driven runs, torching and spotting. Communities and archeological sites threatened.

SHU Lightning Complex (2 fires), Shasta-Trinity Unit, Cal Fire. Cal Fire IMT 1 (Kerschen). Shasta and Trinity counties, CA. Timber, brush and grass. Moderate fire behavior. Road closures in effect.

Soda Complex, Mendocino NF. Unified command between IMT 2 (Fiorella) and Cal Fire (Bradley). Fifteen miles northwest of Upper Lake, CA. Timber. Active surface and backing fire with single tree torching. Residences threatened.

Hell's Half, Six Rivers NF. IMT 1 (Quesinberry). Eight miles southwest of Burnt Ranch, CA. Timber. Active backing fire with single and group tree torching and spotting. Residences threatened. Evacuations in effect.

American River Complex, Tahoe NF. IMT 1 (Muir). Eleven miles northeast of Foresthill, CA. Timber, brush and chaparral. Minimal fire activity with creeping, smoldering and occasional torching.

Ukonom Complex, Six Rivers NF. IMT 2 (Paul). Ten miles east of Orleans, CA. Timber. Active fire behavior with wind driven runs, single and group tree torching and spotting. Structures threatened. Road and trail closures in effect.

Siskiyou Complex (2 fires), Klamath NF. IMT 2 (Swartzlander) and IMT 1 (Dietrich). Eighteen miles southwest of Happy Camp, CA. Conifer and hardwood overstory with heavy timber litter. Moderate surface fire with intermittent torching. Structures and cultural sites threatened. Forest road, campground and trail closures in effect.

BTU Lightning Complex, Butte Unit, Cal Fire. Cal Fire IMT 1 (Morris). Twenty-seven miles north of Yuba City, CA. Timber, brush and logging slash. Minimal fire activity with slow rates of spread.

Blue 2, Six Rivers NF. IMT 2 (Svalberg). Twelve miles east of Klamath, CA. Timber. Surface fire with creeping, smoldering, single tree torching and short range spotting. Cultural sites threatened.

Bear Wallow Complex (2 fires), Klamath NF. IMT 2 (Johnson). Confine/contain management strategy. Thirteen miles southeast of Happy Camp, CA. Timber and brush. Increased fire activity with wind driven runs and spotting.
