Six MAFFS C-130 air tankers have deployed in support of the State of California. The aircraft are based at McClellan Airport in Sacramento California. The Mission Commander is LTC Roger Williams, 145th Air Wing Air National Guard, North Carolina. Aircraft are provided by the 145th Airlift Wing, Charlotte North Carolina, the 302nd Airlift Wing, Colorado Springs, CO and the 153rd Airlift Wing from Cheyenne Wyoming.

Area Command Teams (Zimmerman and Lohrey). NIMO (Gage) assigned to Shasta-Trinity NF.

BTU Lightning Complex (31 fires), Butte Unit, Cal Fire. Cal Fire IMT 1 (Lewin). Twenty-seven miles north of Yuba City, CA. Timber, brush and logging slash. Increasing fire activity. Communities of Jonesville, Butte Meadows and Concow threatened. Precautionary evacuation advisories have been issued for several communities. Highway 70 closed.

SHU Lightning Complex (158 fires), Shasta-Trinity Unit, Cal Fire. Cal Fire IMT 1 (Kerschen). Shasta and Trinity counties, CA. Timber, brush and grass. Extreme fire behavior. Several communities and power generation system threatened. Communities of Shingletown and Burney threatened. Evacuation orders in effect for several communities.

MEU Lightning Complex (107 fires), Mendocino Unit, Cal Fire. Cal Fire IMT 1 (Waterman). Previously reported as the Mendocino Lightning Complex. Mendocino County, CA. Timber and grass. Moderate rates of spread with isolated spotting and torching. Numerous residences threatened. Greenfield, and Orr Springs threatened. Evacuations orders in effect.

Whiskeytown Complex (3 fires), Whiskeytown National Recreation Area, NPS. Twelve miles west of Redding, CA. Timber and brush. Moderate fire activity with upslope runs. Communication towers and power lines threatened.

American River Complex (3 fires), Tahoe NF. IMT 1 (Summerfelt). Eleven miles northeast of Foresthill, CA. Timber, brush and chaparral. Watershed, power lines and private inholdings threatened.

Yuba River Complex (28 fires), Tahoe NF. IMT 2 (Joseph). Thirteen miles northeast of Nevada City, CA. Timber and brush. Active fire behavior. Several communities, hydroelectric facilities and recreation sites threatened.

Iron Complex (27 fires), Shasta-Trinity NF. IMT 2 (Swartzlander). One mile north of Junction City, CA. Heavy timber, brush and grass. Low to moderate fire activity under a smoke inversion. Communities and lookout threatened. Highway 299 has restricted traffic flow.

Lime Complex (53 fires), Shasta-Trinity NF. IMT 1 (Opliger) and IMT 2 (Kaage). Fourteen miles west of Hayfork, CA. Timber. Short duration crown runs, single and group tree torching and short-range spotting. Numerous structures, ranches and youth camps threatened. Community of Platina evacuated. Voluntary evacuation order in effect for Wildwood.

Walker, Sonoma-Lake Napa Unit, Cal Fire. Cal Fire IMT 1 (Morris). Ten miles northeast of Clearlake Oaks, CA. Chaparral. Afternoon flare-ups. Walker Ridge Road closed.

Peterson Complex, Lassen NF. Unified command between IMT 1 (Ruggiero) and Cal Fire. Includes previously reported Popcorn fire. Twelve miles east of Cassell, CA. Timber and grass. Spotting. Community of Little Valley threatened; voluntary evacuation order in effect.

LNF June Lightning Complex, Lassen NF. Sixteen miles southwest of Chester, CA. Timber. No new information.

Cub Complex (2 fires), Lassen NF. IMT 2 (Batten). Sixteen miles southwest of Chester, CA. Timber. Increased fire activity with short uphill runs with short range spotting. Traffic control on Highway 32. Smoke impacting community of Chester.

Humboldt Complex, Humboldt-Del Norte Unit, Cal Fire. Humboldt County, CA. Timber, slash and grass. Slow spread with occasional spotting. Numerous residences threatened.

Canyon Complex (34 fires), Plumas NF. IMT 1 (Pincha-Tulley). Sixteen miles northeast of Paradise, CA. Timber. Moderate rates of spread and isolated torching. Numerous residences and archeological sites threatened. Road closures in effect.

Hell's Half Complex (2 fires), Six Rivers NF. IMT 2 (Secrest). Eight miles southwest of Burnt Ranch, CA. Timber. Occasional torching. Structures threatened.

Soda Complex (4 fires), Mendocino NF. IMT 2 (Heintz). Fifteen miles northwest of Upper Lake, CA. Chaparral, mixed conifer and oak woodlands. Group tree torching. Residences threatened.

Mill Complex, Lassen NF. IMT 1 (Larsen). IMT also managing the TGU Lightning Complex. Includes previously reported Antelope fire. Sixteen miles northeast of Los Molinos, CA. Timber. Burning in wilderness area.

Antelope, Lassen NF. Seven miles southeast of Paynes Creek, CA. Timber. No further information received.

June ABCD Misc Complex (4 fires), Mendocino NF. Twenty-four miles southwest of Chico, CA. Chaparral, timber and grass. Backing fire with short runs and isolated torching. Partially burning in wilderness area.

TGU Lightning Complex (3 fires). Tehama-Glenn Unit, Cal Fire. Tehama County, CA. Chaparral. Moderate rates of spread.

Siskiyou Complex (5 fires), Klamath NF. IMT 2 (Paul). Eighteen miles southwest of Happy Camp, CA. Conifer and hardwood overstory with heavy timber litter. Increased fire activity with short uphill runs and occasional torching. Campground and residence threatened.

Mad Complex (4 fires), Six Rivers NF. Humboldt County, CA. Timber, brush and grass. Low rates of spread with isolated torching. Residences threatened.

Corral, Lassen-Modoc Unit, Cal Fire. Twenty-three miles west of Termo, CA. Timber and grass. Moderate rates of spread with spotting.

Ukonom Complex (3 fires), Six Rivers NF. IMT 2 (Lund). Includes previously reported Blue fire. Ten miles east of Orleans, CA. Timber. Increased fire behavior. Structures threatened.

Gould, Klamath NF. Nineteen miles southwest of Etna, CA. Timber. Smoldering with isolated torching. Decrease in acreage due to more accurate mapping.

Basin Complex (2 fires), Los Padres NF. IMT 1 (Dietrich and Molumby). Five miles southeast of Big Sur, CA. Timber, brush and slash. Active burning at higher elevations with short crown runs, torching and spotting. Numerous residences threatened. Evacuations in effect. Highway 1 closed.

Indians, Los Padres NF. Unified Command between IMT 1 (Molumby) and Cal Fire IMT 1 (Hutchinson). Eighteen miles west of King City, CA. Timber, chaparral and grass. Increased fire activity. Numerous structures and cultural resources threatened. Evacuation orders in effect for Aroyo Seco.

Clover, Sequoia NF. IMT 2 (Johnson and Harvey). Thirty-two miles north of Weldon, CA. Timber and brush. Backing and creeping fire.. Residences threatened.

Oliver, Merced-Mariposa Unit, Cal Fire. Cal Fire IMT 1 (Hodson). Twelve miles east of Mariposa, CA. Timber, heavy brush and downed fuels. Upslope runs with individual and group tree torching. Numerous structures threatened. Evacuation orders in effect.

Oliver Complex (4 fires), Sierra NF. Seven miles west of Fish Camp, CA. Timber, heavy brush and downed fuels. Upslope runs with individual and group tree torching. Decrease in acreage due to more accurate mapping.

Silver Complex (5 fires), Sierra NF. NIMO (Cable). Twelve miles southeast of Mariposa, CA. Timber. Moderate fire behavior.

North Mountain, Stanislaus NF. IMT 2 (Woychak). Seven miles northeast of Groveland, CA. Chaparral and timber. Stringer runs to ridge tops. Numerous residences and lookout tower threatened.

Big Springs, Cibola NF. IMT 1 (Hughes). Eighteen miles east of Valencia, NM. Hardwood litter. Plume-dominated fire behavior with group torching, long-range spotting and backing. Residences threatened. Evacuations for communities of Tajique, Torreon and Sherwood Forest.

Distillery, Coronado NF. IMT 2 (Small). Ten miles east of Vail, AZ. Timber and grass. Backing with isolated torching. Residences, archeological sites and power lines threatened. Precipitation occurred over the fire area yesterday.

White Tank, Coronado NF. IMT 2 (Sciacca). IMT also managing the Nuevo fire. Ten miles east of Arivaca, AZ. Short grass and mesquite. Moderate fire behavior. Precipitation occurred over the fire area yesterday.

West Fork, Cimarron District, New Mexico State Forestry. Twenty-eight miles west of Raton, NM. Mixed conifer and juniper with oak understory. Moderate to low intensity surface fire. Reduction in acreage due to more accurate mapping.

Hot Air, Apache-Sitgreaves NF. IMT 2 (Hall). Twenty-nine miles southwest of Alpine, AZ. Ponderosa pine and brush. Group and single tree torching with surface fire. Structures threatened.

Crystal Peak, San Carlos Agency, BIA. Twenty-three miles south of San Carlos, AZ. Chaparral. Active fire behavior.

Ethan, Pima Agency, BIA. IMT 2 Ordered. Twelve miles southwest of Phoenix, AZ. Brush. Very active fire behavior with spotting. Residences threatened. Evacuations in effect.

Nuevo, Coronado NF. Seventeen miles northwest of Nogales, AZ. Brush and grass. Moderate fire behavior. Precipitation occurred over the fire area yesterday. Reduction in acreage due to more accurate mapping.

Mule, Tucson District, Arizona State Forestry. Five miles northeast of Bisbee, AZ. Brush. Running and short-range spotting. Residences threatened. Evacuations in effect.

Bear Mountain, Apache - Sitgreaves NF. Twenty miles south of Alpine, AZ. Timber and brush. Creeping and smoldering.

Redington - WFU, Coronado NF. Forty-one miles northeast of Tucson, AZ. Chaparral. Torching, small runs and short-range spotting. Last narrative report unless significant activity occurs.

Deaton, Texas Forest Service. Started on private land thirty-nine miles south of Ozona, TX. Brush, pinyon pine, juniper and grass. Creeping and smoldering.

Dry Devil's River, Texas Forest Service. Started on private land thirty miles south of Sonora, TX. Pinyon pine juniper, brush and grass. Minimal fire activity.

Hadley, National Forests in Florida. Thirty-five miles west of Jacksonville, FL. Southern rough. Torching and short-range spotting. Residences threatened.
