LPGA, Florida DOF. Six miles west of Daytona Beach, FL. Southern rough. Minimal fire activity. No further information received.

Mustang Corner, Everglades NP. Fifteen miles southwest of Kendall, FL. Grass. No new information.

Russian, National Forests in Florida. Confine/contain management strategy. Thirteen miles northeast of Lake City, FL. Southern rough. Smoldering. Monitor fire. Last report unless significant activity occurs.
