Lonesome Complex, Rogue River NF. IMT 1 (Pendleton). Twelve miles east of Prospect, OR. Timber. Active fire behavior with single and group tree torching and spotting. Historical structures threatened.

Kitson, Willamette NF. IMT 2 (Rapp). Six miles southeast of Oakridge, OR. Timber. Brush. Creeping and smoldering with single tree torching and short-range spotting. Structures threatened.

Gnarl Ridge, Mt. Hood NF. IMT 2 (West). Ten miles south of Parkdale, OR. Timber. Creeping and smoldering.

Wizard, Deschutes NF. IMT 2 (Paul). Eighteen miles northwest of Sisters, OR. Ponderosa pine. Isolated torching and short-range spotting. Structures threatened.
