Deep, Big Cypress National Preserve. IMT 1 (Quesinberry). Three miles northeast of Miles City, FL. Southern rough and grass. Active fire behavior with torching and spotting.

2009 Winter Initial Attack, Texas Forest Service. Texas IMT 2 (Hanneman). IMT is supporting multiple fires in west Texas. Acres reported are a cumulative total.

Highway 31, South Carolina Forestry Commission. Nine miles northwest of Myrtle Beach, SC. Timber understory. Moderate fire behavior. Residences threatened.

Duncan, Texas Forest Service. Twenty miles south of Balmorhea, TX. Grass. Active fire behavior with spotting.

McElroy, Texas Forest Service. Twenty miles southwest of Balmorhea, TX. Brush and grass. Moderate fire behavior with short-range spotting. Structures threatened.

Elephant Mountain, Texas Forest Service. Twenty miles southwest of Marathon, TX. Grass. Minimal fire activity. Reduction in acreage due to more accurate mapping.

Valentine Complex, Texas Forest Service. One mile south of Valentine, TX. Grass. Minimal fire activity. Structures threatened. Reduction in acreage due to more accurate mapping.

Harley, Florida DOF. One mile northeast of Bithlo, FL. Hardwood litter. No further information received.

Otter Creek, Daniel Boone NF. Eighteen miles northeast of Manchester, KY. Hardwood litter. Minimal fire activity.

Group Camp, Tennessee DOF. Twelve miles northeast of Jamestown, TN. Hardwood litter. No further information received.

Battle Creek, Osage Agency, BIA. Three miles northwest of Skiatook, OK. Hardwood litter. No new information. Last report unless new information is received.
