Deep, Big Cypress National Preserve. IMT 1 (Quesinberry). Three miles northeast of Miles City, FL. Southern rough and grass. No new information.

Stoney Ridge, Eastern Cherokee Agency, BIA. IMT 2 (Wilder). Eight miles northeast of Cherokee, NC. Pine, hemlock and hardwood litter. Active fire behavior. Communities of Big Cove and Sherrill Cove threatened.

2009 Winter Initial Attack, Texas Forest Service. Texas IMT 2 (Hanneman). IMT is supporting multiple fires in west Texas. Acres reported are a cumulative total.

Duncan, Texas Forest Service. Twenty miles south of Balmorhea, TX. Grass. Minimal fire activity.

McElroy, Texas Forest Service. Twenty miles southwest of Balmorhea, TX. Brush and grass. Minimal fire activity.
