Tiller Complex, Umpqua NF. IMT2 (Ensley). Six miles northeast of Tiller, OR. Timber. Creeping with isolated torching and spotting.

Williams Creek, Umpqua NF. IMT2 (Paul). Fifteen miles east of Glide, OR. Timber. Smoldering and creeping. Residences and power transmission lines threatened.

Discovery, Okanogan/Wenatchee NF. Washington IMT2 (Gormley). Timber. Thirty miles west of Yakima, WA. Creeping.

North Fork Complex (2 fires), Umatilla NF. IMT2 (Batten). Confine/contain management strategy. Fifteen miles southeast of Ukiah, Oregon. Timber, brush and grass. Smoldering.

Heatwave Complex (4 fires), Olympic National Park. Transfer of command from IMT2 (McBratney) back to the local unit will occur today. Confine/contain management strategy. Fifteen miles west of Brinnon, WA. Timber with heavy dead and down fuels. Creeping and smoldering. Last report unless significant activity occurs.

Cougar Ridge Complex, Wallowa-Whitman NF. IMT2 (Rapp). Twelve miles south of Wallowa, OR. Timber. Smoldering. Reduction in acreage due to more accurate mapping.

ABCD July-August, Rogue River NF. IMT2 (Hutton). Eleven miles north of Prospect, OR. Timber with heavy dead and down fuels. Smoldering, creeping and isolated torching. Road closures in effect.
