Department of Interior personnel are assigned to several locations in the Gulf of Mexico to assess and mitigate impacts resulting from the Deepwater Horizon oil spill.

- A total of 322 Fish and Wildlife Service personnel are assigned to Delta, Breton and Bon Secour National Wildlife Refuges, as well as Houma, LA and Mobile, AL.

- A total of 296 National Park Service personnel are assigned to Gulf Islands National Seashore, Jean Lafitte Park and Preserve, Everglades National Park, Dry Tortugas, Biscayne National Park, De Soto National Memorial and Big Cypress National Preserve.

Eagle Trail, Tok Area Forestry, Alaska DOF. IMT 2 (Allen). One mile south of Tanacross, AK. Spruce. Creeping and smoldering with isolated torching. Traffic delays along Alaska Highway. Precipitation occurred over the fire area yesterday.

Gilles Creek, Delta Area Forestry, Alaska DOF. IMT2 (Paul). Twenty miles north of Delta, AK. Dormant brush, slash and black spruce. Active fire behavior with isolated group torching. Numerous structures threatened.

Toklat, Tanana Zone, BLM. Limited perimeter control incident. Started on State land 25 miles southwest of Nenana, AK. Black spruce and tundra. Smoldering and creeping. Residences and outbuildings threatened. Precipitation occurred over the fire area yesterday. Reduction in acreage due to more accurate mapping.

Applegate, Tanana Zone, BLM. Started on State land 25 miles northeast of Manley Hot Springs, AK. Dormant brush, slash and black spruce. Creeping and smoldering. Numerous structures threatened.

Slokenjikh, Tanana Zone, BLM. Previously reported limited perimeter control incident. Forty miles north of Tanana, AK. Grass and tundra. No further information received. Last report unless significant activity occurs.

Granite Tors, Fairbanks Area, Alaska DOF. Previously reported confine/contain incident. Twenty-eight miles northeast of Moose Creek, AK. Hardwood, brush and tundra. Smoldering. Last report unless significant activity occurs.

Big Swede, Delta Area Forestry, Alaska DOF. Previously reported limited perimeter control incident. Thirty miles northeast of Delta Junction, AK. Running fire. Last report unless significant activity occurs.

Mississippi Impact Area, Military Zone, BLM. Previously reported limited perimeter control incident. Ten miles southwest of Delta Junction, AK. White and black spruce. Smoldering with intermittent torching. Last report unless significant activity occurs.

Sischu 2, Tanana Zone, BLM. Previously reported limited perimeter control incident. Mixed spruce and tundra. No further information received. Last report unless significant activity occurs.

South Fork Healy, Delta Area Forestry, Alaska DOF. Previously reported limited perimeter control incident. Forty miles east of Delta Junction, AK. White and black spruce and mixed hardwoods. Minimal fire activity. Last report unless significant activity occurs.

*** Big Mountain**, Upper Yukon Zone, BLM. Limited perimeter control incident. Eighty miles northwest of Eagle, AK. Timber. No further information received. Last report unless significant activity occurs.

Eklutna, Mat-Su Area, Alaska DOF. Thirty-seven miles northeast of Anchorage, AK. Timber and grass. No new information.

Paradise Fork, Tanana Zone, BLM. Previously reported limited perimeter control incident. Eighty miles southwest of Tanana, AK.

Upper Gerstle, Delta Area Forestry, Alaska DOF. Previously reported limited perimeter control incident. Thirty miles southeast of Delta Junction, AK. Black spruce and mixed hardwoods. Minimal fire activity. Last report unless significant activity occurs.

Sischu 1, Tanana Zone, BLM. Previously reported limited perimeter control incident. Fifty-five south of Tanana Alaska. Mixed spruce and tundra. No further information received. Last report unless significant activity occurs.

*** Judge Creek**, Upper Yukon Zone, BLM. Limited perimeter control incident. Forty-five miles northwest of Eagle, AK. Black spruce. No further information received. Last report unless significant activity occurs.

*** Lost River**, Tanana Zone, BLM. Limited perimeter control incident. Thirty-four miles southeast of Ruby, AK. Timber. Creeping fire. Last report unless significant activity occurs.

*** Dominion**, Southwest Area Forestry, Alaska DOF. Limited perimeter control incident. Twenty-six miles northwest of Takotna, AK. Black spruce. No further information received. Last report unless significant activity occurs.

HYPOTHERMIA

Hypothermia occurs when your core body temperature falls below normal. It can easily happen in cold winds or wetness. Hypothermia can also occur in moderately cool temperatures, particularly if coupled with dehydration. People tend to forget to drink on cool, wet days and can get hypothermic even when the temperature stays well above freezing.

- - Symptoms of hypothermia include Slurred speech
 - Weakness and loss of coordination
 - Confusion
 - Irrational behavior

- - Uncontrollable shivering (although, at extremely low body temperatures, shivering may stop)
 - Pale and cold skin
 - Drowsiness – especially in more severe stages
 - Slowed breathing or heart rate

- Your body automatically begins to shiver to warm itself. As your energy is used up to keep warm, you may reach a point where your body will be unable to warm itself. If left untreated, your body will gradually shut down; and you can die.

- You can avoid hypothermia with the following precautions:
 - Guard against dehydration.
 - Avoid fatigue.
 - Avoid cold winds.
 - Take precautions, change out of wet clothes.
 - Be aware of the symptoms and take action upon their onset.

- If you recognize hypothermia, take the following steps:
 - Move the patient to shelter.
 - Remove wet clothes and replace them with warm, dry garments.
 - If the victim is alert, give them food and warm liquids to drink.
