Department of Interior personnel are assigned to several locations in the Gulf of Mexico to assess and mitigate impacts resulting from the Deepwater Horizon oil spill.

- A total of 130 Fish and Wildlife Service personnel are assigned to Delta, Breton and Bon Secour National Wildlife Refuges, as well as Houma, LA and Mobile, AL.

- A total of 54 National Park Service personnel are assigned to Gulf Islands National Seashore, Everglades National Park, Biscayne National Park, De Soto National Memorial and Big Cypress National Preserve.

Predictive Services Discussion: A low pressure system will move into the West today with strong winds developing across portions of southeast California, southern Nevada and the Four Corner states. Significant fire potential will develop in southeast Arizona and south-central New Mexico with windy and dry conditions. A dry high pressure system will move into the East with low relative humidity developing across the Mid-Atlantic, Southeast and western Great Lakes. The Northeast will see breezy and dry conditions.

SAFECOM Summaries

The Aviation Safety Communiqué (**SAFECOM**) [AMD-34/FS-5700-14](#) should be used to report any condition, observation, act, maintenance problem, or circumstance with personnel or the aircraft that has the potential to cause an aviation-related mishap. SAFECOMS are a tool used to identify, document, track, and correct aviation safety related issues.

During higher flight activity months, NPS, BLM and the Forest Service will summarize SAFECOMS and identify trends and other learning points. Though searching the SAFECOM website for individual reports are always available as a good source of lessons learned, SAFECOM summaries are a great source of information condensed and easily used as a topic for a safety discussion.
