Rock House, Texas Forest Service. Fort Davis, TX. Grass. Active fire behavior.

Swenson, Texas Forest Service. Three miles north of Swenson, TX. Brush and grass. Minimal fire activity.

Killough, Texas Forest Service. Six miles north of Post, TX. Mesquite and grass. Smoldering.

Cooper Mountain Ranch, Texas Forest Service. Fifteen miles northeast of Sterling City, TX. Grass. Extreme fire behavior. Community of Rotan is threatened. Evacuations in effect.

* **DHR**, Texas Forest Service. Fifty miles east of Fort Stockton. Grass. Active fire behavior.

Hickman, Texas Forest Service. Started on private land ten miles southeast of Midland, TX. Grass. No further information received.

Encino, Texas Forest Service. Thirteen miles west of San Angelo, TX. Grass. Active fire behavior. Residences threatened.

* **PK West**, Texas Forest Service. Sixteen miles northeast of Breckenridge, TX. Brush and grass. Active fire behavior. Residences threatened.

*** Frying Pan Ranch**, Texas Forest Service. Twenty-five miles northwest of Andrews, TX. Grass. Extreme fire behavior. Residences threatened.

Cannon, Texas Forest Service. Fifty miles east of Fort Stockton. Grass. Active fire behavior. Residences threatened. Reduction in acreage due to more accurate mapping.

*** Little Smokey**, Texas Forest Service. Fifty miles east of Fort Stockton, TX. Grass. Active fire behavior. Residences threatened.

Elim Church Rd., Georgia Forestry Commission. One mile northeast of Ludiwici, GA. Southern rough. Minimal fire activity.

Indiahoma Wye, Wichita Mountains NWR. IMT2 (Dueitt). Seven miles northeast of Indiahoma, OK. Timber and grass. Torching and spotting. Residences threatened.

*** Centerpoint**, Buffalo National River, NPS. Three miles northwest of Ponca, AR. Hardwood litter. Moderate fire activity. Residences threatened.

HYPOTHERMIA

Hypothermia occurs when your core body temperature falls below normal. It can easily happen in cold winds or wetness. Hypothermia can also occur in moderately cool temperatures, particularly if coupled with dehydration. People tend to forget to drink on cool, wet days and can get hypothermic even when the temperature stays well above freezing.

- - Symptoms of hypothermia include Slurred speech
 - Weakness and loss of coordination
 - Confusion
 - Irrational behavior

 - Uncontrollable shivering (although, at extremely low body temperatures, shivering may stop)
 - Pale and cold skin
 - Drowsiness – especially in more severe stages
 - Slowed breathing or heart rate

- Your body automatically begins to shiver to warm itself. As your energy is used up to keep warm, you may reach a point where your body will be unable to warm itself. If left untreated, your body will gradually shut down; and you can die.

- You can avoid hypothermia with the following precautions:
 - Guard against dehydration.
 - Avoid fatigue.
 - Avoid cold winds.
 - Take precautions, change out of wet clothes.
 - Be aware of the symptoms and take action upon their onset.

- If you recognize hypothermia, take the following steps:
 - Move the patient to shelter.
 - Remove wet clothes and replace them with warm, dry garments.
 - If the victim is alert, give them food and warm liquids to drink.
