Texas IMT 2 (Hannemann) is managing existing and new fires located in Texas state initial attack zones.

Honey Prairie, Okefenokee NWR. Florida IMT 2 (West). Five miles northeast of Fargo, GA. Southern rough. Minimal fire activity. Numerous residences threatened.

Simmons Road, North Carolina DFR. Transfer of command from North Carolina IMT 2 (Hendricks) to North Carolina IMT 2 (Brandon) will occur today. IMT is also managing the Juniper Road fire. Nine miles northeast of Tar Heel, NC. Brush. Minimal fire activity.

Juniper Road, North Carolina DFR. Thirteen miles northeast of Rocky Point, NC. Brush. Minimal fire activity.

Racepond, Georgia DOF. Twelve miles south of Hoboken, GA. Hardwood litter. Minimal fire activity. Structures threatened.

Sweat Farm Again, Georgia DOF. Twelve miles west of Waycross, GA. Southern rough. Minimal fire activity. Residences threatened.

Arbuckle Complex, Oklahoma DOF. Three miles south of Dougherty, OK. Timber and grass. No new information.

Williams, Texas Forest Service. Thirteen miles south of Kent, TX. Brush. Minimal fire activity.

* **Stewart**, Texas Forest Service. Started on private land seventeen miles northwest of Sterling, TX. Brush. No further information received.

Agua Creek, Texas Forest Service. Three miles northwest of Sundown, TX. Grass. No new information. Last report unless new information is received.

* **Grasshopper**, Wewoka Agency, BIA. Five miles southwest of Cromwell, OK. Hardwood litter. No further information received.

* **314**, Texas Forest Service. Started on private land three miles northwest of Brookston, TX. Timber and brush. Active fire behavior.

After Action Review part 2

The “Chainsaw” AAR

- It's 0'dark thirty. The crew has worked the fire for sixteen hours straight. No one has eaten a hot meal for days and oh yeah, you might as well be cold. No time for the After Action Review? -- Think again!

It's time to bust out the ...**CHAINSAW AAR**. The idea behind the Chainsaw AAR is simple; **SPEED**. When you need to get an After Action Review done quickly try this simple format.

1. Have the team form a loose circle.
2. Start with a single team member and ask one of these questions:

What is one thing that went well on this shift?
What is one thing that went bad on this shift?
What is one thing you would do different next time?
What is one thing you learned today?
3. Continue around the circle until everyone has had a chance. It may be necessary to place a time limit on each individual (i.e. 30 seconds).
4. Avoid unnecessary discussion (dinner is waiting).
5. Note the comments for future discussion.
