Beaver Creek, Twin Falls District, BLM. IMT 1 (Lund). One mile west of Hailey, ID. Timber, brush and grass. Extreme fire behavior with crowning. Power lines and numerous structures threatened. Evacuations, area and road closures in effect.

Patch Springs, Salt Lake Field Office, BLM. IMT 2 (Dunford). Two miles northwest of Terra, UT. Timber and grass. Active fire behavior with group tree torching. Power lines and communities of Terra and Willow Springs threatened. Evacuations and road closures in effect.

Elk Complex, Boise NF. IMT 1 (Harvey). Ten miles southwest of Pine, ID. Timber, brush and grass. Short crown runs and spotting. Numerous structures threatened. Evacuations, road and area closures in effect.

Millville, Bear River Area, Utah DOF. Six miles southeast of Logan, UT. Timber and grass. Active fire behavior. Numerous structures threatened. Evacuations in effect.

McCan, Twin Falls District, BLM. IMT 2 (Kidd). Four miles northwest of Fairfield, ID. Timber, brush and grass. Creeping and smoldering. Structures threatened.

North Fork, Boise NF. Twenty miles southeast of Cascade, ID. Timber. Short crown runs with long-range spotting.

222, Richfield Field Office, BLM. Fifteen miles southwest of Eureka, UT. Timber and grass. Single tree torching.

Rockport, Northwest Area, Utah DOF. Ten miles northeast of Park City, UT. Brush and grass. Creeping and smoldering. Structures threatened. Evacuations and road closures in effect.

Juni, Boise District, BLM. Thirty-two miles south of Jordan Valley, OR. Timber, brush and grass. Active fire behavior with isolated torching. Structures threatened. Road closures in effect.

Placer, Boise NF. Four miles south of Idaho City, ID. Timber, brush and grass. Creeping and smoldering.

Pony Complex, Boise District, BLM. Transfer of command from IMT 2 (Wilde) back to the local unit will occur tomorrow. Twelve miles north of Mountain Home, ID. Timber, brush and grass. Creeping and smoldering. Structures threatened. Increase in acreage due to more accurate mapping.

Lodgepole, Salmon-Challis NF. Transfer of command from IMT 2 (Whalen) back to the local unit will occur today. Ten miles west of Challis, ID. Timber and brush. Smoldering with interior torching.

Thunder City, Payette NF. Previously reported incident. Four miles northeast of Stibnite, ID. Timber. Crown runs with spotting. Last report unless significant activity occurs.

Predictive Services Discussion: Scattered showers and thunderstorms will develop across Arizona, Utah and eastern Nevada. Isolated thunderstorms will form over the northwestern U.S. from northern California to northwestern Montana. Showers will continue over far northwestern Washington. Heavy rain and thunderstorms will move through the Southeast. Temperatures will remain very warm in the West, with some cooling in the far Northwest. The Plains will continue very warm, while mild conditions remain over the East. In Alaska, warm weather will continue over most of the central and south, with cold temperatures over the North Slope. Scattered showers will develop in southern Alaska, with isolated thunderstorms over the Interior.

SAFENET
Miscellaneous Category



SAFENET is a process that provides a method for reporting unsafe situations on or off the fireline. The information provided on the form will help collect important, safety-related data to determine long-term trends and problem areas. A SAFENET may be filled out at any time to report a valid concern about unsafe situations in fire operations, as well as document corrective action.

- Discuss the methods for filing a SAFENET.
 - Electronically by accessing the SAFENET website at safenet.nifc.gov or linking to it through the NIFC website.
 - Hardcopy is no longer available or accepted.
- Discuss advantages of filing a SAFENET through your supervisor versus sending it yourself.
 - Increase the chances of finding an immediate solution.
 - Keeps supervisor "in the loop."
- Discuss using SAFENET in situations other than fire.
 - Prescribed fire
 - All-risk
 - Training
- Where does a SAFENET go, and what response can you expect?
 - SAFENETs are received and stored in a database in Boise. After a SAFENET is received, the names are removed. . The SAFENET doesn't get posted to the web until 2 business days after it has been forwarded to the affected agencies for corrective action.
 - Every new SAFENET is then forwarded to the affected agency's designated list of contacts, which usually includes the National or Regional Safety Officer.
 - It is each agency's responsibility to ensure that corrective actions are taken.
- Corrective actions should be submitted by people directly involved in mitigating the circumstances that led up to the unsafe situation. The submitter of the original SAFENET can use the "Immediate Action Taken" block of the SAFENET form to provide this information. Safety managers and line officers or supervisors may also file a corrective action to provide additional mitigation information.
- Discuss using SAFENET to monitor safety issues other firefighters may be having.
