* **25 Mile Creek**, Southeast Region, DNR. Fifteen miles northwest of Chelan, WA. Timber, brush and grass. Running and spotting.

* **Palisades Flats**, Spokane District, BLM. Twenty-five miles east of Wenatchee, WA. Brush and grass. Creeping and smoldering.

Silvercreek II, Colville Agency, BIA. Three miles southeast of Keller, WA. Timber. Interior smoldering. Last report unless significant activity occurs.

Predictive Services Discussion: High pressure over the southwest U.S. will continue to steer monsoon moisture northward through the central Rockies with wet thunderstorms today. High based thunderstorms are also expected from Oregon through northern portions of the Great Basin. Further East, showers and thunderstorms will be widespread from the High Plains through the Mississippi Valley as well as the gulf coast region near a frontal boundary. Another trough of low pressure will bring unsettled conditions and gusty winds to southwest Alaska.

TAKING A NAP NEAR THE FIRELINE

Operational Engagement Category

Firefighting is often exhausting work and firefighters can find themselves needing to sleep while on the fireline. Before pausing to rest, firefighters must weigh the following considerations:

- Are lookouts posted? Discuss who that lookout can be. Can the lookout on the knob across the draw watch over you or does it need to be your partner on the fireline alternating rest times?
- Is the area free of hazards? (Falling snags or rolling materials) Discuss what you need to do to create a safe resting area.
- Are you still within agency work and rest guidelines? Review what these guidelines are.
- Does your crew need a break? Have they been pushed too hard? Talk about situations where you need to simply take yourself and/or your crew off the fire for uninterrupted rest.
- To reduce risks:
 - Keep lookouts posted; rotate lookouts.
 - Communicate crew conditions and status to supervisor or chain-of-command contact. Have firefighters discuss ways that they find to rest on the fireline and suggestions for methods to alternate shifts for more effective firefighting.
